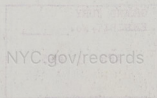
I Abraham Bey, make the following statement;  
I was first sent on October, 1963, on an assignment by Captain Joseph X, of Muhammad's Mosque #7, with orders to kill Mr. Jackie Robinson. Brother Ortbert Bey was also sent with me on this assignment. After two month had elapsed and having not done the job Catain Joseph X took us off that assignment and gave us orders to kill Minister Malcom X, who was at the time out on 90 days suspension. After being given the assignment to do the later, Ortbert Bey and myself decided to hear Minister Malcom X side of the story. Captain Joseph X, finding out our intensions, put the story out that we had pistols and was not connected with the Mosque, which lead to the arrest of Ortbert Bey with a "Sullivan Law" charge against him and I have witnesses for the above said statement.

"The Moorish Science". He was  
called The Grand Sheikh.

Abraham born into this  
Group. Left The Moorish Science in  
1952. 52-54 in School in N.Y.

1954 joined Marines.  
Military Police. Left in Jan 1954.

1956 went to trade school in K.C. and worked in a garage. This for about 1 1/2 years.

Be about early 58 or late 57 began to take active part in Black Muslims.

Any group of Muslims in a community is considered a temple and can have meetings. But they don't get a #. Must have over 25 paying memberships. Be able to give 2,000 papers semi annually. (about 150 newspapers each). (every 2 mths it comes).

Chicago sends a delegation to assure meeting - usually Eljazz Mohammed Jr or Raymond Sheriff.

When they leave they take the minister, curtain and 150 lbs back to Chicago.

usually go to Sheriff's house.

Stage

late 57 early 58, began to see Jesse White (4x) and John Spears (6x). They were from K.C. had gone to minister's school

in Chicago and had come back to K.C.  
to start a mosque.

Bey had known both  
men in school, knew Bey's  
background.

Bey had conversations  
with them, in K.C. Tried to  
get people together, help them  
set up a mosque. Wanted Bey  
to help them get members away  
from The Moorish Science Temple.

At first Bey said no.  
Told Bey he would be a minister  
and once they saw up the mosque,  
the would move on to Ocala. and  
Tex and Bey would be minister  
in K.C. Said that they would  
be an armed insurrection and that  
Bey should get out on ground  
floor.

Bey moved into their  
apt. about 6 months after they  
contacted him - about middle  
of 1958. They were not working.  
Bey paid no money. All 3  
supported by Chicago, sent enough  
literature for Chicago to pay for

food. Rent paid by Cheas from Chicago. Average of about \$150/wk. Cheas made out to Jesse 4x. he was in charge of this group of 3. Cheas were signed by John Ali, Secy of Muslim then and train.

Talking to people. Have them sign a roster to show Cheas what people had been spoken to in order to get them to join and familiar with Elijah. These lists forwarded to Cheas every month. At this time showed the people that Elijah wanted 10,000 trained and fearless men to take with him to Chicago to make certain demands.

Began to get members. Socie meeting in Apr. Began to get crowds. Talia in K.C. began to watch the group.

Jesse had told Bey that he was in charge of 4 boxes for recruiting, Miss, Kansas, Okla, Denver Colo.

In Feb 59, 6 or 7 months  
after Bey moved in, had about  
35 members. Bey, Jesse,  
John Spears and Marion Boone  
(not yet a member) in Spears car



to deliver some literature in K.C.  
Kansas. Had been living in Kansas  
City, Miss.

Stopped by policeman in  
K.C. Miss. Wanted to shoot men.  
Then another police car came.

One officer grabbed Jesse - Jesse  
hit the officer.

In those days had been  
training every day in judo &  
karate

Bey grabbed the other one  
& threw him. Boone & Spens then  
attacked officer on top of car.

15-20 more Cops came. Arrested,  
worked over. Sherry & Elizabeth Jk.  
come, made payments for bail  
etc. & got this men out, for 1 yr.  
S.S. In jail for 6 days - made  
conversations - first time that  
negroes had fought back against  
white police - so men popular.  
Arrested of Assault.

on 60 days of jail  
~~Elizabeth Jk.~~ and Sherry came down.  
Both come to see Bey in jail.  
First time he had ever seen  
either. They took Jesse to sick and



Spoke to him. Then Jesse said everything worked he OK and that he was pretty sure that after this meeting that the mosque would get a #. Other 2 went right back to Chicago.

Had spoken to about 23 men in jail. More men came in. About 3 wks after leaving jail they rented a store front on 12<sup>th</sup> St K.C. Miss.

At this time collecting \$2.00 average from each member plus newspaper sales. At that time papers sold for 15¢ on street, 12¢ had to go to Chicago. At first got papers from Chicago. Then after paper treasury built up wanted send money in advance. Before jail took 500 every 2 wks. Forwarded money in cash to John Ali, at mosque address on Woodlawn Ave. He would send back receipts signed by him.

once out of jail members  
came fast.

They found out that his  
letter of acceptance had come from  
Chicago making him a 1st Lt.  
Letter signed by Elzard Mohammed,  
letter congratulating all 4 for the  
way they handled themselves and for  
the recruiting done while in jail.  
Considering K.C. for a #.

(There were 26 mosques with #  
at this time). Jesse made minister,  
Spious made Asst minister and  
would perform other duties. Everybody  
understood that to mean he would  
be acting as Captain too.

A mosque is made up of a  
Deminister - who teaches the religion  
and responsible for mosque. Also  
in charge of all trials. Would hold  
trials to determine if suspension and  
how much for violation of rules.  
He is superior to Captain and have  
power to relieve him of Command.  
Once a month each minister goes  
to Chicago for reporting and instructions.

Usually goes alone. Usually he transports money to and from Chicago. He gets a salary which is fixed in Chicago. He can recommend to Chicago how much the Captain, Secretary and LT's should make.

Captain in Charge of FOI or women if a female. He can appoint investigators, Secretaries for FOI, Squad Leaders, and LT's with ministers approval. Saw a man sitting, speaking engagements for ministers in Charge of Newspapers.

Secretary keeps all records; in charge of money, keeps the books for the newspapers, letters come to him from Chicago re: membership, personnel records of each member; weekly report to John Ali re financial condition of mosque. Once a month he goes for a quarterly meeting with John Ali. Somewhat two weeks apart from ministers meeting. Secretary carries the records of the mosque. These records often kept in ministers house.

Moses keeps the records in the newspaper office and his home. He lives in Caronde Long Island. He would carry the records to the office in the Restaurant after FOI meeting Monday night. Takes them home Monday night. During the week he is in ~~the~~ <sup>in</sup> his office of the Newspaper office. Keeps the financial Records in Newspaper office.

On Monday night Moses brings home 1-2-4. 3 is kept either in Restaurant office or Newspaper office.

In #7 Monday night is pay night

for the officials. Members feel that Mx was getting 150/wk - Joseph 125/wk - Maceo 100/wk - Secretary, according to the seizure of mosque may have assistants. In Mosque # 7 Aubrey Emile was next to Maceo, also secy of Mosque 7B - (Brooklyn). Maceo has other assistants who work on the books.

Maceo in charge of Secy of the east. Would give advice to other secretaries in other Mosques.

In Mosque # 7, Maceo transfers the money himself in a brief case. Ben has been with him, acting guard as far as the train station. Generally goes alone, occasionally Captain Joseph goes with him.

Investigators - in every mosque. Trained in Chicago. Many times has more authority than a Lt and he reports to the Captain. Reports work closely

paying about \$40/month  
 for Secretariat in K.C. 2 large  
 rooms. One for meeting hall, other  
 for training purposes.

3 men had moved to another  
 apt paying \$50 per week.

Minister was getting \$8/month.  
 Kept the difference on the sale of  
 newspapers. Brothers wanted pay  
 for newspapers in advance.

Wanted to fire themselves  
 from Chicago which would  
 get brothers to see - keep the proceeds.

Got out of jail in March 59  
 Got \$30 in April 59.

Gov William Edgerton,  
 owner of Edgerton Hotel in K.C.  
 in Miss became interested and  
 went to Chicago. This after Ben  
 got out of jail. Owns Cleaners,  
 whiskey store etc.



About 2 wks after Bey got out of jail, Edgeton wanted to go to Cal. to set up a shipping business and some palm oil on his land in Sabana. Bey was relieved to go with him by car, his car. Stays in Denver, Tulsa, Okla City, and several cities in California. Bey was to leave Muslim of Islam literature with people Edgeton was seeing in these various cities. None of these places, except L.A. had mosques at this time. Jesse gave Bey his ordure. Edgeton furnished everything.

This took about 3 wks. Drove back with Edgeton. Dropped off the Herald Dispatch, paper published in California by who Bey met and made arrangements with.

Drove back to K.C. sometimes in late April.

About 50-75 people members at this time.

In Aug 59 held a  
 large meeting in Atlanta Georgia.  
 Mohammed supposed to speak.  
 6 Cars from Maque #30 drove down.

Bay was going down to  
 St Louis, #28, to help them build  
 up membership, came their to Minister  
 wanted come up to help K.C. #30.  
 6 Cars from K.C. and  
 3 Bussloads from St Louis went to  
 Atlanta.

Bay demoted in Atlanta  
 by Sharif for mocking K.C. FOI  
 and St Lou FOI through friends  
 of Atlanta. Demoted to a dues  
 paying priest.

Minister of #30 had  
 moved out to his own apt just  
 before Atlanta. Bay and Assoc  
 Minister in Apt when he moved.  
 Out of 3¢ a newspaper - sales  
 had gone to 1500 every 2 wks.  
 plus other literature re Supreme  
 Wisdom which they got for free  
 but wanted free for 1.50.

Even after Bay demoted others  
paid his expenses.

After Adonia Spears sent  
to Oakland to set up a mosque.  
Edward 3x became Captain.  
Anthony 2x Walton became Secy at  
about the same time. He and  
Garland x Williams moved in  
with Bay. Williams became  
1st Lt about 3 months later,  
Bay still being supported.

3/29/65

Bay stayed in KC until  
about March of 1961.

Before this Bay wanted  
to around Kansas and Missouri,  
especially Lincolnton, feeling  
popular and trying to organize  
groups into meetings. Usually  
went in a group of 6 accompanied  
by Garland. But Bay in charge  
as director of minister because  
Garland was very young. I was  
going to school. He was made  
LT, to attract the younger school  
set. Although Bay had no rank,  
he was in fact the superior of  
of Garland. He got no cut of the  
newspapers, but did ~~not~~ stay  
rent free.

In Summer of 1960  
Jesse 4x, The minister took  
between 500-600 dollars in contribution  
for himself. Put it in his own  
bank account. Bay went to Chicago,  
Alone, with a petition from the  
membership, asking for a new

Ben had been to Chicago before in Honors day. This first time met high officials.

Went directly to John Ali.

In Chicago Muslims have a  
Cleaners - Bakery - Restaurant -  
men's Clothing Store - 3 Barber Shops  
and a little dress factory -  
a fueling station - Used Car  
business. Grocery Store.

University of Islam - (Grade  
and High Above) run by a  
James 3x Shabaaz.

Newspaper, printed there,  
run by Herbert Mohammed, a  
son of Elzoot.

Another son runs the  
Cleaners (ONIAK) and his daughter  
runs the dress factory (all  
female members must buy 4 dresses).

Shoruff married to  
his daughter his son runs the  
Grocery Store and it is required  
that members buy their Groceries  
there.



used to have a farm  
 outside of Chicago, run by  
 John Speares Brother. No longer  
 in operation because this Speares  
 went to jail for drug dodging.

Hasson Sherriff (Capt) runs  
 both grocery & men's clothing store  
 fueling Station and barber  
 shop is run by yet another son  
 of Elzard Mohammed.

Mosque #2 is in Chicago.

Went to see John Ali  
 at his office in the University,  
 which is right next door to  
 the mosque (5335 Greenwood Ave).

Showed Ali the petition.  
 Ali said to see Captain Sherriff -  
 the Supreme Captain. 1 1/2 hr. later  
 saw Sherriff in Mosque Restaurant.  
 Sherriff had come from his home  
 to meet Bey. 10-11 or 12 min.

Sherriff said that Bey  
 should have referred this to  
 minister Jesse Butler than going



going to Chicago.

Bay went Back to N. C.  
The next day. Suspended by  
Jesse for 90 days the next day.  
Ousted up before the body,  
charged with despoils for an  
affair.

Bay had to move from the  
rent free apt. In one instance,  
when you are put out of the  
moufue, the minister speaks  
against you, encouraging the  
membership to attack you.  
Bay knows of many such cases.  
Captain Edward and some new  
~~some~~ men tried to attack Bay,  
during the 90 days. Bay walking  
down the street with a girl.  
These men were in a car. Bay took  
the girl into a pool room. Came  
out with some friends and  
the Captain and his men left.

During these 90 days Bey  
worked in a Garage. This was the  
first job he had since he  
joined The BM.

Left for New York in Spring of  
1961. Bey had tried to proselyte  
a K.C. mosque but couldn't get  
back in.

Tried to join Mosque #7  
but needed approval of minister  
of Mosque #30 which he couldn't  
get. Got a job as a truck  
driver.

In August of 1961 James  
gave his approval. Bey put on  
probation. Bey left the Mosque #7  
during his period of suspension  
during the beginning of 1963.

First shortly after Balyn  
Morgue opened. Investigator went  
to Brother's house in Balyn wife  
wouldn't let him. One Monday  
after FOI meeting Captain Joseph  
said he wanted the brothers from  
honor guard who live in Balyn to  
stay behind. Kenneth 10x, Bay  
and one other stayed. There 3 and Joseph  
left. Said investigator had been  
to this brother's home, had twice,  
sent 3 out to discover what  
was wrong. Didn't say what to  
do if Bay refused, he was made  
at that. <sup>Said to get the money</sup> Now some negro these  
3 visited this brother on Summer ave.  
Brother, smoking, drinking beer and  
watching TV. Pushed their way in,  
when he said the deal with  
the messenger. Bay and others  
beat him up.

Reported back on Wednesday night.  
Saw Joseph in the restaurant before  
meeting. Told Joseph what had  
happened. Joseph had asked if any one  
had seen the 3 leave. Told  
Joseph he had been beaten badly  
but not killed. Joseph confronted  
the 3 men.

By evening picked up papers  
from station R.R. Station from Chicago  
2500 - 4,000 every 2 wks. More  
coming in by mail, being picked  
up by Hughton in a rented truck.

About 6 weeks after above  
incident. Heard talk in Mosque  
against Dawood, husband DAKOTAN  
STATION. Now a member but made  
statements against Elzard in  
Amsterdam News in 1962. He  
was building his own group called  
the Muslim Brotherhood in 125 St.  
Called Orthodox Muslims.  
Clarence 7x called By, Clarence  
15x, Richard 8x, Leon Amir together.

All went to 125<sup>th</sup> and 5<sup>th</sup> Ave.  
 Clarence said he would be waiting  
 in a car outside. Clarence  
 said they would go up and  
 put this guy out of Commission  
 for speaking against the messenger.  
 One man in the Store. Con went  
 up to man, Bey and Rufford 8x,  
 took him in back room. Ollie  
 and Clarence 15x stayed in Store in  
 front. Tried to find out where  
 husband of Barbara Station.  
 Took him up when he  
 wouldn't see. Told him if any  
 more articles appeared, would wreck his  
 Store. No more articles did appear.  
 Clarence reported back to  
 Joseph but Bey not there.

In winter of 1963 for Boston  
 for Convention. Same time Boston.  
 Bey in charge of Bus 18 Busses  
 under Command of Capt. Joseph H.  
 As Bus pulled in ~~there~~ saw a  
 man outside with a sign calling  
 Elgar a glory and proclaiming  
 himself Messenger. Edward 18x (Bey's



Brother in Law and Bey knocked  
him down and stomped.

Joseph made complimentary remarks  
about it later.

James Warden had been beaten  
by <sup>4 men</sup> Butler, Johnson and Richard &c.

Bey heard Joseph say  
he was going to have Warden  
beaten up. Heard him say that  
in a restaurant in front of Douglas St.,  
Woy, Charles &c., Lundy and  
Douglas had been sent to get James  
but they were met by  
Longton and Blackstone &c., Sidney &c.

Joseph was speaking about Malcolm  
how he was spreading lies and was  
dangerous to Messenger. Bey asked  
where is to James. Joseph said that  
he hadn't seen him but would  
like to have some one to get ~~him~~ him.

One week ~~later~~ earlier  
Joseph spoke to Bey about Malcolm,  
2 weeks before Jackie Robinson.

About 1 month before Mx  
killed, James Warden was beaten.  
By heard from Henry 14x that Warden  
had been beaten by 4 men.

Henry 14x had been beaten by  
Clarence 7x and others about 2 months  
before Mx killed. Works as Grunion lobster  
126-125<sup>th</sup> on 7<sup>th</sup> ave west side of  
Street as a Cook.

Alvin ~~Johnson~~ had been  
assaulted by Joseph ~~x~~ to kill Malcolm.

George Whitney had been  
beaten by a group headed by  
Clarence during same period that  
Warden and Henry 14x beaten.  
Others beaten during this period.

~~Dec~~ of 63 or ~~Jan~~ of 1964  
Julius Robinson wrote articles in  
Amsterdam critical of Elzard Mohammed,  
at this time Bey and Orlov  
Bey had guns for 3 months.

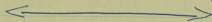



INTERVIEW OF ABE BEY

On May 5, 1965, 3 PM, the assigned and Det. Confrey, did meet with Abraham Bey, who stated the following:

The owner of the WEST SIDE BARBER SHOP, 120-121 St. & St. Nicholas Ave., Male, Negro, first name LOUIS, knowing Abe's reputation, asked him if he (Abe) could get him three sticks of Dynamite with capshe's willing to pay the price Abe sets. He was told that he would know sometime this week.

There is a new Gymnasium on the corner of 116 St. & 8th Ave. owned by a WESLEY ( Cab Driver, who always carries a gun) WINSTON runs the gym for Wesley. Winston asked Abe if he and Orbett Bey were interested in joining a gang that would operate for profit only ( On the style of the Mafia) doing stick-ups and hits for hire. Informant will keep contact with above.

On Thurs. Night, April 29, 1965, outside the Theresa Hotel, Abe and Edward 18 X Gadsen had a conversation with JAMES SHEBAZZ, who told them that someone was trying to sell him ( Shebazz) plastic explosives and Grenades, but that he thought it was an FBI trick. They started to talk about the riots last summer and Shebazz told them thay it would be different this year, there are 500 men trained and ready to give there lives, things will be breaking soon.

Appointment has been made for Friday, ~~April~~ *MAY* 7, 1965.

INFORMATION FROM A.B.

On May 7, 1965, the assigned and Det. Confrey, did meet the above who stated the following.

He has been contacted by GLADSTONE ALEXANDER, who wants him to join a small unit that is being formed. This unit will be composed of the following: GLADSTONE ALEXANDER, SIDNEY SEALEY, JOHN 57X GRAY, KENNETH 10X, LANGSTON SAVAGE, CLARENCE 18X HOLI DAY and the informant. There may be others in the group not known at the present time.

CHARLES 21X HALE tried to sell guns to JAMES SHEBAZZ, shebazz told him he was not interested. Shebazz told A.B. that he thinks Hale is an FBI Informant.

In regard to the youths that were brought into the 28 Pct. on this date who stated that their instructor is ALLAH, the following was ascertained. There are three ex-Muslims, teaching these kids- JOHN 37X, CLARENCE 9X, and RALPH ALLAH.

INTERVIEW OF A.B.

On May 12, 1965, the assigned did meet with the above named subject who stated the following.

There is a Gymnasium located on 125 St. Between 5th & Madison Aves, on the uptown side, upstairs. A group of young men, Approximately 20 are being trained in Karate at this location. These youths are being trained by a Male, Negro, late 20s, 5-2, light skinned, medium build. This instructor took the Karate lessons with A.B. in the Bronx and is instructing these youths to call him Sin-Say. This instructor helped JAMES SHEBAZZ train the Blood-Brothers.

"YAMI" ( Man who sold A.B. a 32 cal. Revolver in 1963) is also training a group of youths on 129 St. Yami's group includes some of the associates of the blood brothers. YAMI is described as Male, Negro, 5-6, stocky build, 30s, Dark Comp., Goatee & Mustache. He resides in 129 St. the first building in off 7th Ave. on the downtown side.

I regard to RICHARD or ROGERS ( Inquiry from FBI) subject states that in the summer of 1964 he was introduced to two persons by this name who are associated with the Black Nationalists, claims that when he met them he was told they were both armed and were rough boys. They claimed to be from Newark, N.J. but A.B. does not believe this as they seemed to know too much about Harlem. They are described as follows:

1. RICHARD- Male, Negro, 5-10, 170, early 30s, Med. Brown comp., Shaved head.
2. ROGER- Male, Negro, 5-9, 160, early 30s, Brown Comp., Close Cropped Hair.

On May 14, 1965, the assigned accompanied by Det. Cavallaro did meet with the above by pre-arrangement.

THOMAS 17X WHEELER is the instructor of the group that is in training in the Gym on 125 St.

The gym on 116 St. that is being run by WESLEY (The Cab Driver) is being entirely financed by the Chinese Communists. The informant was at a party with one of the instructors from said Gym who told him that this place is one of there strongholds. ( Informant believes that if this place is watched you would probably come up with the arms cache.)

A candy store located at 422 Saratoga Ave. is the place where the arms and explosives coming in from Boston are taken. The owner is the contact.

LANGSTON SAVAGE has not been seen in his usual haunts for several weeks. He and JAMES SHEBAZZ have had passports for several years. HABIB TOWANI ( A Jamaican, spanish speaking, an ardent follower of Malcolm X and very militant) is a member of the AAAU and is the connection for SHEBAZZ with a nationalist group that is stationed in Puerto Rico. This group works with the Haitian Gov't. and anyone who wishes to enter the Dominican Republic, goes to Puerto Rico and is taken by Haitian boat to Haiti and over the border to Dom. Rep.. Informant says that LANGSTON SAVAGE offered to take him there.

ROBERT 57X DUNN wanted in 48 Sgd. ( Shooting of Ben. Brown ) can be found on the corner of 145 St. & St. Nicholas Ave. selling MUHAMMED SPEAKS. Det. Rogan-48 Sgd. Ntfd.

KENNETH 10 X SMITH is supposed to be killed. He took a large sum of money from an out of town group ( Possibly Boston) for a shipment of narcotics and took off with the money.

GLADSTONE ALEXANDER is supposed to receive a shipment of COCAINE on 5/18/65. Stuff is coming in by boat, and is believed to have originated in CUBA. GLADSTONE hangs out in the vicinity of 144 St. & 7 Ave. Capt. Gáacome- Narc. Sgd.

On May 15, 1965, ( Sat. Night) there was a party at 27 Cooper Square, 2 stories, complete with a Calypso band. This place is rented by a white girl ( Member of RAM) admission was \$1.00, and you paid for your drinks, its purpose was to raise money for the defense of the persons arrested in the STATUE OF LIBERTY CASE. Relatives of SAYEED arrested in above case were in attendance. JAMES SHEBAZZ attended the party accompanied by MARY KOCHIYAMA. There will be another party this Friday May 21, 1965. Informant attends the party with EDWARD 18X GADSEN.

Informant also stated that in regard to these youth groups now in training, they ( the kids) have been told that in the event that the Police pick up the leaders , WHITE PEOPLE are to be killed. Thus, when there is no motive the police won't know who to arrest.
