

TO HIS HONOR, THE MAYOR OF THE CITY OF NEW YORK:

The undersigned present this statement concerning the management of the Building Department of the City of New York, and the conduct thereof, by its present Superintendent, Mr. Stevenson Constable, upon which they request that the said Superintendent be by your Honor removed from his official position as Superintendent of said Department.

And in support of such request they present herewith the following

CHARGE:

That the said Department has been and is, under the management of its present Superintendent, inefficiently and incompetently conducted. That it has been and is now managed and controlled in such manner as to cause great and unreasonable loss and damage to the owners of property in this City, to architects, builders and others engaged in the erection and alteration of buildings in this City -- all of which it is hereby charged is due to the inefficiency and mismanagement of the present Superintendent.

And in support of the foregoing charge, your petitioners submit the following specifications:

I. That the said Department, through its Superintendent, has caused "violations" and "unsafes" to be filed against buildings both erected and in course of erection, without just or reasonable cause.

II. That said Department, through its said Superintendent, has neglected and refused to remove "violations" and "unsafes" arbitrarily and without just cause filed against

buildings both erected and in course of erection, within reasonable time after the unjustness of such filing has been shown.

III. That the said Department, through its said Superintendent, has arbitrarily and without sufficient cause refused to sanction or approve plans and specifications submitted and filed as required by law for the erection and alteration of buildings.

IV. That the said Department, through its said Superintendent, has unreasonably and unnecessarily delayed in passing upon, whether for approval or disapproval, plans and specifications for the erection and alteration of buildings submitted as required by law.

V. That the said Superintendent, in his dealings and business with architects, builders and others having business with the said Department, has been and is arbitrary, overbearing and unreasonable. That by such arbitrary, overbearing and unreasonable conduct the said Superintendent has caused loss and damage to owners, builders, architects and others interested in the erection and alteration of buildings in this City, and that the general management and conduct of the said Department by its present Superintendent has been and is of such a character as to be a decided detriment and hindrance to the beginning and prosecution of building operations in this City.

And the undersigned state that they stand ready to establish by competent proof, the charge and specifications hereinabove made. And they respectfully pray that your Honor may cite the said Stevenson Constable, Superintendent of the Building Department of the City of New York, to answer the charge herein made, upon a day and hour to be by you named, and that they, the undersigned, may then and there have an opportunity to present their evidence in substantiation thereof.

## Stable and the Architects.

the Editor:

I read in your valuable paper one account about charges being preferred against Superintendent of Buildings Constable, and another in which he is sustained by a number of well-known architects. I am one myself. Those who signed the charges are men who have business with the Department at all times, and are very much annoyed by Constable's methods. Those who signed the sustainer are men who do not know anything about Constable, and seldom, if ever, visit the office—men who plan cathedrals, churches, halls and public buildings of all kinds in all parts of the State; men who plan skyscraping office buildings, of which Constable and his deputies are ignorant as to construction;

men who never visit the office in person, but generally send an aid; in fact, men who never transacted much business with the Department. It is the men who build homes for the people that are imposed upon, annoyed, insulted. Now, the sustainers say give Constable more money, more room, better accommodation. The facts are, the Department never had so much room as it has now, and for many years not so little business.

## WANT CONSTABLE REMOVED.

Petition with 100,000 Signatures Said to Be in Circulation.

A petition has been signed by 100,000 citizens, it is said, asking for the removal of Stephenson Constable, Superintendent of the Department of Buildings.

In order to prevent the use of any more defective building material, the Building Trades Section of the Central Labor Union at its meeting last night appointed a special committee of three to obtain information in regard to the use of defective material in buildings, and to lodge complaints at the Building Department.

Delegate Bausch, of the Wood-Carvers' Association, proposed the appointment of the committee, and he and James Miller, of the Elevator Constructors' Union, and James Fitzgerald, of the Marble Workers, were appointed on it.

## WANT CONSTABLE OUSTED.

Architects Charge the Superintendent of Buildings with a Score of Failings.

WILL PETITION FOR HIS REMOVAL.

They Are Now Seeking Signatures to a Request that Mayor Strong Wield the Axe.

A petition embodying serious charges against Stephenson Constable, Superintendent of the Building Department, is circulating among architects in New York City. When a sufficient number of names have been attached to it, the promoters say, it will be laid before the Mayor with a demand for Mr. Constable's removal.

The charges range from incompetence to gross neglect of duty. It is asserted that Mr. Constable is not only unfit to maintain the obligations of his office but that he even seeks to delay the work of the department. It is expected that the petition will be presented to Mayor Strong next week. The petition follows:

The undersigned present this statement concerning the management of the Building Department of the city of New York and the conduct thereof by its present superintendent, Mr. Stephenson Constable, upon which they request that the present superintendent be by Your Honor removed from his official position as superintendent of said department, and in support of such request they present herewith the following charges:

That said department has been and is, under the management of its present superintendent, inefficiently and incompetently conducted. That it has been and is now managed and controlled in such manner as to cause great and unreasonable loss and damage to the owners of property in this city and to architects, builders and others engaged in the erection and alteration of buildings in this city; all of which it is hereby charged is due to the inefficiency and mismanagement of the present superintendent. In support of the foregoing charge your petitioners submit the following specifications:

1. That the said department, through its superintendent, has caused violations and unsafes to be filed against buildings without just or reasonable cause.
2. That said department, through its superintendent, has neglected and refused to remove violations and unsafes arbitrarily and without just cause filed against buildings within reasonable time after the unjustness of such filings has been shown.

Charges three and four allege that Mr. Constable has refused to pass, or has unreasonably delayed passing, upon plans and specifications.

The fifth charge says the Superintendent is arbitrary, overbearing and unreasonable, whereby, as charge six asserts, owners, builders and architects have been caused loss and damage.

Dear Sir:-

I have noticed in the Daily Press petition to have been reported to have been signed by a number of architects and builders and submitted to you September 4th against the management of Department of Buildings and particularly against Mr. Constable Superintendent. I have been in the business for the last ten years and I have made a specialty of drawing plans for tenement and private houses, from the first of January up to the present time, I have had filed and passed by the department plans for not less than eighty five tenement houses, besides number of private houses, also alterations, and I must admit that I had very little trouble whatever in having plans approved. The cause of the delay in a good many instances in having plans approved by the Department is caused by the fact that some of the architects and builders are not fully versed in the requirements of the present building law and not with the department.

This is my personal knowledge and I think it is only due justice to Mr. Constable that I state as far as I can see his management has been upright and honest and impartial since he has held his office.
