

**REMARKS:**

**INSTRUCTIONS:**

1. Property coming into the custody of this department (except motor vehicles) shall be promptly invoiced on this form, which shall be typewritten in quadruplicate (2 white, 1 buff, 1 green), and forwarded with the property to the Property Clerk's office. The green copy shall be receipted by the Property Clerk and returned to the originating command for file. An additional green copy shall be prepared and forwarded to the Property Clerk with narcotics and decedent's property.
2. Separate vouchers shall be prepared for: a) prisoner's personal property; b) firearms; and c) narcotics.
3. If there is more than one prisoner, finder or claimant involved, enter the additional names and addresses under "Remarks". If owner or claimant is a corporation, give the corporate name, not the name of an individual connected with it.
4. U.S. currency shall be entered first, then foreign money, jewelry, etc. Each denomination of currency (bills and coins) shall be given an item number. The serial number of each bill shall be listed. Under "Cash Value", the total amount for each denomination of U.S. currency shall be entered.
- \*\*5. The estimated value of the property shall be entered under "Cash Value" ONLY when the property is returned to a claimant at the station house. The claimant's name and address and time and date of return of property shall be entered under "Remarks".
6. Security lead seals shall be used where appropriate and the seal number shall be entered alongside the description of the article. Not more than five articles shall be placed on one seal.
7. When invoicing found property, a transcript of the blotter entry concerning its finding shall be entered under "Remarks".
- \*8. When invoicing decedent's property, name and address of deceased and related aided case number shall be entered under "Remarks".
