
Dear Sir:-

We thank you very much for your courtesy, which was received at the hands of Mr. E. A. Noblett on last Saturday.

We infer from the contents of your note that Mr. Noblett has laid before you a tale of woe which is not of a very complimentary nature, as far as we are concerned, and we take the liberty of writing you merely to lay before you the plain facts in the case referred to.

During the evening of Monday, Nov. 22nd, in the usual course of our sale Mr. E. A. Noblett purchased lot #74 in our catalogue, paid for it and was given a receipt and order to take the animal from the Garden and we heard nothing more from him until the following Saturday when he, under the same conditions, purchased another animal in the consignment of Mr. C. W. Williams. If our memory serves us correctly we believe it was on the Monday or Tuesday of the second week of our sale when Mr. Noblett spoke to our Mr. Hedges regarding his first purchase, remarking that the animal did not exactly suit him and requesting that we resell the horse on his account. Our Mr. Hedges very readily assented to this and arranged with Mr. Noblett to offer it on Wednesday evening; in fact the gentleman requested that the horse should not be sold until Wednesday evening in order that he might be present personally and, to use his own expression, "push her up a little". We did not, at the time exactly understand the meaning of this remark, but what followed easily explained it. On Wednesday evening we sold the horse and much to our chagrin found that it was knocked down to Mr. Noblett himself. Thus, you see, Mr. Noblett violated a rule that it has always been our aim to enforce to the letter, i.e. to allow no "by bidding" of any name or nature whatever, and had we known at the time that he was bidding on the animal not only would we have instructed the attendant to remove the animal from the ring but would most positively have refused to accept a bid from Mr. Noblett. Herewith we beg to hand you one of our catalogues in the front of which you will find the conditions of sale, under which Mr. Noblett purchased the animal. We also enclose you one of our entry blanks on the back of which you will find the terms and conditions to Consignors.

Mr. Noblett's case, in a nutshell, is simply this, in the first place he was simply a purchaser and in the second he was a consignor. The sale closed, as you are aware, on Wednesday evening. On Thursday Mr. Noblett did not send to the Garden for the horse, and as we had to vacate the premises on that day, merely as an act of courtesy to him we took it upon ourselves to remove the horse from the Garden to the American Horse Exch.,

immediately notifying him of that fact and rendering him our bill for offering the animal. The horse is still Mr. Noblett's property and is subject to his order at the American Horse Exchange, on payment of charges against him.

You will see by the conditions that we are merely the agents of the buyer and the seller; it is our aim at all times to protect both and had Mr. Noblett made any claim whatsoever before the removal of the animal from the Garden we would have taken great pleasure in advising with the consignor, Mr. Butler, and doing all we could for him. However, the way the matter stands now it is simply between him and Mr. Butler, as we feel that we have acted in good faith and as an honorable business firm to a customer.

Hon. William M. Strong,
Mayor.

We, the undersigned residents and merchants of the City of New York, desire to call your attention to the corrupt practice of licensed auctioneers, who purchase entire stocks of merchandise to assist debtors to defraud their creditors, and more particularly to auctioneers, L. Ullman and Company, of 476 Broadway, New York.

On August 17th and 18th of this year we sold and delivered merchandise to Julius Schweizer of 67 Greene Street, New York, amounting to several thousand dollars, and on August 19th, 1897, between the hours of ten and twelve P. M., the entire stock of the said Schweizer was removed to the auction rooms of Mr. Ullman, he having purchased the same with the knowledge that Schweizer was insolvent; thereafter Schweizer has not been seen.

When we complained to Mr. Ullman he told us that it was his business to buy entire stocks of merchandise.

We are aware of your prompt action in similar matters in the past and sincerely beg you to take such steps in the matter as you deem expedient, for we are united to stop such practice.


