

Indictment for felonious assault and battery.

Herman Knabe, sworn and examined, testified:
Where is your place of business? No 1426 Third ave,
corner of Eighty first St.; it is a lager beer and
liquor saloon. Do you know this prisoner? Yes sir
Has he in your place on the 30th of May? In my
place; at that time I kept in Twenty sixth St. It was
not at that place? No sir. You kept a saloon where?
No 555 West Twenty sixth St. At that time did this
prisoner come in there? Yes sir, with three more
men. What time of day? I should judge about three
o'clock in the afternoon. They called for drinks, I
gave them four drinks. After they had the drinks
I says, "Who is going to pay for these?" He told me
he had no money; he walked out. Let them go, I
did not say any more, I was glad to get rid of
them. About half an hour or twenty minutes after
they came back again and said, "Give us some
more drinks." I said, "No, I won't give you any
drinks. If you don't give us to us, we are going
to get it." I says, "I guess not so long as I am
here." One of these men took up a pitcher standing
at the bar and got hold of it with his two
hands and tried to chuck the pitcher in my
face. I got hold of the pitcher. I had an ice hatchet
in the other. In the mean time the rest of the
party commenced to fire glasses and chairs

anything they could get hold of they fired at me. I hit the prisoner right in the shoulder; he staggered and he fell down, and these other parties fired the glasses and anything they got hold of and this young man (the prisoner) came up again and pulled a pistol and fired two shots at me. I was behind the counter. If I had gone from behind the counter they would have killed me; he fired twice. A man up stairs heard the noise and came down and he opened the door. They could not get any more glasses or anything else. I told this man who came down stairs to help me to get them out; when he came down they all ran out. The shot did not take effect upon me. I saw the pistol in his hand and saw the flash; the counter is about two or two and a half feet wide; he was about two feet away from the counter. Cross Examined. I struck the prisoner with the pick from behind the counter. He held the pistol right at me over the bar; he held it in his right hand that way (showing) I was standing about four feet from him opposite him at the time; the pistol was about level with my head. How soon after this was the prisoner arrested? He was arrested about three weeks ago. You made a complaint at the time. Was the muzzle of the pistol pointed at you at the time it was fired? The muzzle of the pistol was pointed at me when the flash went off. I saw the muzzle.

Patrick Kiernan, sworn and examined in his own behalf testified. Live in South Second St. Brooklyn. In what do you work? Joseph Cowley. What place in Brooklyn does he carry on business? Greenpoint. You heard the statement of the complainant here? Yes sir. You were in his place that day? Yes sir. Tell the jury all that occurred in that place? On May 18, 1880 I went into Krabe's place and called for some drinks; he was behind the bar talking to another man; he came over to me and says, "I don't care for selling you any drink." I says, "How is that? You might as well sell to me as to anybody else." He said, "No; go on out of here." I had a 50 cent piece on the bar. I took my money out and put it into my pocket, and he picked up an ice pick from under the counter and he came around and struck me with it in the neck and I stumbled on the floor. I got up again and Mr. Krabe was following me up. I was about four feet from the door, and this pistol I had I took it out and I fired it towards the ceiling for fear he might get on me and strike me with that ice pick again. Did you point that pistol at Mr. Krabe, the muzzle at him? No sir, I pointed it at the ceiling to scare him back. Had no intention of hitting him, I intended to scare him. Where was Krabe at the time? He was outside the bar when he struck me with the pick. How tall are you? About five feet ten or eleven, I am

not sure which. You say you were on the floor when Mr. Knabe struck you with a pick? Yes sir. Can you form any idea about how far you were from the counter at the time he struck you; what was Mr. Knabe's position towards you at the time he struck you with the pick, was he outside the counter or inside the counter? Outside the counter. Were you between the counter or the door? I was between the counter and the door trying to back out when he struck me, I was backing out, I was afraid to turn round. Cross Examined. Were you ever in there before? Yes sir, I used to go in once in a while. You had been in there before? Yes sir. He knew you? Yes sir. Ever had any trouble there before? No sir. Were you in there alone this day? No sir; there was a couple of friends with me, two or three, I am not sure which I ordered drinks and put 50 cents down on the counter and Mr. Knabe refused to give us drinks, I don't know why. I was not drunk; he had no trouble with me. I did not get any drinks and I did not refuse to pay for them. I did not get a chance to tell my story before the Police Magistrate. It was not a revolver I fired; it was a powder pistol. I did not throw any glasses, but I guess my friends threw some. I lifted the pitcher but I did not try to fire it at him.

Officer Patrick McElwain swore that that night he arrested the prisoner on this complaint but he got away; he took a pistol from him. He was convicted of assault and battery. Penitentiary; one year; fine, \$250.


