On the accompanying resolution of the Board of Aldermen, No 595, to pave 13th Avenue, from 23rd to 27th Street, with granite blocks on concrete foundation, within the limits of land grants, I have the honor to report:

Thirteenth Avenue was recently filled in and is still settling. The part of the avenue already paved with granite blocks on concrete foundation is settling to such an extent as to seriously damage the pavement, and it is not so easy to make repairs as if the granite blocks had been laid on sand. It is therefore recommended that the resolution be amended by striking out the words "on concrete foundation."

The resolution provides that "the said Kilpatrick and Roylance shall at all times keep the switch or track hereby authorized in good repair, also the pavement between said tracks and at least two feet thereof in good condition and repair."

I respectfully recommend that the resolution be amended so as to read, after the words "as shown upon the accompanying diagram,"--"under the direction of the Commissioner of Public Works, and the said Kilpatrick and Roylance shall keep the pavement between the rails of their track and two feet outside of it, in good repair; and at all times when a new pavement is laid either upon 11th Avenue or 58th Street, restore their pavement between their rails and two feet outside, in conformity to the specifications for paving either the said street or avenue."

I have the honor to submit report on the following resolutions, passed by the Board of Aldermen and now awaiting your action:

✓ No 601. To pave with Macadam the roadway of the Boulevard Lafayette, from 11th Avenue to Kingsbridge Road, etc.

✓ No 602. To pave 98th Street, from 4th to 5th Avenue, with asphalt on concrete foundation.

✓ No 604. To pave 150th Street, from the Boulevard to Amsterdam Avenue, with asphalt.

✓ No 605. To pave 100th Street, from 4th to 5th Avenue with asphalt.

These pavements are necessary, and it is recommended that the resolutions be approved.

✓ No 614. To permit M. J. Leonard to place and keep a watering-trough at the corner of 7th Avenue and 150th Street.

✓ No 620. To permit C. J. Sullivan to erect and maintain an iron watering-trough at 100th Street and the Western Boulevard.

Watering-troughs at these two locations would benefit the public. It is recommended that the resolutions be approved.

✓ No 626. To permit Charles Hoenninger to place an ornamental clock in front of No 529 Third Avenue.

As the proposed clock will not exceed the dimensions prescribed by the City ordinance in relation thereto,

there is no objection to the resolution.

✓ No 610. To permit the Chelsea Union to place transparencies on the lamp-post on the N. E. corner of 35th Street and 8th Avenue, and on the N. W. corner of 29th Street and 8th Avenue.

There is no objection to the placing of a transparency on the lamp-post at 29th Street and 8th Avenue, but the placing of a transparency on the lamp-post at 35th Street and 8th Avenue should not be permitted because this is a fire-alarm signal lamp.

✓ No 613. To permit the Chelsea Union to place transparencies on a certain lamp-post at the N. W. corner of 24th Street and 8th Avenue.

✓ No 615. To permit the Chelsea Union to place and keep transparencies on lamp-posts at the N. W. corner of 18th Street and 8th Avenue, S. W. corner of 14th Street and 8th Avenue, and S. W. corner of Perry and Hudson Streets.

✓ No 617. To permit the Chelsea Union to place and keep transparencies on lamp-posts at the N. E. corner of 51st Street and 8th Avenue, and the N. E. corner of 48th Street and 8th Avenue.

✓ No 628. To permit the Chelsea Union to place transparencies on the lamp-post on the N. W. corner of 43rd Street and 8th Avenue.

As the lamp-posts referred to in the four preceding resolutions are not used for lighting purposes, there is no objection to the resolutions.

✓ No 609. To permit S. V. R. Cruger to pave the sidewalk in front of No 273 Spring Street.

There is no objection to this resolution, provided that Mr Cruger will lay one course of four feet of heavy flagging or bridge-stone through the centre of the sidewalk.

✓ No 618. To permit Patrick H. Carley to place and keep a watering-trough on the sidewalk, near the curb, in front of No 553 West 46th Street.

✓ No 625. To permit Albert Weilds to place and keep

a watering-trough on the N. W. corner of 194th Street and Kingsbridge Road.

The watering-troughs provided for in these two resolutions are not considered necessary.

✓ No 608. To permit Fred Mayser to place and keep a sign on the unused lamp-post in front of the Central Opera House, No 207 East 67th Street.

There is no unused lamp-post in front of these premises, but there is a City lamp which is regularly lighted. As it is the intention of the applicant to use this lamp for advertising purposes, it is recommended that the resolution be not approved.

No 663. For gas-mains, etc., in Ryer Avenue, from Burnside Avenue to a point 600 feet north.

No 664. For gas-mains, etc., in Montgomery Avenue, from East 176th Street to 177th Street.

No 665. For gas-mains, etc., in St. John's Avenue, from Crescent Avenue to Pelham Avenue.

No 666. For gas-mains, etc., in Crotona Park North, running westerly from Franklin Avenue for a distance of 350 feet.

No 670. For gas-mains, etc., in Samuel Street, from Honeywell Avenue to Mohegan Avenue.

No 671. For gas-mains, etc., in 179th Street, from 3rd Avenue to Park Avenue.

No 673. For gas-mains, etc., in Park Avenue, from 97th to 102nd Street.

No 676. For gas-mains, etc., in 100th Street, from Madison Avenue to 4th Avenue.

No 677. For gas-mains, etc., in Lexington Avenue, from 97th to 100th Street.

No 678. For gas-mains, etc., in 183rd Street, between Kingsbridge Road and Amsterdam Avenue.

No 679. For gas-mains, etc., in Terrace View Avenue, from Broadway to Jansen Avenue.

No 680. For gas-mains, etc., in Hamilton Terrace, from 142 to 144th Street.

There is no objection to these resolutions, and

I recommend that they be approved.

✓ No 708. To fence vacant lots on the south side of 84th Street, from Amsterdam Avenue to the Boulevard.

It is necessary to fence these lots to prevent the commission of nuisances thereon. I recommend that the resolution be approved.

✓ No 653. To lay water-mains in 179th Street, from 3rd to Park Avenue.

✓ No 645. To lay water-mains in St. Nicholas Avenue, from 111th to 125th Street.

✓ No 646. To lay water-mains in the Boulevard, between 111th and 116th Street.

✓ No 647. To lay water-mains in Ryer Avenue, from a point 450 feet north of Burnside Avenue to a point 600 feet north of said Avenue.

✓ No 648. To lay water-mains in Lexington Avenue, between 97th and 98th Streets.

✓ No 651. To lay water-mains in 123rd Street, between Amsterdam Avenue and the Boulevard.

✓ No 644. To lay water-mains in 113th Street, between 6th and 7th Avenue.

The water-mains provided for in these seven resolutions are necessary. I therefore recommend that the resolutions be approved.

✓ No 636. To pave 113th Street, from Amsterdam to Morningside Avenue, with asphalt.

✓ No 709. To pave 97th Street, from the Boulevard to Amsterdam Avenue, with asphalt

✓ No 703. To pave 149th Street, from Convent to Amsterdam Avenue, with asphalt.

✓ No 702. To pave Convent Avenue, from 149th to 152nd Street, with asphalt.

✓ No 698. To pave 143rd Street, from the Boulevard to the New York Central Railroad tracks.

✓ No 657. To pave 148th Street, from Convent to Amsterdam Avenue.

The pavements provided for in the six preceding resolutions being necessary, I recommend that the

resolutions be approved.

✓ No 660. For a supply of water to the improved drinking fountain on the S. W. corner of 146th Street and Third Avenue.

This drinking fountain will be a great convenience to the public. I recommend that the resolution be approved.

✓ No 637. To pave 114th Street, from Amsterdam to Morningside Avenue, with asphalt.

✓ No 641. To pave Park Avenue, west side, from 97th to 101st Street, with asphalt block pavement.

✓ No 642. To pave 99th Street, from Park to Madison Avenue, with asphalt blocks.

It is necessary to pave these parts of 114th Street, Park Avenue and 99th Street. I recommend that the resolutions be approved.

✓ No 640. For lamp-posts, etc., in East 89th Street, between East End Avenue and the East River.

✓ No 662. For gas-mains, etc., in Mohegan Avenue, from Samuel Street to 181st Street.

✓ No 667. For gas-mains, etc., in Independence Avenue, from Boston Avenue to Broadway.

✓ No 668. For gas-mains, etc., in East 172nd Street, from the Southern Boulevard to Vyse Avenue.

✓ No 669. For gas-mains, etc., in Fleetwood Avenue, from 173rd Street to a point 350 feet north.

✓ No 672. For gas-mains, etc., in 234th Street, from Webster Avenue to Grand Avenue, etc.

✓ No 674. For gas-mains, etc., in 99th Street, between Park and Madison Avenues.

These seven resolutions are premature inasmuch as the streets proposed to be lighted have not been regulated and graded or are otherwise not in a condition to render practicable the laying of gas-mains and the lighting of public lamps. It is recommended that the resolutions be not approved.

✓ No 649. To lay water-mains in Hunt Avenue, from Bronxdale Avenue to Sagamore Street, etc.

This avenue is in the newly annexed district. The City has no water-mains there, and there is no appropriation to pay for obtaining a supply of water from private sources. It is recommended that the resolution be not approved.

✓ No 652. To lay water-mains in Independence Avenue, from Boston Avenue to Broadway.


It will require the remainder of this year to finish the grading of Independence Avenue, now in progress, and there are no houses on the line of the avenue to be supplied with water. The resolution is premature.

It is recommended that it be not approved.

✓ No 699. To pave 187th Street, from 11th Avenue to Kingsbridge Road, with granite blocks.

This improvement is necessary, but the resolution should be amended so as to provide for a concrete foundation for the granite.



Dear Sir:

On the accompanying resolution of the Board of Aldermen, No 656, directing the Commissioner of Public Works to provide electric illumination to Room 16 of the City Hall, by applying to the chandeliers and other gas fixtures in said room incandescent lamps and the requisite power to supply the necessary light; also to supply a sufficient number of electric fans for said room, I have the honor to report that in the estimate for supplies for 1896 no provision was made for the expenditure necessary to carry this resolution into effect; and the drafts upon our supply fund have already been so heavy that there remains in hand but a small balance, barely sufficient to pay for such supplies as will be absolutely necessary between this time and the close of the year. No 726. To erect an iron stairway at the N. E. corner of 89th Street and 3rd Avenue.

This resolution is opposed on the ground that the erection and maintenance of the proposed stairway would constitute an illegal obstruction on the public sidewalk. Although the stairway would be within the stoop-line it would nevertheless be illegal, for it has been held in the case of *The People ex. rel. Reilly against the Mayor, etc.*, that "the corporate authorities have no power to authorize encroachments upon the streets except such as are provided by law. The space within the stoop-line is as much a part of the street as is any portion travelled over by the public."

No 721. To permit H. Pomerantz to keep two ornamental lamp-posts and lamps in front of No 264 Broome Street.

There is no objection to this resolution, and I recommend that it be approved.



✓ No 761. To permit M. Bromberg to keep an ornamental lamp-post and lamp in front of No 76 Carmine Street.

There is no objection to this resolution.

The Chief Engineer reports that he sees no objection to extending this vault to the curb-line, provided that a pocket be left in the vault, three feet by three feet in the clear, for hydrant now there and as shown on the plan.

No 756. To permit the Siegel-Cooper Co. to lay a cross-walk of asphalt on 6th Avenue, between 18th and 19th Streets.

The crosswalk provided for in this resolution is a desirable improvement, and would be a convenience to a large body of shoppers.

No 757. To permit the Church of St. Ignatius Loyola to extend the vault of the Church on the N. W. corner of Park Avenue and 83rd Street.

There is a receiving-basin at this corner which cannot be dispensed with. No vault extension should be allowed which includes the space occupied by this basin. As the basin is what is called a side-basin, located on 83rd Street, about eight or ten feet from the corner, it is suggested that if it should be determined to grant permission to extend the vault, and the Church authorities would prefer to build a new basin directly at the corner, the old basin might be dispensed with, but in no case can the drainage of that corner be secured without a basin.

No 758. To permit the construction of a double track railroad by the New York and Brooklyn Railroad Company in, by and through a tunnel from the intersection of Ann Street and Park Row to and under the East River, so far as the jurisdiction of the City of New York may extend, etc.

The Chief Engineer reports that, having no plans or profiles of the proposed tunnel, he cannot make an intelligent report on the resolution.


Referring to my letter to you of 22nd inst., in which I reported on resolution No 757 of the Board of Aldermen, to permit the Church of St. Ignatius Loyola to extend a vault in front of its premises on the N. W. corner of 83rd Street and Park Avenue, which resolution has been returned to this Department for re-examination, I beg to say that this department will have no objection to the resolution provided it be amended to read as follows:

R E S O L V E D

That permission be and the same is hereby given to the Church of Saint Ignatius Loyola to construct a vault in front of its premises on the north-west corner of 83rd Street and Park Avenue, having a frontage of 50' 10" on Park Avenue and 50' 0" on East 83rd Street, as shown upon the accompanying diagram, the space covered by the vault not to include that occupied by the present receiving basin, unless said basin is rebuilt at the corner by the Church authorities; without payment of the usual fee, provided the said Church of Saint Ignatius Loyola stipulates with the Commissioner of Public Works to save the City harmless from any loss or damage that may be occasioned during the progress or subsequent to the completion of the work of extending said vault; the work to be done at its own expense, under the direction of the Commissioner of Public Works, such permission to continue only during the pleasure of the Common Council.

The amended part of the resolution is underscored.

I have the honor to present report on the following resolutions, passed by the Board of Aldermen and now awaiting your action:

No 825. To permit the West Side Bank to place and keep an ornamental clock and post on the sidewalk, near the curb, in front of Nos 485 and 487 Eighth Avenue.

The dimensions of this post and clock will not exceed those prescribed by the revised ordinances, hence there is no objection to the resolution.

No 824. To permit N. L. Glauber to place and keep a show-case within the stoop-line in front of his premises S. W. corner of 17th Street and 6th Avenue.

Upon investigation it is found that the show-case provided for in this resolution will not conform to the provisions of the revised ordinance of 1886 in relation to show-cases. It is proposed to place the show-case on the side of the building, where it would be a permanent structure greatly in excess of the dimensions prescribed by the ordinance for show-cases. I therefore recommend that the resolution be not approved.

No 827. To permit Andrew Mickels to place and keep an iron railing for conveying meat in front of his premises on the east side of First Avenue, 50 feet south of 13th Street.

Upon inspection, it is found that the iron railing referred to in the resolution is already in place and

has been used for several years. No permit was ever granted for it, and the resolution is the result of a notice which was served upon the owner to remove it. Complaints have been made to this Department that the railing is an obstruction to the free use of the sidewalk. For this reason I ask you to disapprove the resolution.

No 368. To light 142nd Street, from Brook to St. Ann's Avenue.

No 369. For three additional lamps in front of the Immaculate Conception, 14th Street.

No 370. For gas-mains in Fulton Avenue, between Pelham Avenue and St. John's College Grounds.

All the gas-mains, public lamps, etc., called for in the 15 preceding resolutions are necessary, and it is recommended that the resolutions be approved.

No 372. To pave 114th Street, from the Boulevard to Riverside Drive, with asphalt blocks on concrete foundation.

The Water Purveyor reports that 340 lineal feet of this street have a grade of 9 per cent., which is too steep for asphalt block pavement. This area should be paved with granite blocks, and it is recommended that the resolution and ordinance be amended accordingly.

Amended

No 379. To permit the Commercial Cable Company to remove the pillar and globe from the curb in front of the premises No 12 West 27th Street to a like position in front of the premises No 1,269 Broadway.



No 362. To light Longfellow Street, from Home to Jennings Street.

No 367. To light Stebbins Avenue, from 400 feet north of Jennings Street to East 169th Street.

These thoroughfares are not regulated and graded and have no sidewalks on which to place public lamps. The resolutions are premature.

I have the honor to report on the following resolutions, passed by the Board of Aldermen and now awaiting your action:

No 477. To pave 101st Street, from Madison to 5th Avenue, with asphalt blocks on concrete foundation.

This is a very desirable improvement. It is therefore recommended that the resolution be approved.

No 469. To lay water-mains in 98th Street, between West End Avenue and Riverside Drive.

No 470. To lay water-mains in the Boulevard, between 119th and 122nd Street, etc.

No 471. To lay water-mains in Stebbins Avenue, 400 feet north from Jennings Street to East 169th Street.

The water-mains provided for in these three resolutions are necessary. It is recommended that the resolutions be approved.

No 463. To permit Helen C. Juillard to lay a steam pipe in St. John's Lane.

There is no objection to this resolution as it provides that the usual fee shall be paid for the privilege and that the work shall be done under the supervision of this Department at the applicant's expense.

No 460 . To permit Rocco Marasco to erect and maintain a show window in front of No 55 Spring Street.

There is no objection to this resolution as it provides that the show window shall be such as will comply

in all respects with the provisions of the ordinance adopted May 21st, 1895.

No 455. To erect an additional lamp-post, with lamp, in front of the Press Club No 34 West 26th Street.

As there is no lamp in front of the Press Club, there is no objection to the resolution.

No 473. To lay water-mains in Anthony Avenue, from Gray Street to 174th Street.

No 474. To lay water-mains in East 170th Street, from Crotona Avenue to Boston Road.

No 475. To lay water-mains in Quarry Road, from Arthur Avenue to Lafontain Avenue, etc.

The sections of Anthony Avenue, East 170th Street and Quarry Road in which it is proposed to lay water-mains, are not graded. They should be graded before water mains are laid.

No 472. To lay water-mains in Intervale Avenue, from Freeman Street to Wilkins Place.

There are no houses to be supplied with water on this part of Intervale Avenue, hence the resolution is premature.

No 465. To permit Henry Koch of No 2,204 8th Avenue to place and keep a storm-door in front of said premises.

No 461. To permit Thomas Ohl to place and keep a storm-door in front of his premises N. E. corner of 125th Street and 2nd Avenue.

No 456. To permit Joseph Ullmann to place and keep a storm-door in front of No 165 Mercer Street.

Storm-doors are illegal encroachments on the public sidewalks. It is therefore recommended that resolutions Nos 465, 461 and 456 be not approved.



Dear Sir:

In the matter of the accompanying resolution of the Board of Aldermen, No 476, to pave 98th Street, from West End Avenue to Riverside Drive, with asphalt blocks, I have the honor to report that the grade is too steep for a pavement of this character, or for granite blocks. At West End Avenue the elevation is 75 feet; 100 feet west of West End Avenue, 76 feet, and then it falls in $265\frac{1}{4}$ feet to an elevation of 51 feet, making the maximum $9\frac{1}{2}$ per cent. If a uniform grade had been adopted, it would have been less than 6.6 per cent, which would make an asphalt block pavement practicable. I recommend that the resolution be not approved because neither an asphalt nor a granite pavement can be laid on that street until the grade is changed and made uniform.

As requested, I present report on the following resolutions, passed by the Board of Aldermen and now awaiting your action:

No 479. To appoint Albert Carr a City Surveyor.

The Consulting Engineer reports that Mr Carr is familiar with the theory and practice of surveying and competent to perform the duties of a City Surveyor.

No 522. To flag the north side of 88th Street, east of Madison Avenue.

I have certified to the Board of Aldermen that the safety, health and convenience of the public require that this sidewalk be flagged. It is recommended that the resolution be approved.

No 525. To fence vacant lots on the north side of 116th Street, between 5th and Lenox Avenues.
