

S i r : -

I hope you will forgive me for inflicting my troubles on you, but I can only say in extenuation that the one glimmering ray of hope visible to me at this time is through application to you, and this alone is my excuse for the annoyance I may cause.

To begin with, I am at present an Official Stenographer in the City Magistrates' Court, First Division, at a salary of \$2,000.; last month I was appointed by the Board of Special Sessions Justices an Official Stenographer in the Children's Court, Borough of Manhattan, at a salary of \$2,500. I regret to say, however, that the Municipal Civil Service Commission refuses to transfer me from the City Magistrates' Courts to the Children's Court on the ground that a new rule, passed in 1904, prohibits the transfer of stenographers from the grade of \$1,800. up to \$2,400. (which is the grade they are pleased to classify me in), into the grade of \$2,500. to \$3,000. (which is the grade the Children's Court position is classified in.)

Nevertheless, on or about the 1st of January last, the Municipal Civil Service Commission transferred John R. Steven-

son from the Municipal Court of this City, salary \$2,000. per annum,- the very grade I am classified in - to the City Court of this City at a salary of \$3,000., the position in this instance, I omitted to say, being that of Official Stenographer, and I am anxious to learn, in view of Mr. Stevenson's transfer, why that does not establish a precedent for my transfer in the same way.

In conclusion, Your Honor, let me say that at the time I was appointed in the Police Courts - a matter of twelve years ago - there were no such grade classifications, and I could have been appointed to the City Court, the Court of Special Sessions, or any other court in the County where there happened to be a vacancy at that time, and I am at a loss to understand why this 1904 rule should operate against me after all these years of service.

May I hope, sir, that you will consider this application for relief, and take such action in the premises as may seem to you fitting and proper?
