The officials in charge are making every

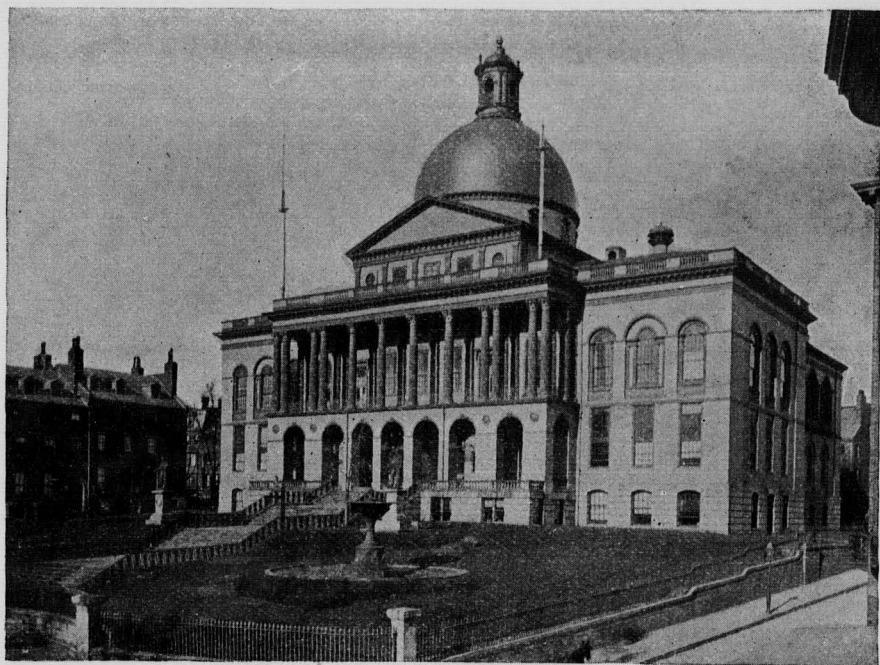

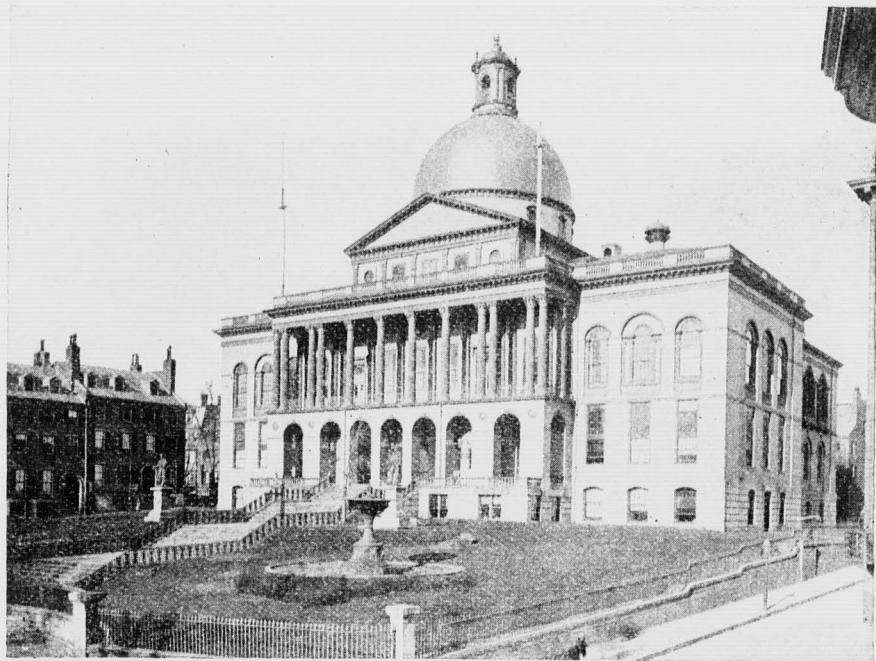

My dear Mr. Mayor:-

As Secretary of the Committee on Transportation I have the honor to report that several efforts were made to secure the attendance of a majority of the Committee, but was unable to do so in consequence of the absence in Europe of three members of the Committee and the illness of Mr. H. Walter Webb prevented his transacting any business. No members of the Committee except Mr. Spencer the Chairman, General Thomas and myself could be got together, and General Thomas early in April sailed for Europe. The work of the Committee was delegated by them to myself and I have discharged it to the best of my ability.

The principal work devolving upon the Committee was,

1st. Negotiations with the Trunk Line Commissioners for the purpose of procuring low passenger rates from all points in the United States, which was accomplished after several meetings, with the friendly aid of Commissioners George R. Blanchard and L.P. Farmer. The result of this negotiation was reduced to writing and printed in the form of a circular (a copy of which is annexed hereto), and was widely distributed through most of the principal newspapers in the territory

affected by the reduction of rates.

2nd. The duty of providing transportation for The President of the United States, his Cabinet, The Vice President of the United States, The Speaker of the House of Representatives, The Diplomatic Corps, the family of General Grant, Generals Longstreet and Buckner, the General Commanding the Army of the United States, the retired Admirals of the Navy, and the Admiral commanding the Navy, devolved upon this Committee.

Arrangements were made with The Pennsylvania Railroad Company and The Baltimore & Ohio Railroad Company to run special trains from Washington to New York and return:

The Pennsylvania Railroad provided the private car of its President, Mr. Frank Thomson, for The President of the United States his Secretary and family. Two Parlor cars for the use of the Diplomatic Corps. One Parlor Car for the use of the Cabinet and the family of General Grant and General Miles, commanding the Army. A Parlor car for reporters and members of Committees assigned to this train. A dining car, and a combination baggage and smoking car, for the accommodation of all guests, constituted the President's train.

The Baltimore & Ohio Railroad provided a private car for the use of The Vice President of the United States, his family and Secretary. Also a private car for the use of Thomas B. Reed, Speaker of the House of Representatives.

A Pullman Parlor Car for the use of General Longstreet, the Admirals of the Navy, etc., guests of the City of New York, and arrangements were made by which luncheon was served in the cars of The Vice President and The Speaker of the House of Representatives for the guests of the City.

A Parlor car, one dining car, and a combination baggage and

smoking car, for the accommodation of the Committees of the two Houses of Congress who were accompanied by their Sergeant at Arms, who paid their bills for luncheon etc. A Parlor car for reporters and members of Committees assigned to this train.

It required considerable detail work to arrange the transportation of so many distinguished persons with their secretaries and servants. I personally visited Washington four times arranging these details. Special tickets admitting each guest to their special train were printed and personally delivered to each guest by special messenger or by members of the Transportation Committee.

Both trains left Washington at precisely 10:30 A.M. April 26th, arriving at New York 3:12 and 20, respectively, where they were surrendered to the Reception Committee who took them in charge. They were landed by special Ferry Boats at the foot of West 23rd Street.

Returning, the trains left New York at 11:30 A.M. on the 28th, and arrived at Washington at 5 P.M.

Not a hitch occurred nor has a complaint been received by the Committee in regard to the management of these trains and so far as advised everything was carried out as designed.

It became necessary to have some assistance in the management of these trains and for the work of the Transportation Committee and I therefore employed Mr. Charles H. Rodda, my Secretary during the last Campaign, who has given two months or nearly so to this work. Mr. E. V. Skinner, who was subsequently appointed member of this committee assisted by the Hon. Charles H. Treat and Samuel G. French, took charge of the Baltimore & Ohio train. Mr. Rodda and myself took charge of the President's train.




