I wrote to ask if there was any way in which you might help me to become eligible so that I might have a chance to compete in the examinations.

It seems to me that the above requirement is unjust as it debars many who are well qualified to teach & able to pass the requisite examinations although they have not completed a college course.



SMALL PARKS COMMITTEE.

Former Mayor Hewitt May Have the Chairmanship if He Accepts.

Mayor Strong announced this morning that he would in a few days appoint an advisory committee on small parks. Former Mayor Abram S. Hewitt will probably be named as Chairman of the committee if he will accept.

The other members have not yet been selected, but the Mayor is in correspondence with several men in reference to the matter. The committee will consist of three or five members, and they will serve without salary.

The committee is to be appointed to look over the field and select locations for small parks on the East and West sides in the tenement house districts, as provided for in various acts of the Legislature. On the report of this committee the Board of Estimate will appropriate the money.

But it is that daughter who now asks a kindness at your hands. My Husband, Chas. G. Wilson, seeks the appointment as Postmaster here. Peacock, is a member of the County Republican Executive Committee and as such by misrepresentation and the use of fraudulent proxies secured the endorsement of the Committee, though my Husband had the personal endorsement of eleven out of a possible sixteen.
