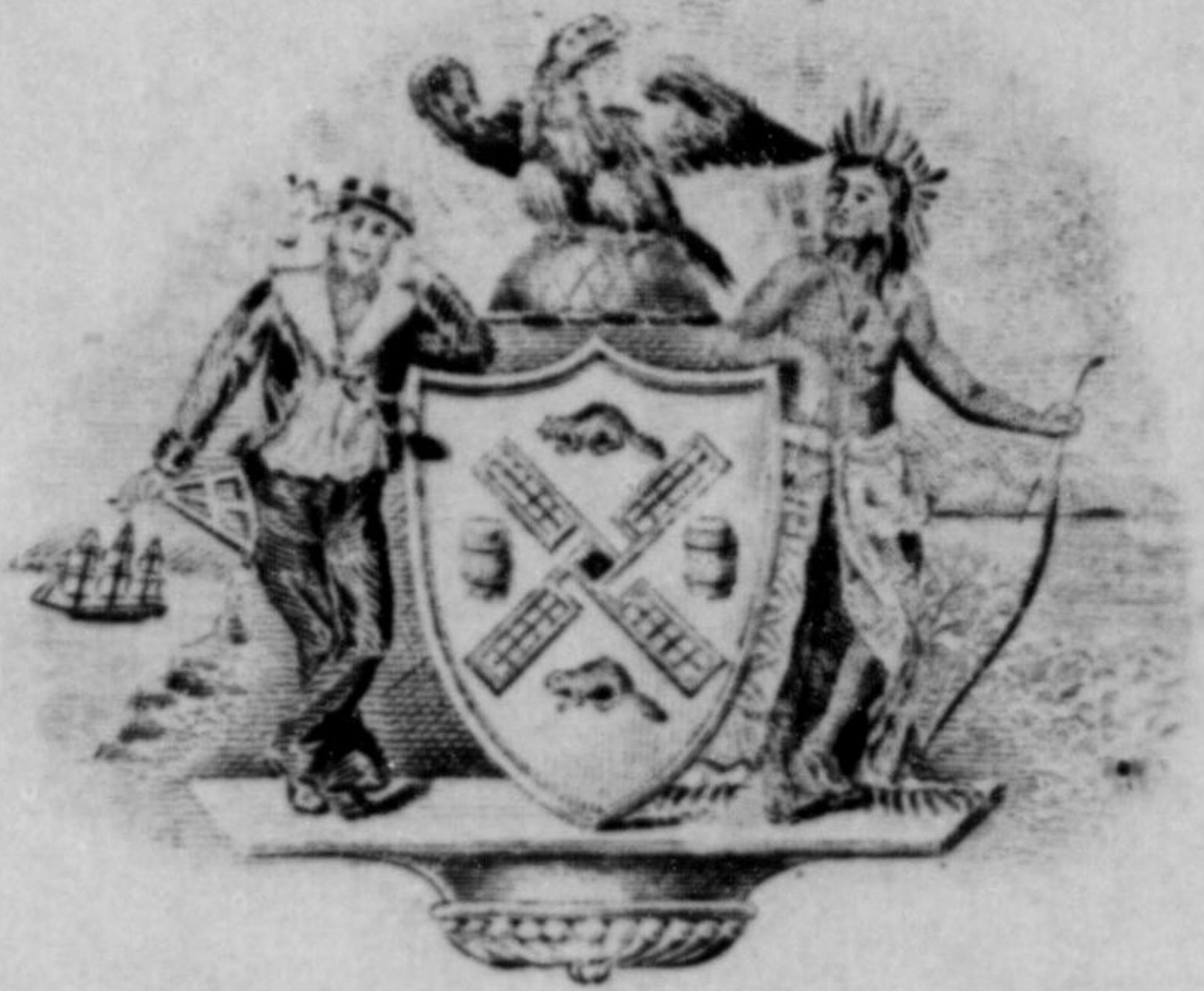

Your attention is called to the following resolution adopted by the Board of Aldermen, at its meeting held on February 15th, 1910:

Whereas, The Charter provides in section 188, subdivision 8, that issues of special revenue bonds for supplementing the annual Budget shall be limited to \$2,000,000 per annum; and

Whereas, The departmental requests for issues under this provision of the Charter each year greatly exceed this sum; and

Whereas, Such requests ordinarily fail to present sufficient information upon which to base an intelligent judgment as to the necessity for the granting thereof; and

Whereas, The avowed intent of the Charter for such issues is to meet only unforeseen expenses and emergent purposes; therefore be it

Resolved, That the heads of the various departments, offices, bureaus and divisions of the City and County governments be requested to present to this Board a full and comprehensive statement indicating the necessity, reasons and all essential data for each request for special revenue bonds, to be prepared in a manner similar to that required by the Board of Estimate in submitting the annual Departmental Estimates.

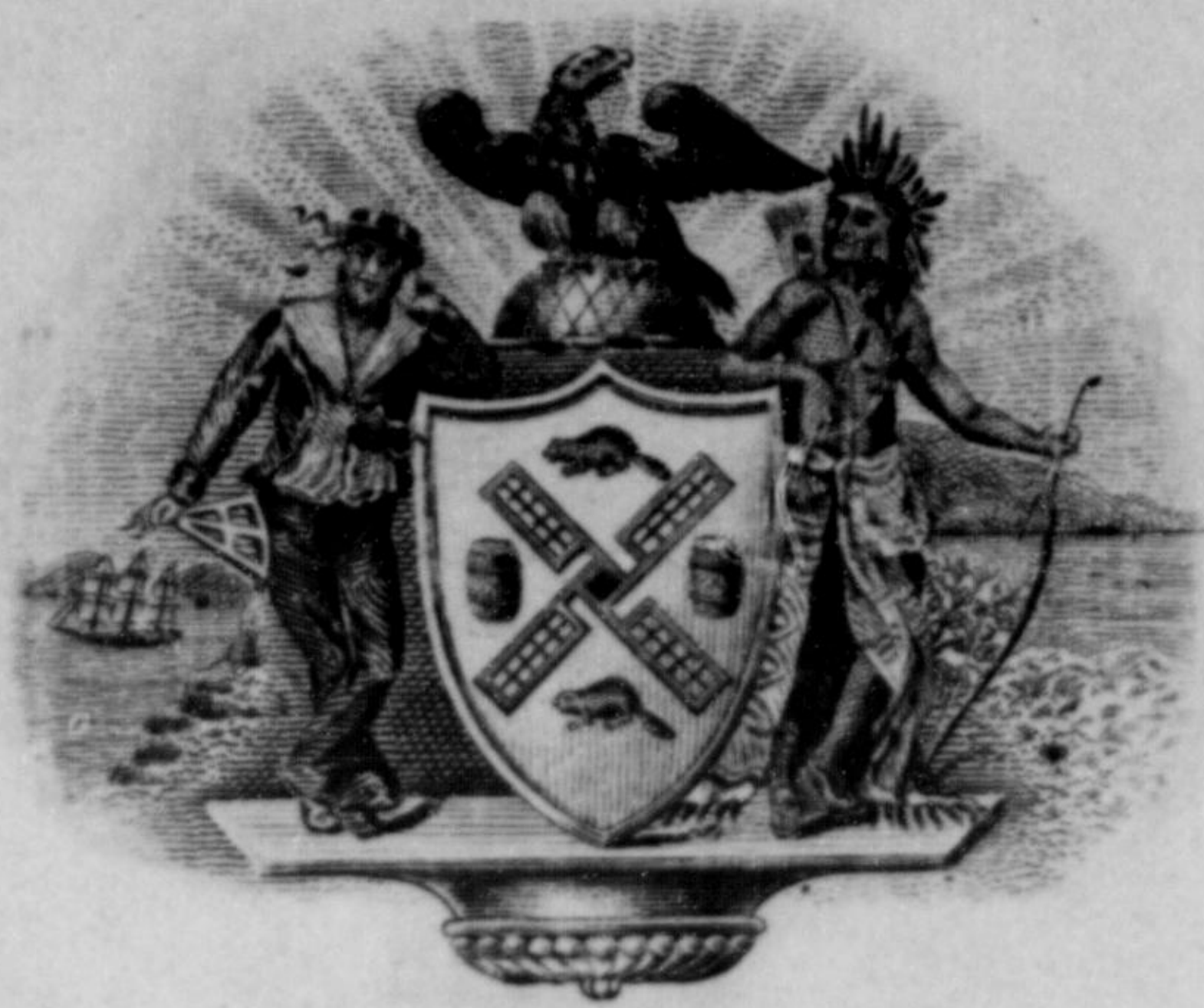




The Board of Aldermen of The City of New York,

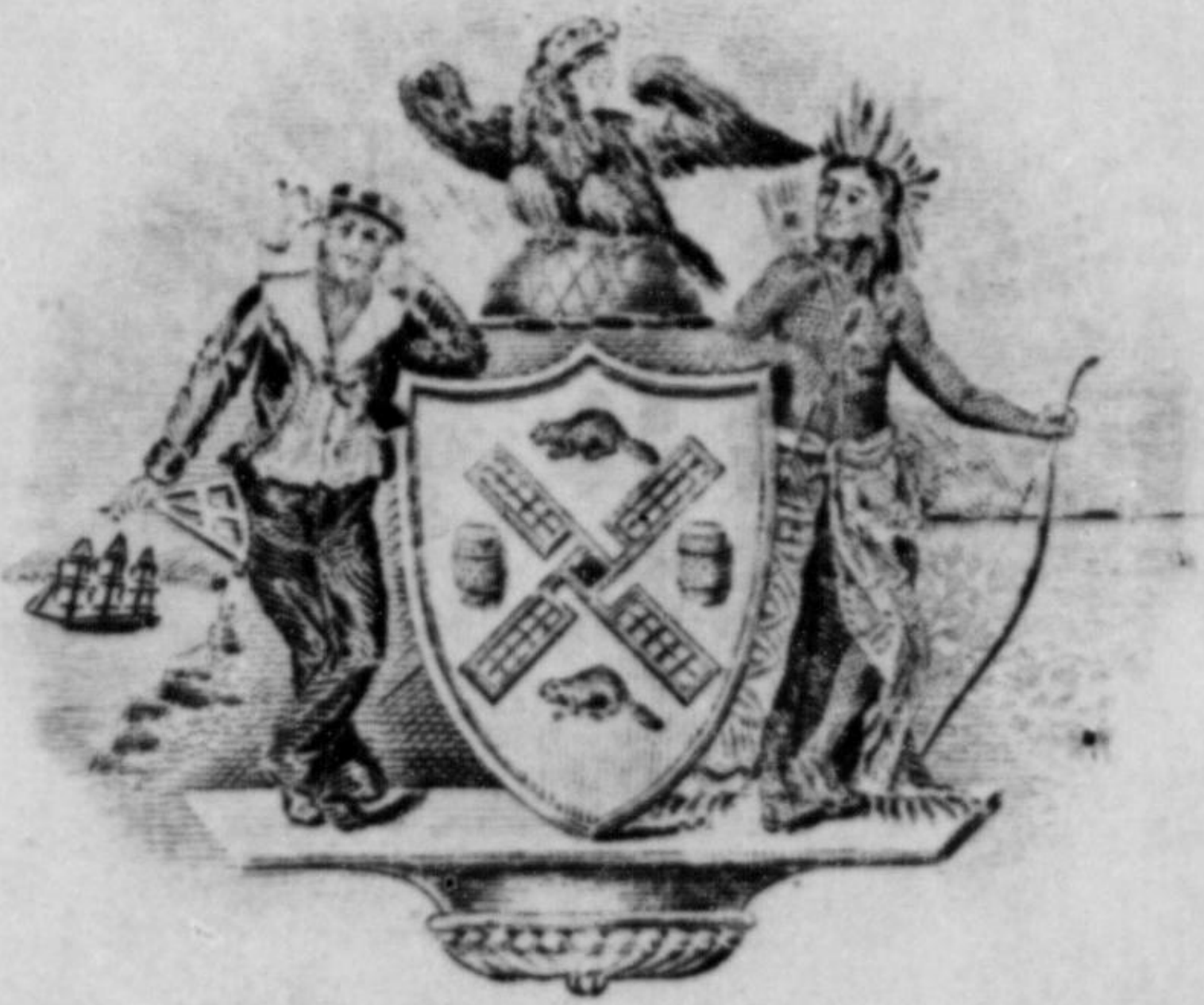

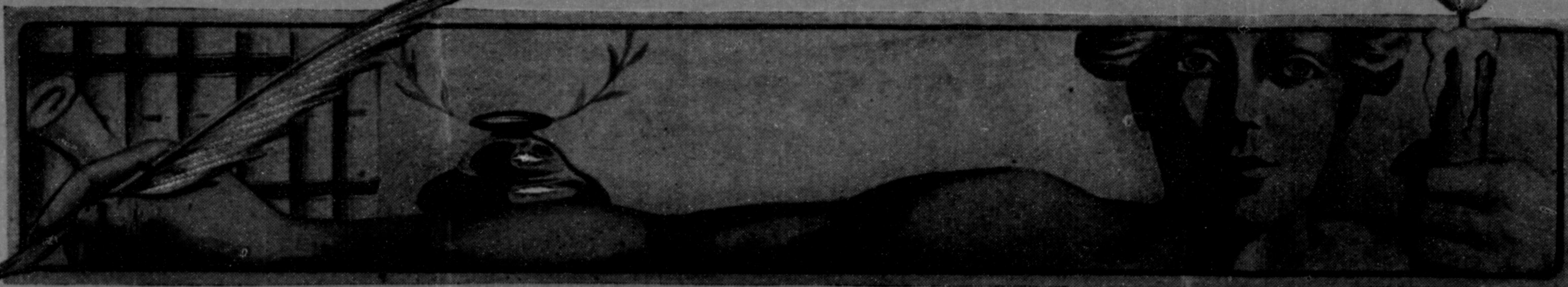

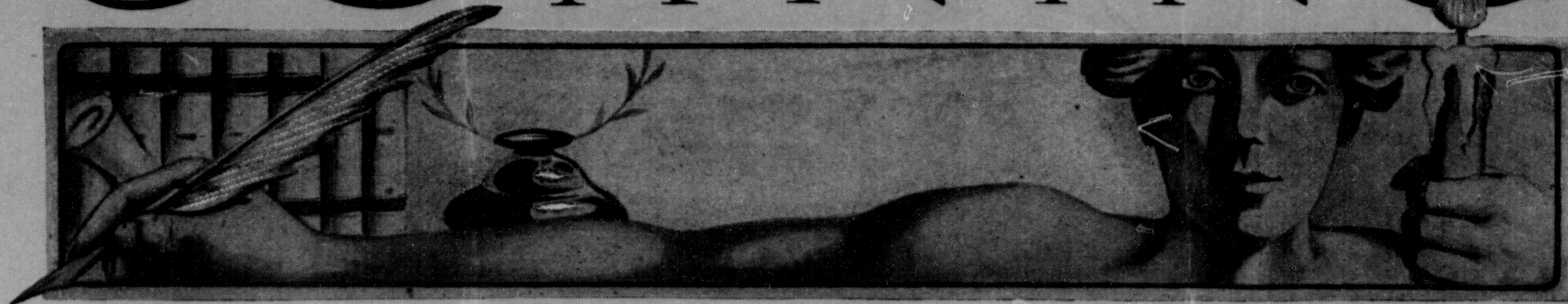
