Men are elected to the State Legislature to look after the interests of their constituents in certain localities, but many have lost sight entirely of this fact in their desire of subservience to party, and especially to the Republican party.

The indirect taxes that are being heaped upon the five large cities of this State are beyond all reason of justice, and Republican representatives should be made to understand and feel, at home, their disgraceful acts and their betrayal of confidence to their respective electors.

The voters of all political parties will do well, in these five cities, not to elect any man to either branch of the State Legislature who does not *openly pledge* himself to act, at all times, for *Home Rule* as to direct taxation, personal liberty, ballot reform and municipal ownership of public utilities, while the five cities of Albany, Buffalo, New York, Rochester and Syracuse, acting as a unit, can control both the Senate and Assembly, and therefore the Legislature of the State of New York.

MORTGAGE TAX.

It is now proposed to impose an indirect tax of one-half of 1 per cent. upon all new mortgages. Last year about \$600,000,000 in mortgages were recorded in this State, of which the City of New York contributed about \$450,000,000.

This proposed tax would have exacted \$2,250,000 from mortgages in the City of New York and only \$750,000 from those of all the rest of the State.

STOCK TRANSFER TAX.

It is also proposed to impose an indirect tax of \$2.00 upon each transfer of 100 shares of stock, and the City of New York will be required to pay the entire estimated \$5,000,000 to be raised from this Indirect Tax.

The whole Republican system of indirect taxation is wrong, unfair, unjust and un-American.

The people alone can stop it at the election this fall, and don't make any mistake, but that there are other indirect taxes coming under the already pledged policy of the Republican party.
