

**MEMORANDUM FOR THE MAYOR:**

From David Ferguson, Supervisor of the City Record, answering your letter submitting Dock Commissioner Tomkin's request to have the full minutes of his department printed in the City Record. To do this Mr. Ferguson says would be to open the way for renewal of the abuses in the City Record which have been put an end to during your administration. He points out that only by a most strange interpretation of the Charter could the publication of the minutes of the Dock Department giving the details of all their transactions, be warranted. He says further that prior to your administration many of the departments used the City Record to keep their records and to save typewriting. This was done away with soon after your administration started, resulting in a great saving to the city and without injury to the departments. He points out that the Health Department proceedings were formerly printed in the City Record in the most minute detail, saving the clerks and the bookkeepers a great deal of labor, but costing the city a great deal for printing. The same was done in the Fire Department. This was all stopped, as it was in the Dock Department. Commissioner Tomkins seems to be the only Commissioner to continue to insist upon the publication of all of his proceedings in the City Record.

S i r :

I beg to acknowledge your communication of the 27th instant, with letter dated January 23d, from the Commissioner of Docks and Ferries relative to the printing of the minutes of that department in the City Record.

I respectfully advise you that there is no provision in the Charter which would permit of the publication in the City Record of the kind of matter the Dock Department formerly had published, unless a far-fetched interpretation were given to Section 1546, which reads as follows:

"In every department, office of a borough president or board there shall be kept a record of all its transactions, which shall be accessible to the public, and once a week a brief abstract, omitting formal language shall be made of all transactions, and of all contracts awarded and entered into for work and material of every description, which abstracts shall contain the name or names and residences by street and number, of the party or parties to the contract, and their sureties, if any. A copy of such abstract shall be promptly transmitted to the person designated to prepare the City Record, and shall be published therein. Notice of all appointments and removals from office, and all changes of salaries, shall in like manner, within one week after they are made, be transmitted to and published in the City Record."

This section was very greatly abused in the past. The fact that it specifically provides for "a brief abstract omitting formal language" was ignored and all manner of trivial matter was published in the City Record by several of the departments. For instance, under the old system some of the clerks in the Health Department who had charge of the preparation of

of the matter to be published in the City Record practically used the City Record to keep some of the books. The matter printed in the City Record was simply cut out and pasted in books which should have been kept with pen and ink. Dr. Lederle stopped that early in your administration. The same abuse of the City Record was made by the Fire Department, but it was promptly stopped by the Hon. Rhinelanders Waldo, when he was Commissioner of that department. Many of the departments used the City Record to cut down the work of its typewriting force, although the cost of setting the type and printing the matter in the Record was eight or ten times the cost of hiring typewriters.

In citing these instances of the mis-use of the City Record, I do not mean to imply that the present Dock Commissioner has any such purpose in view, but I merely wish to make clear the danger of putting a wide-open interpretation on Section 1546 because of the careless wording of that provision of the Charter. It provides that once a week a brief abstract omitting formal language shall be made of all transactions. "All transactions" could be taken to mean anything and everything, such, for instance, as recording the receipt of every letter and the answer to every letter. I do not think the framers of the Charter meant that all such trivial and detailed departmental matters of that kind should be abstracted and published in the City Record. For instance, if every department of the city government should send to the City Record for publication each week the briefest kind of an abstract of all the letters received, and also the briefest possible abstract of the action taken on all of those letters, it would treble or quadruple the cost of publishing the City Record. If that were done in the Mayor's office, for instance, a special corps of clerks would be kept busy and several pages of the City Record filled every day. Then, if each department wanted that printed matter printed again in pamphlet form and at

the end of the year have those pamphlets bound in expensive bindings, the cost would be enormous. If all that were done I do not see how the public would gain anything or the efficiency of any of the departments be increased.

The fact that the Dock Department has been better managed, since Mr. Tomkins became Commissioner, than ever before in its history, a fact which I think any citizen will admit, seems to me of itself to prove that the printing of all of these detailed doings of the department in the City Record and in pamphlet form is not a matter vital to the successful administration of the Dock Department.

I am sending you herewith sections of two copies of the City Record of January, 1910, which contain the kind of matter formerly published by the Department of Docks and Ferries. The sections of the City Record transmitted are from the issues of Tuesday, January 18, 1910, and of Wednesday, January 19, 1910. The Dock Department matter in the issue of January 18 begins on page 663 and ends on page 667 and in the issue of January 19, 1910, it begins on page 695 and ends on page 701. An examination of this printed matter shows that it gives details of each day's doings in the Dock Department, even down to the receipt of many letters and the action taken on those communications.

If Section 1546 were interpreted so as to permit of the publication of matters of that sort it will establish a precedent that will cost the city an immense sum of money annually. My understanding of it is that the function of the City Record is to give publicity to municipal matters of public interest, many of which are specifically detailed in the Charter, and that it was never intended to be a book-keeping annex for the recording of the minute details of the departments. In these days of perfected card index systems, filing devices and high efficiency of office management, I cannot see why any department should be dependent upon the City Record for the accurate and convenient recording of department-



For these reasons I respectfully recommend that the request of the Commissioner of Docks and Ferries be not granted.

S i r :

I beg to acknowledge your communication of the 11th instant, suggesting that it will be in the interest of economy to amend the law requiring the publication of the Annual Report of the Public Administrator of New York County.

Pursuant to the provisions of section 27, Chapter 230 of the Laws of 1898, this very voluminous annual statement of the Public Administrator of New York County is published ten times in the City Record, once as part of the minutes of the Board of Aldermen and nine times, as per the provision that it be published three times each week, for three weeks in the City Record. Brief notices referring to such publications are also published for a like period and time in three daily newspapers designated by the Board of City Record. All these publications are mandatory.

It is my belief that every reasonable purpose would be served if the law were amended to provide for one publication of the Annual Report in the City Record and one brief publication in three daily newspapers calling attention to the detailed statement in the City Record.

In the matter of your communication of February 18, relative to the advisability of holding an efficiency exhibit during the present year, I respectfully advise you that this office could make such an exhibit, largely with the aid of charts.

Briefly such an exhibit would show:

It will probably take a month or six weeks to prepare such an exhibit. The cost of preparation would be probably about \$200. The approximate amount of floor space required will be 20 x 30 feet, or about 600 square feet.

Dear Sir:

In the matter of your communication of the 24th inst., asking for copies of the annual reports for 1912 of eighteen boards, courts, institutions, etc., I beg to advise you that up to the present time none of the 1912 reports of the boards, etc., on your list have as yet been printed, and only two of them have been received at this office. The Court of Special Sessions submitted its report on February 21, through the Mayor's office, and it is being held here pending the receipt of a requisition for the printing of it in pamphlet form. The report of the Board of Parole was received through the Mayor's office on February 26, and I am informed that it will not be printed until the annual report of the Department of Correction is ready for printing. It will then be made a part of that report. The Bronx Parkway Commission is a State board and this office does not print its reports. This office has never printed the reports of the New York Public Library, the Metropolitan Museum of Art, the Brooklyn Public Library, and several other of the institutions you name.

The making of annual reports is not mandatory except in the case of a few city departments such as the Finance, Tenement House, Docks & Ferries, etc. The Mayor, however, has under the charter the power to call for reports from any of the city departments. I think the quickest way to get the information you desire would be to request the heads of the various institutions and boards on your list to forward the data required. If it will be of any service, I will be glad to send you the reports of the Board of Parole and the Court of Special Sessions which are now in this office.
