

I just received a copy of your bill introduced on the 8th instant, No. 713, entitled:

"An Act amending section seventeen of the final maps, plans and profiles of the twenty-third and twenty-fourth wards of the city of New York, in relation to the grades of the Kingsbridge and Fordham Roads."

I would suggest that the words "and ten inches" in the ninth line of page 1, be stricken out, and that the words "commissioner and" be inserted after the word "Said" in the twelfth line of the second page. I would also suggest the following as an addition to Section 1.

"No change or alteration shall however be made of the map of section seventeen as now filed unless at the request or with the consent in writing of at least two-thirds of the owners of the property fronting on that part of the said Kingsbridge road where the said change of grade may occur."

I feel confident that if you had understood the actual effect of the bill as it now stands you would not have introduced it in its present form. The grades it provides for from Webster avenue would make a grade at the north cut intersection of Fordham road with Kingsbridge road, 113 feet above high water, or 10.5 feet above the grade shown on section 17 of the final maps and 7.5 feet above the grade proposed by this Department last year, and upon which a hearing was had. Such a change as your bill provides for, would damage all the property fronting on the east side of Kingsbridge road between Marion avenue and a point a short distance north of Cole's Lane. This will add to the cost of improvement considerably and which cost must be borne by the property owners.
