I beg to submit the following statement in connection with the request of the Mayor of the City of Tokyo to be furnished with the publications relating to the laws and regulations, schedules and working-sheets in connection with the periodical census or investigations of occupations carried on in this city.

The city makes no comprehensive census of occupations for the entire population. The census board gathers statistics of employments of persons between 14 and 18 years of age. I enclose copy of the statistics compiled by the census board in this connection, also copy of an article describing the work of this board, together with samples of the schedules used for that purpose.

The State Department of Labor makes an annual inspection of all the factories in the state and publishes detailed statistics concerning these investigations which in effect are a factory census. The Department of Labor believes that these statistics are comprehensive. That department also publishes similar statistics in

regard to mercantile concerns but these statistics cover only the larger establishments. The working sheets and schedules used by the factory inspectors, I have not thus far been able to obtain. However, I think the statistical reports sufficiently indicate the nature of the schedules.

There is also submitted a special report on industrial training--the result of investigations made by Professor Richards of Cooper Union for the State Labor Department, of various groups of industries. This report goes into great detail and is self-explanatory in every respect. It includes the working schedules and instructions issued for carrying on the work, and probably shows the character such an inquiry should assume in order to derive full information.

Finally, I am enclosing the latest bulletin of the federal census bureau with reference to manufactures in New York City--the bulletin on occupations has not yet been published. The federal census bureau, I am sure, will be very glad to receive a request from Your Honor to furnish the Mayor of the City of Tokyo with a copy of this bulletin when printed.

I have delayed in making reply, in order to collect these publications.

MEMORANDUM FOR THE MAYOR:

Mr. Ferguson, Supervisor of the City Record, has declined to furnish blanks to the Permanent Census Board to be filled out in the public schools, maintaining that since the information is to be supplied by clerks of the Board of Education, the Board of Education should furnish the blanks. Mr. Chatfield, the Secretary of the Permanent Census Board thinks Mr. Ferguson is wrong, and Dr. Maxwell endorses his contention. He says the information on these blanks is essential to the proper amendment of the census, and that if the reporting is not done by the schools the Census Board will have to send its own clerks to the schools and obtain the information.

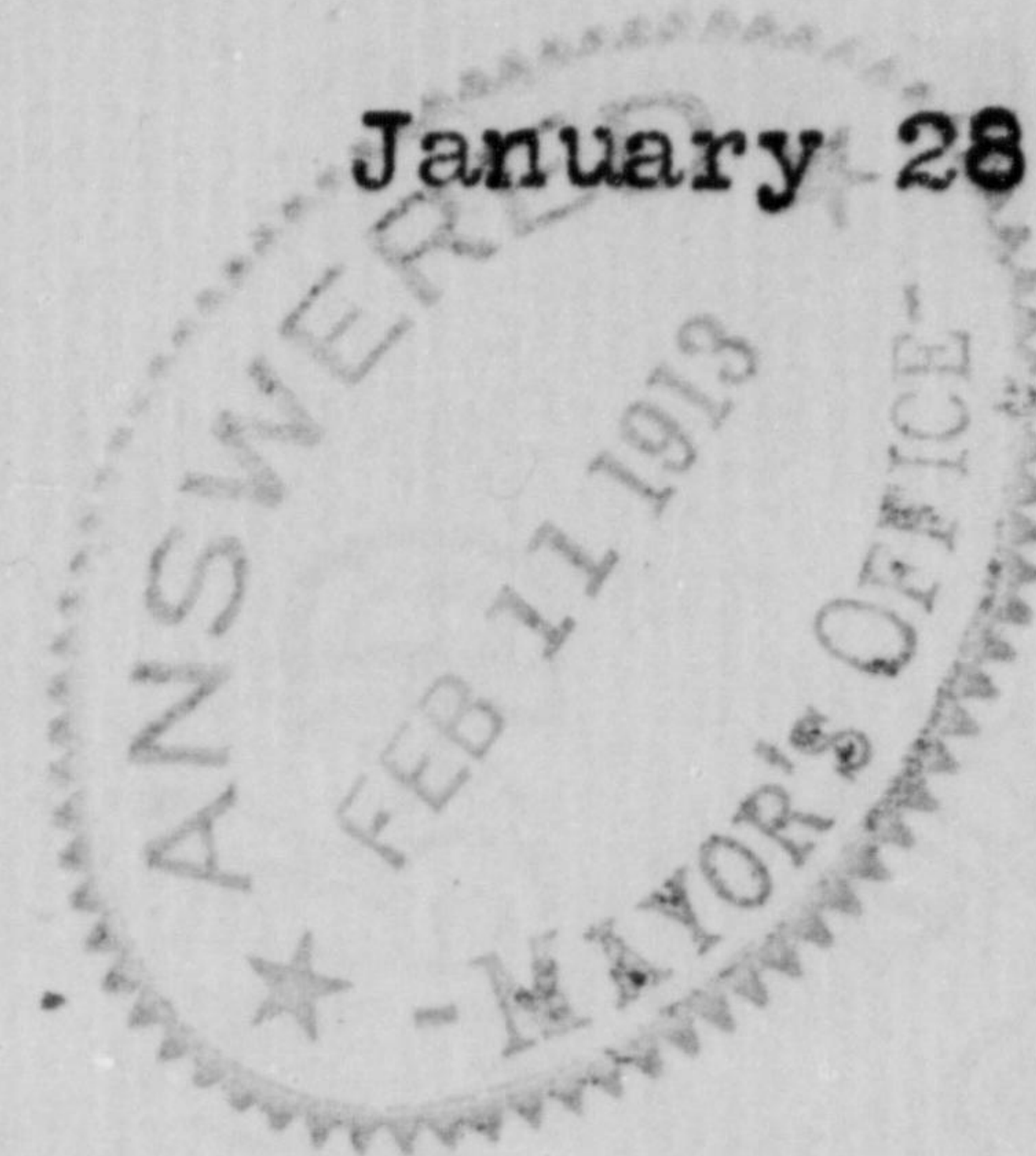

On January 8, 1913, Mr. Ferguson, Supervisor of the City Record, was asked to cancel seven items in the annual printing contract. The request also stated that a requisition for different forms as substitutes for the canceled items would shortly be made. The items withdrawn were blanks to be used by schools in reporting to this office the names and residences of pupils admitted or discharged. On January 17th, requisition for the new blanks was made upon the City Record. Mr. Ferguson declined to furnish any blanks which are to be filled out in the public schools, maintaining that because the information is to be supplied by clerks who are employees of the Board of Education, the Board of Education should furnish the blanks. He is willing to furnish blanks that are to be filled out in schools not under the control of the Board of Education.

I believe the contention of Mr. Ferguson is essentially unsound and therefore appeal to Your Honor for a review of this ruling.

The information furnished on these blanks is essential to the proper amendment of the census. It is a check upon the work of

the enumerators and enables us to reduce the number of cases reported for the action of the attendance officers. It is a material aid to the work of the enumerators, since in advance of the actual canvass, they are placed in possession of facts which it then becomes unnecessary to ascertain or verify. In an area where a recent canvass has not been made, the information contained in the reports on admissions and discharges enables us to approximate the changes which have taken place therein since the previous canvass. For these reasons, admissions and discharges have been reported from the schools of each borough since the initial canvass was completed. Such reporting is also an essential part of the plans for amending the census in Rochester and Buffalo.

If the reporting is not done by the schools, it will be necessary for this board to send its clerks to the schools to obtain the information. Last year, clerks were sent to a number of the public schools where the pressure of work made it difficult to forward the reports systematically. From this experience, it seems probable that 20 persons would be required to do all the work. Moreover, the City Record would then furnish without question the blanks to be used--the blanks which are now denied.

If the census board is to control the form and manner of reporting, it must furnish the blanks. Otherwise, it must accept the information in whatever form it may be submitted. If reports are not prepared in a uniform manner, they must be re-copied and in this case also, the blanks must be supplied by the City Record for the purpose, in order to refer these reports to the files economically.

Re-copying is an unnecessary waste of time and labor. It was tried when the schools forwarded lists of names on foolscap, and proved utterly impracticable.

In order to control its method of reporting, the Municipal Civil Service Commission supplies to all departments--including the Board of Education--blanks for declaration sheets, requests for transfer, quarterly and annual reports, and bound books for entering detailed records. The Department of Finance furnishes forms for open market orders, vouchers of every description, monthly balance sheets, inventory blanks, etc. The Board of Estimate and Apportionment supplies forms for various budget schedules for the annual budget estimate and no question is raised by the City Record as to the propriety of its action, although these blanks are filled out by employees of other departments, including those of the Board of Education. The City Record itself controls its business with other departments in the same way. Each of these instances is a clear recognition of the fact that whenever an expenditure for printing results in a decrease in the amount of clerical help required, the expenditure is justified.

The Board of Estimate and Apportionment has recognized the validity of the point at issue by furnishing postage to send the reports in question to this office from the schools. It is difficult to see why this board may supply the postage to send the blanks but may not furnish the blanks.

Mr. Ferguson insists that the blanks are used by the Board of Education because they are filled out by that board's employees--the school clerks. It is true that the work of the census board is primar-

ily for educational purposes, but the schools have made the reports in question solely to enable this office to carry out the provisions of the law. It has been a matter of no small difficulty to develop in the schools the feeling that such reporting is a reasonable demand upon their time and effort. The census board would probably be unable to compel the reporting to be done if the schools made a direct refusal. It is a fully warranted conclusion that if every blank filled out in the schools should be turned over to the Board of Education for its use, it would receive only a partial recompense for the work done for the census board by the schools.

The new plan will serve the schools as well as ourselves and will enable us to co-operate, instead of merely using the time of the school clerks for our own benefit. It will consume no material or blanks that are not required for the work of the census board. The Board of Education will furnish the blanks of direct use to itself. One copy of each report made to the census board will be retained in the schools in order that this office may check up missing reports with the least difficulty for this office and for the school concerned.

I beg to submit for your approval, the resolutions accompanying this letter. These resolutions provide for increasing the number of civilian enumerators from thirty-five to forty-five. In its budget estimate for 1913, this board requested that forty-five civilian enumerators be allowed. The Board of Estimate agreed as to the number, but provided that thirty-five should be civilians and ten patrolmen. The patrolmen have not been available and will not be, and are indeed not necessary. The work can be done equally well by civilians without fear of being molested. Such work as the statute requires of the police, can be performed from the precinct station-houses.

The resolutions provide, therefore, for utilizing the money appropriated for the salaries of the ten patrolmen to pay the salaries of ten civilians. A balance of five thousand dollars will remain.

The Permanent Census Board has been requested by the Board of Education, by the City Superintendent of Schools, and by other educational agencies to furnish information in connection with the development of vocational and industrial schools. It is desired to use the balance of \$5,000. to establish four positions for enumerators of higher grade, who will be employed in collecting such information, and to increase the compensation of the very efficient supervising enumerator from \$1500. to \$1800.



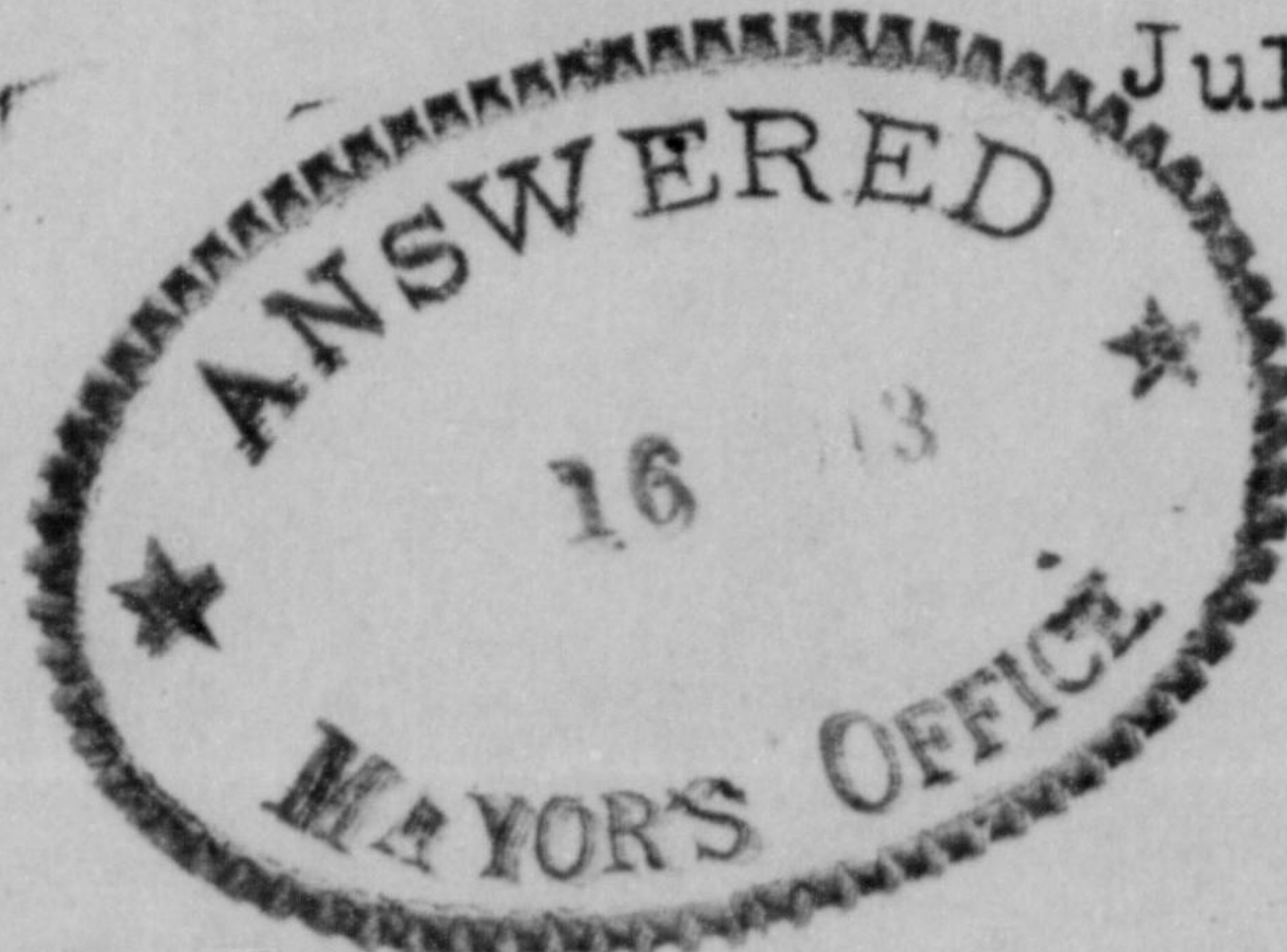

I submit herewith for your approval a number of resolutions. These resolutions provide, first, for the promotion of clerks in accordance with the schedules now before the Board of Estimate and Apportionment, and to fill vacancies caused by the transfer of several clerks to other departments--all these promotions being made in the order of standing on the eligible lists for promotion, or in order of seniority of appointment; second, for the appointment of first grade clerks to fill the vacancies caused by the promotions above mentioned, such appointments being made in the order of standing on the list certified by the Municipal Civil Service Commission, or in the cases of the temporary clerks, in conformity with the provisions of paragraphs 3 and 4 of rule 12 of the Civil Service Commission, where there is no list available; third, for increasing the salary of the supervising enumerator, James F. McManus, in accordance with the schedules pending before the Board of Estimate and Apportionment.
