off the bars and the breaking of the

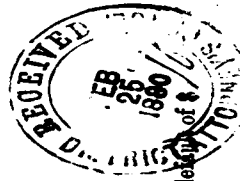

That

late of the *twentieth* Ward of the City of New York, in the County
of New York, aforesaid, on the *twenty third* day of *February*
in the year of our Lord one thousand eight hundred and ~~seventy~~ *eighty* with force
and arms, at the Ward, City and County aforesaid, the *store* of
Leopold Leucht the younger there situate, feloniously and
burglariously, did break into and enter, the same being a building in which divers
goods, merchandise, and valuable things were then and there kept for use, sale and
deposit, to wit: the goods, chattels, and personal property hereinafter described, with
intent the said goods, chattels, and personal property of the said *Leopold*
Leucht the younger then and there therein being, then and there
feloniously and burglariously to steal, take and carry away, and

*One hundred and fifty yards of carpet of the

of the goods, chattels, and personal property of the said

so kept as aforesaid in the said *store* then and there being, then
and there feloniously did steal, take and carry away, against the form of the Statute in
