Dear Sir:

The Mayor forwards to me your letter of March 12th, stating that you have been instructed by the Central Labor Union to appeal to his Honor to have a recent order of mine modified; this is the order forbidding employees entering saloons.

You say that the employees claim that in answer to a call of nature, there being no lavatories, they are compelled to enter these places.

The Mayor asks me to give this communication my consideration. I have to say that I am in entire sympathy with it and that I am ready to do anything in my power to relieve the situation. Where a claim is made and is properly substantiated that a visit to a saloon was made only for the purpose referred to, no action will be taken.

The condition of New York is in this respect a most barbarous one. I consider the duty of providing proper conveniences to be hardly less imperative than that of providing for the wants of the poor. Since my attention was first called to the bearing of this state of affairs, with regard to my order, I have been contemplating an appeal to the Good Government Clubs and to all others who are in a position to exert influence, to do all in their power to secure at least temporary relief, trusting that New York will in time become sufficiently civilized to demand that proper provision be made by its government.

Report in reference to seizing Incumbrances in 13th Street, east of First Avenue. Taking of truck by force from me. Resisting arrest. Reluctant assistance of Police Officer, together with final discharge of Prisoner, by Judge Thomas F. Grady of Essex Market Court March 19th, 1895.

In this case, I had ordered an Incumbrance truck, with a detail of two men, to meet me, Foreman Daily of Section #14, together with an Officer, corner of East 14th Street and Second Avenue at 10 A. M., March 19th, after which there being no vehicles in that vicinity to seize, I ordered truck and men to follow me around into East 13th Street, going East. This being out of the Police Officer's Precinct, we were obliged to proceed unguarded by an Officer, expecting to find another when needed, in the other Precinct (14th)

As we crossed First Avenue, I saw a push cart standing in front of #217 First Avenue, which we seized, and crossed over East, into 13th Street, and there in front of #402 stood two single wagons, which we seized and succeeded in securing them behind our Incumbrance Truck, and opposite East 404 and 406 stood two other vehicles. I ordered these to be seized also, which was done, but before we could get them turned around in order to fasten them behind the Incumbrance Truck, there came one George B. Marks, together with five or six stout blacksmiths, from 412 East 13th Street, and ordered them to take the large Truck, which stood off 406 East 13th Street into #412 East 13th Street. I told him not to touch it, and I, together with my men, attempted to hold the Truck and force Marks and his men away from it, at the same time telling him that I should arrest him for a misdemeanor, but he, with his men, overpowered me, with my light force, and they rolled said Truck into #412 East 13th Street. (In the mêlée, the single wagon that stood opposite #404 East 13th Street was spirited away.) Before seizing the above mentioned truck, I stepped into #406 East 13th Street and inquired who that Truck belonged to. They told me they did not know, but that it had stood there three or four days, and that they wished it would be taken away.

In the meantime I had sent for an Officer. When he came, which was after we had the fracas with George B. Marks, and whom I pointed out to the Officer, and demanded his immediate arrest. Marks claiming and demanding to see a warrant for his arrest. He was then standing in doorway of #412 East 13th Street. I insisted upon the Officer arresting him, that I would go with him and make the complaint of interfering with me as a City Officer in the discharge of my duty. Still the Officer did nothing, and this man George B. Marks began to move in the building between said Truck and Office, when I seized him by the coat collar, and demanded the assistance of the Police Officer, who stood by my side. (His number was 37 from the 14th Precinct), but he did not put his hands on Marks, nor assist me in any way to prevent Marks from getting away from me, as he was attempting to do, but I clung to him, he abusing me all the time, with his foul epithets and threatening to strike me, in fact, I did receive a scratch under the right eye, and finally succeeded in getting in the rear of Marks, and ordered him to walk out of the building ahead of me, although the officer had demanded of me before that I let go of Marks, also, demanded that I go out of the building first and that then Marks would follow, but I told him "never", fearing that Marks might disappear from rear of building. Just then a gentleman came in, and handed me his card, saying that he saw how I was situated and interfered with in attempting to do my duty, and that if I needed any evidence to call on him. (It was John N. Bogert, 104 Elm St. scales of weights and measures) After this Marks concluded to go out peaceably, and to the Police Station with Officer, where I made complaint against him, and as it was yet time for Court, we proceeded to Essex Market Court, where we appeared before Judge Thomas F. Grady, who after reading the complaint demanded of me to know where I got my authority from. Whereupon I informed him that it was from the Law governing the Street Cleaning Department, and showed him a small pamphlet of the Law, which after reading, remarked "Oh! that is preposterous. Do you pretend to say that if there is a wagon standing along the Street anywhere that you have the right to come along and gobble it up? Absurd!! No cause of action. I discharge the Prisoner. You Street Cleaning



folks better clean the mud out of the Streets first before you begin to gather up the wagons." To which I replied, "Well, Judge, how do you decide, have I not the right to take that Truck?" "No, No" (he said) "You have no right to touch it."

Now I find, upon examination, that the Law is very plain, and positive on the matter of Incumbrances, to be found in Sect. 1,936 of Chapter 368, Laws of 1894, Page 785, also Chapter 697 Laws of 1894, which allows no vehicles to stand in the Streets anywhere in the City, from 8 A. M. until 4 P. M., except feeding hours, from 11.30 A. M. until 1 P. M. without a horse to it, or on Sundays and Legal Holidays, and from 4 P. M. until 8 A. M. only by a permit from the Street Cleaning Department, which makes it a misdemeanor for any one violating this Law, owner or pretended owner, with fine attached, so that this man committed really the double offence of allowing his vehicle to stand in street and resistance of an arrest by a City Officer. As this same Law gives to the Superintendent, District Superintendents, foremen and Dump Inspectors the power of arrest, and then not to be supported by either the Police Officers or Judge of the Courts places us in a very awkward position, humiliating and shorn of all power.

(George B. Marks is 40 years old, Wagon Manufacturer, at 412 East 13th Street, and resides 340 East 14th Street.)

Dear Sir:

I beg to acknowledge the receipt of your letter of March 12th relating to a communication from Mr. A. W. Stewart, 33 Rose St., which is herewith returned.

I beg to say that this Department has no power to afford any relief in this matter. Such bridges are authorized by the Bureau of Permits. They are "constructed under the supervision and subject to the direction of the Department of Public Works", and it is made the duty of the person to whom the privilege is granted to clean the gutters thoroughly under such bridges on every Wednesday between sunrise and nine A.M. The Mayor may, for any violation of this ordinance, or on the complaint of any citizen, or for any cause that he may deem sufficient, revoke any such permit so granted, or the like privilege now enjoyed without permit.

I think that the ordinance concerning iron bridges over gutters, recently passed by the Board of Aldermen, is an important move in the direction of improvement, and I should be very glad to have my Department charged with the cleaning of the gutters under





such bridges, as that ordinance contemplates,,but not the existing wooden ones, many of which can, with difficulty, be removed.

The ordinance, from which the above quotations are taken, is from the Revised Ordinances, revised by Shepard & Shafer, in force January 1st, 1881, page 262, Article XLIII.

I write to tell you that the district covered by the Federation is daily showing the influence of your energetic efforts to keep the East Side clean. The improvement since the beginning of the month has been very marked. We are keeping a lookout for defects and shall not hesitate to send them in, but in the meantime I want to tell you how pleased we are with the great improvement everywhere apparent. I have spoken to many of our church members about the necessity of destroying paper and rubbish, and shall speak of it in the public schools whenever I visit them. It will take some time to educate the people, and I am glad your standard is one towards which we can work up.

Do not relax your vigilance in regard to trucks. It is impossible to put in writing, much less to speak at your conference of the pernicious uses to which they are put. A man that can afford to own a truck can also afford to hire it housed.

You will be interested to know that we are going to make strenuous efforts to have two or three lavatories placed over here.

In reference to the complaint of Frank A. Stumm, Esq., the greater portion of Broadway between 14th and 23rd Sts., is swept by private sweepers. That street sprinkling is controlled by the Department of Public Works, and is prohibited between November 25th and March 25th.

In reference to the complaint of William Murray, Esq., 311 Water St., the streets referred to have since been cleaned.

In reference to the complaint of S. M. Acker, Esq., 316 W. 104th St., the street in question is now in good condition.

In reference to the complaint of George G. Trask, Esq., 140 W. 46th St., there are several livery stables on the block and unharnessed carriages sometimes stood in front of them. The stable men were cautioned. A large building was also being erected in consequence of which there was building material in the street. The block in other respects is kept in as good condition as possible.

In reference to the complaint of Mrs. Piser, 762 Union Ave., the ashes complained of were kept in the cellar where the driver could not see them.

Gentlemen:

I have received from the Mayor, with instructions to reply directly to you, your letter to him of March 28th concerning the removal of the refuse of your establishment, and asking "why it is under a Reform Administration of the City Government and with a Street Commissioner who boasts of rendering better service to the citizens of this city than his predecessor, that we cannot get our refuse taken away by the wagons of the street cleaning department as they have always been done heretofore."

In the first place, I have never made a boast or intimated that I am rendering better service than my predecessor. In the next place, as this is a "Reform Administration", it seems worth while to obey the laws.

Under the law I am confined to the removal of ashes, garbage and street sweepings. The amiable habit which has grown up during years past, of taking all manner of rubbish, including the waste products of profitable industries, cannot be continued.

Your letter to Mayor Strong has been referred to me, and I will say that your proposition would not be of use to us, for the following reasons:

The system advised by us is to establish housed compartments at each of the dumping stations and store the garbage, which will be discharged into self-propelling boats for transportation.

Your system of lighters would require a boat constantly at each station; the above method would allow of one boat collecting from several stations.

The present intention is not to dump at sea but to furnish the garbage to crematories, or reduction works, to be disposed of in a sanitary manner.

Your wagon proposition is by no means new as it has been tried at several points, notably New Orleans, and was abandoned as expensive and unsatisfactory.

It is the present intention of this Department to separate the ashes and garbage, and this being done, the ashes are valuable



filling material and can readily be disposed of.

The fact that the City has no right to deprive the people of the privilege of stabling trucks in the streets and at the same time stabling its own vehicles in the streets, is fully recognized by this Department and is clearly set forth in applications made some time ago to the Board of Sinking Fund Commissioners for authority to hire lots for the purpose of receiving the carts in connection with the stables in 12th street, in 52nd street and in 80th street. Gentlemen:

The Mayor has sent me your communication of April 15th, saying that at three o'clock on Sunday one truck and two carts were "stole" from in front of your premises. You believe that these are "exempt from Colonel Waring's brigade that take those wagons. It is an utter impossibility to stow these carts and trucks, as there is no facility for the same in this district. Some immediate action should be taken against this outrage."

I hardly think that when one performs the disagreeable duty of executing a law which he has sworn to execute, and which involves the removal of trespassing property from the public thoroughfares, it is exactly fair to accuse him of theft.

I have heard a good deal about the impossibility of stowing away carts and trucks in certain districts. I do not believe it, and daily observation of hundreds of additional trucks being withdrawn from the streets, satisfies me that any man who is not permitted by negligent and unfaithful public officers to use the streets for a truck yard, or for a workshop, without paying fines

amounting to more than the rent of suitable premises, will lose very little time in adopting the cheaper method.

I know perfectly well the inconvenience caused to you and to others from being suddenly deprived of a privilege of public encroachment which you have come to regard as a natural right. If this were all of it, I would make an effort to have the law modified, but this is by no means all of it. If you saw the hundreds of complaints that come from the people, and especially from women and from mothers, and from all who see what an insufferable nuisance this street storage of trucks is, you would do what many others in your condition are doing, and find some way to transact your private business on private ground.
