

MONTHLY REPORT OF THE SECRETARY

and

EXTRACTS FROM THE MINUTES OF THE NEW YORK CIVIL SERVICE

SUPERVISORY & EXAMINING BOARDS.

NEW YORK, OCTOBER, 1896.

MEETING OF THE COMMISSIONERS, HELD OCTOBER 12, 1896.

The Secretary reported that the Mayor had enjoined the Park Department from making appointment of Roundsmen on the certification of this Commission of June 25, 1896, he having received a communication in the form of an affidavit from John D. O'Brien, claiming that his name had been prejudiced in favor of O'Connor, and had referred the matter of the certification to this Board for re-consideration.

The Secretary informed the Board that O'Connor's name had been placed above that of O'Brien, not because of his long term of service in the Department, but in that O'Connor had a higher rating on his mental examination than O'Brien, and that raising his rating on the physical examination to 70% in no way prejudiced O'Brien's position, as the facts in the case are, that taking into consideration O'Connor's first rating on his physical and combining that with the mental his general average was greater than that of O'Brien. Further, that the raising of O'Connor's rating on his physical (to 70%) was due to the fact that the four candidates who had passed in the mental and failed in the physical, and that the Board had referred their appeal to the Chief Examiner, the Physical Examiner and the Secretary, and that it was their opinion, as well as the opinion of the Departments, that a special strength test was not required in examinations for promotions, and, therefore, the four persons who had failed in the physical examination were allowed the minimum percentage to pass (70) in that they were physically qualified to perform the duties of Roundsmen.

It was the opinion of the Board that they saw no reason for rescinding their previous certification to the Park Department of Roundsmen, as they considered their previous action wholly justifiable.

The Secretary was instructed to inform the Mayor that

although a quorum was not present, it was the opinion of the Commissioners that they saw no reason for rescinding their previous action, and the matter was laid over for further consideration at a full Board meeting.

The Secretary stated that, at a meeting held October 6, the Examining Board had requested this Board to adopt the following resolution:

RESOLVED: That the second paragraph of Regulation 14 be amended to read as follows:

"The Examining Board shall have power to employ experts to assist in examinations, whether in a special case or in connection with the examinations for any special grade, position or office. The employment of such experts shall be reported to the Supervisory Board at the meeting next following such appointment."

On motion, duly seconded and carried, it was:

RESOLVED: That this Board recommend to the Mayor that Regulation 14, second paragraph be amended to read as follows:

"The Examining Board shall have power to employ experts to assist in examinations. The employment of such experts shall be reported to the Supervisory Board at the meeting next following such appointment, for their approval."

The Secretary submitted a communication from the Civil Service Reform Association, dated October 10, with reference to certain non-competitive examinations granted by this Board.

The letter of the Civil Service Reform Association was referred to Commissioner Watson.

The Secretary read a requisition from the Finance Dept., dated October 9, requesting certification for Messenger in the Bureau for the Collection of Assessments and Arrears of Taxes, etc., and stated that the Chief Examiner recommended that certification be made from the eligible list for Messenger in the Public Administrator's Office. The Secretary was instructed to make certification from such list.

A letter dated October 5 was read from the New York Civil Service Commission, acknowledging receipt of proposed amendment to Regulation 17.

A communication from the Labor Clerk, dated Oct. 6, was read, recommending abolition of positions of Laundress, Waitress, Police Tailor and Sweeper.

RESOLVED: That the positions of Laundress and Waitress, now classified in Schedule G, be abolished.

RESOLVED: That the title of the position Police Tailor be altered to read "Tailor."

RESOLVED: That the position of Sweeper be abolished, and that those on the present list of Sweeper be given the physical examination accorded Laborers, and if found qualified, be entered on Laborer's list, according to date of application.

The Secretary read a communication from Supt. Parsons, dated September 9.

The Secretary read a communication from the Department of Public Parks, dated October 5, with reference to John S. Bacon, Carlton A. Clark, James J. Gaw and David M. Callender, whose pay rolls were held by order of the Board.

The Secretary was instructed not to approve the pay rolls of Bacon, Clark or Gaw, and to ascertain if David M. Callender was properly employed.

A letter was read from the Fire Department, dated Oct. 9, recalling requisition for Inspector of Clocks.

RESOLVED: That this Board recommend to the Mayor that the position of Inspector of Clocks in the Fire Department be abolished.

The Secretary stated that he found a great number of Laborers in the Dock Dept. were receiving 23¢ per hour, while a Laborer's regular compensation was 16¢ an hour, and that this might indicate that the men in question were assigned to other duties.

The Secretary was directed to investigate the matter.

The Secretary called the attention of the Board to the fact that, at the request of the Department of Public Works, a special examination had been held for Patrolman on Aqueduct, and a large eligible list secured, but that no appointments had been made therefrom.

A letter, dated Oct. 8, was read from the Dept. of Public Works, requesting permission to transfer Bath Attendant Joseph F. McCarthy to the position of Patrolman on Streets and Roads. The request of the Department of Public Works was granted.

MEETING OF THE COMMISSIONERS, HELD OCTOBER 15, 1896.

A letter from the Secretary was read, presenting for consideration the proposed questions relative to revising the running system of the office in order that the same shall be more efficient and economical. The questions submitted were as follows:

First: That it should be within the discretion of the Supervisory Board to extend the period limit of an eligible list in such cases where it is deemed expedient.

Second: Merging the eligible lists as far as possible by raising the required percentage to pass, especially in cases where there are large numbers of applications filed.

Third: The advisability of holding examinations not more than once or twice a year for such positions for which there are a number of applications on file.

Fourth: The advisability of employing examiners upon a salary instead of per session.

Physical Examiner Brown also, recommended that in the examination for promotion of Fireman and Park Policemen the custom of requiring a physical test be abolished.

The question of extending the period limit of eligible lists was brought up and discussed. Upon motion of the Chairman, it was

RESOLVED: That this Board recommend to the Mayor that the Regulations be so amended so that it shall be left within the discretion of the Supervisory Board to extend the limitation of an eligible list in such cases where it is deemed expedient.

Further, that this amendment as adopted shall apply to existing eligible lists as well as future lists.

The question of raising the minimum percentage in the physical examination for appointment to the uniformed force of the Fire and Park Departments was then discussed. Dr. Brown stated that, in his opinion, it would be advisable to raise the minimum percentage required, thereby obtaining a better class of men for service, and recommended that the minimum be raised.

FURTHER: he also strongly recommended that the physical test for promotion in the aforesaid positions be abolished, as he considered that a thorough medical examination was all that was required. That he had conferred with Commr. Sheffield concerning both of his recommendations, and that Commr. Sheffield's opinion agreed with his.

Chairman Wheeler suggested that the question of abolishing the physical test in promotions be deferred until Dr. Brown had conferred with the other Commissioners and made further investigation into the same.

The Secretary presented the records of examinations for Firemen and Park Policemen, showing that in the physical examination for Firemen 9 out of 72 obtained above 80%; 34 out of 72 above 75%; 21 appointments made; and in the case of Park Policemen 9 out of 94 obtained above 80%, and 40 out of 94 obtained above 75%, with no appointments.

Further, that it was only in exceptional cases where persons who had obtained less than 80% in the general average received appointment to the uniformed force of the Fire or Park Departments. Upon motion, it was

RESOLVED: That this Board recommend to the Mayor an amendment to the Regulations so that the minimum required on the physical examinations for appointment to the positions of Firemen and Park Policemen be fixed at 75%

FURTHER: The minimum on the general average be fixed at 80%.

The question of raising the minimum to pass in the examinations for general Clerks was then discussed. The Secretary presented the records of the Clerks' examination, showing that 29 out of 105 had obtained above 90%, 6 appointments made, all of which were veterans. After due consideration, it was

RESOLVED: That this Board recommend to the Mayor that

the Regulations be amended so as to require the minimum percentage for general Clerks (1st Grade) shall be fixed at 90%

FURTHER: This amendment, as adopted, is not to refer to any other grade or to Clerks who are examined on special subjects.

The Chief Examiner recommended that Regulation 9, 4th obligatory subject, should be amended so that it should be left to his discretion as to how severe an examination should be given in Arithmetic.

RESOLVED: That this Board recommend to the Mayor that Regulation 9, Subdivision 4, be amended by striking out that portion of the clause following the word "arithmetic."

The question of employing Examiners upon a salary was then discussed. The Secretary presented statistics showing the cost of Examiners who were paid for services while attending examinations, and also the cost of examining papers, etc. The Chief Examiner stated that he would recommend the employment of two female Examiners, whose duty would be to assist in conducting examinations and in examining and rating papers, and, when not occupied in this work, they should be assigned to do general clerical work. That he thought such services could be obtained for, say, \$600. per annum, and would recommend that the title given to the position be that of Assistant Examiner.

RESOLVED: That this Board recommend to the Mayor that Schedule F of the classification of positions in the New York Civil Service Commission be amended by adding thereto "Assistant Examiner."

Further, that this Board recommend to the Mayor the appointment of two Assistant Examiners (Female) salary not to exceed \$75. per month. Such Assistant Examiners to be assigned to such duties as the Chief Examiner may direct, with a view to diminishing the expenses of the office.

The Secretary stated that, in compliance with the direction of the Board, he had sent a communication to the Mayor concerning the case of the promotion to Roundsman in the Park Department, and had also called upon the Mayor and informed him in full as to the action taken by the Board.

Further, that the Mayor desired it to be stated that he thanked the Commissioners for their trouble in the matter, and that he would act in accordance with their communication. The Secretary read the communication to the Mayor, and, on motion, the same was approved.

MEETING OF THE COMMISSIONERS, HELD OCTOBER 19, 1896.

The letter of the Civil Service Reform Association was considered. On motion, it was

RESOLVED: That the Chairman be requested to draft a reply to the communication of the Civil Service Reform Assn., and submit same to the several members of the Supervisory Board, and that the proposed answer be acted upon at the next meeting.

The Secretary called the attention of the Board to the recommendation of the Examining Board of October 6, that the minimum percentage for Inspectors under Schedule D be raised to 80, and read communication from the Building Department of July 10, 1896, requesting that the required minimum percentage of Building Inspectors be raised, and that the positions of Inspector of Masonry and of Carpentry be classified.

RESOLVED: That the Regulations be so amended that in the ascertained average of Inspectors under Schedule D, the minimum required percentage shall be 80.

The Secretary was directed to invite Mr. Constable to appear before the Board relative to the question of classifying Inspectors of Masonry and Carpentry.

RESOLVED: That in filling requisitions a copy of that portion of Regulation 16 which requires that appointments be made within ten days after certification shall, in all cases, be endorsed upon the certification.

The Secretary reported that the Mayor had approved the recommendations of the Board abolishing the positions of Inspector of Clocks, Cellarman, Boardman, Digger, Inspector's Assistant, Patrolman, Trackman, Temporary Watchman, Laundress, Waitress, Sweeper, and altering title of Police Tailor to "Tailor."

A letter, dated Oct. 13, from the Department of Public Charities, was read, requesting the classification in the exempt schedule of the position of "General Inspector."

RESOLVED: That the Secretary be instructed to inform the Department of Public Charities that, in the opinion of this Board, fitness for the position of "General Inspector" can be determined by competitive examination, but that we shall be very glad to confer with them as to the scope of the examination, so as to make the subjects qualified to test the fitness of candidates.

The Secretary read a communication from the Building Department, dated October 19, in answer to a letter of this Board of October 17, stating that Francis M. Rutherford, Building Inspector, was acting as 2d Deputy Supt. at a salary of \$2,500. per annum.

RESOLVED: That the Secretary be instructed to inform the Supt. of Buildings that this detailing of Rutherford to act habitually in a superior position for which he has not been examined is in violation of the law and cannot be allowed; that an examination can be held for the position of 2nd Deputy Superintendent, in which all qualified inspectors will have the privilege of competing.

A letter from the Fire Dept., dated Oct. 7, was read, requesting that in examinations for admission to the uniformed force the required minimum percentage be raised.

Commissioner Watson offered the following resolution:
RESOLVED: That Regulation 24, last part of the last sentence be amended to read "or whose ascertained average "on all is below 80, shall be entered on the eligible list."
The Secretary called the attention of the Board to the fact that only 8 candidates out of 74 obtained above 80% on the physical.

At the suggestion of Commr. Watson, the above resolution was laid on the table, and the Secretary instructed to request Dr. Brown to confer with the Fire Department in the matter.

MEETING OF THE COMMISSIONERS, HELD OCTOBER 22, 1896.

The Secretary read a letter from Chairman Wheeler, enclosing proposed reply to the Civil Service Reform Assn., and was instructed to forward a copy of same to each Commissioner.

A communication, dated October 17, from the President of the Park Dept. was read, relative to the four Foremen whose pay rolls are held by this Board.

Under the circumstances stated in this letter, it was resolved,

First: That the Secretary be instructed not to pass the pay roll of James S. Bacon for the time he was illegally detailed.

Secondly: In the case of Carlton A. Clark: That the pay roll of Carlton A. Clark be passed, because the only pay roll in our hands certifies for services after the time during which Mr. Clark was illegally detailed.

Thirdly: That the Secretary be directed not to approve the pay roll of James J. Gaw, now held by order of this Board.

Fourthly: That the Secretary be instructed to pass the pay rolls of David M. Callender.

The matter of Attendants in the Department of Public Charities was then discussed, the Secretary reading a letter from the Chief Examiner, dated Oct. 19, on the subject; also reading a communication, dated Oct. 13, from Supt. Murphy, of Bellevue Hospital, relative to duties of Attendant.

In this connection a letter dated Oct. 14 was read from the Comptroller, directed to Presdt. Croft, of the Department of Public Charities, relative to the pay rolls of James Marsh, William J. Kinnaird, John A. Murphy and Philip Mertz, Attendants, which pay rolls are held by the Comptroller on the ground that said persons are illegally detailed to other duties. A letter, dated October 15, from Supt. Murphy, of Bellevue Hospital, in response to above was also read.

On motion, all action on the examination for Attendants held Oct. 16, 1895, was suspended, and the Chief Examiner instructed to hold no further examinations for that position

until informed by the Department of Public Charities what the duties of Attendants are. .

The matter of the pay rolls of Marsh, Kinnaird, Murphy and Mertz, mentioned above, was laid over until the next meeting.

MEETING OF THE COMMISSIONERS, HELD OCTOBER 26, 1896.

A letter, dated Oct. 26, from the Street Cleaning Dept. was read, stating that they needed for their new automatic dumper an engineer having at least three years' experience with a Robert's boiler.

On motion, the Secretary was instructed to hold a competitive examination as soon as possible for Engineer, with special questions as to Roberts boiler.

The Secretary reported that the Mayor had classified the position of Assistant Examiner.

The Secretary read a report from Dr. Brown relative to raising the required minimum percentage in the physical examination for admission to the uniformed force of the Fire and Park Departments to 80.

The Secretary submitted copies of law providing that sanitary police in Health Dept. shall be examined by this Board, and was instructed to notify the Police Department that under Chapter 567 of the Laws of 1895 this Board has the supervision of the examination of police sanitary inspectors, and to enclose copy of same.

The Secretary was instructed to invite Commissioner Waring to be present at the meeting of the Board on the 9th of November.

The matter of the pay rolls of Attendants Marsh, Kinnaird, Murphy and Mertz, held by the Finance Department pending decision of this Board, was then taken up.

RESOLVED: That the Comptroller be informed that, in the opinion of this Board these men are not entitled to compensation as Attendants, for the reason that they are not properly detailed.

The Secretary read communications from President Croft, of Department of Public Charities, dated Oct. 23, and Thomas F. Murphy, Superintendent of Bellevue Hospital, dated Oct. 13, relative to the duties of Attendant.

RESOLVED: That persons holding the position as defined in the letter of the Department of Public Charities of Oct. 23 be registered in the Labor Bureau, and the Department of Public Charities required to make requisition on the Labor Clerk for Ward Helper to fill such vacancies, and that the Department of Public Charities be requested hereafter to make a requisition for Ward Helper when they require any one for those duties.

Letter was read from Labor Clerk, dated Oct. 22, relative to Chapter 344 of the Laws of 1895.

It was the opinion of the Board that this only debarred veterans residing outside New York County from veterans' privileges, but that, as citizens and residents of this State they were eligible for examination.

A letter was read from the President of the Fire Dept., dated October 23, in response to communications of this Board dated June 27 and October 9, 1896, giving ratings on record of candidates for the position of Chief of Battalion. As this did not give the candidates' rating on the several qualifications, as requested by this Board, it was, on motion,

RESOLVED: That the Chief Examiner be instructed to formulate a series of questions which will determine the qualifications of candidates for promotion in the particulars mentioned in the resolution of this Board of June 24, 1896, and to request the Fire Department to append answers to said questions for each candidate entering an examination for promotion. The Board of Examiners is instructed to rate each candidate for efficiency, character and conduct, as shown by previous service, in accordance with the answers so obtained.

A letter, dated Oct. 26, was read from the President of the Department of Public Charities, in response to letter of this Commission of the 20th inst., giving the duties of the proposed position of General Inspector.

RESOLVED: That this Board recommend to the Mayor that the classification of positions in the Department of Public Charities be amended, by adding thereto, in Schedule D, the position of "General Inspector," and that an examination be held for same as soon as possible.

A letter, dated Oct. 22, was read from Stevenson Constable, Superintendent of Buildings, in reply to communication of this Board of the 19th instant, relative to the position of Second Deputy Superintendent.

RESOLVED: That an open competitive examination be held for the position of Second Deputy Superintendent, Building Department, in accordance with the Building Dept. Law, and that, in reply to Mr. Constable's letter, the Secretary be instructed to inform him that an open, competitive examination will be held, as he states in his communication that there are no persons in the Department eligible for promotion.

The Secretary submitted a requisition from the Department of Public Charities, dated Oct. 9, calling for "Medical Chief of Staff," and the Secretary was instructed to hold such an examination.

Commr. Watson stated that, in his opinion, it was advisable that an expert be engaged to prepare and rate the papers for this examination.

On motion, duly seconded and carried, Dr. William H. Thomson, of No. 7 West 56th St., was appointed Expert to prepare and rate the examination papers for "Medical Chief of Staff." Commission Watson was requested to see Dr. Thomson in the matter.

A communication, dated October 24, from E. P. Kilroe, M.D., at present on the eligible list for House Physician, was read, stating that Dr. Robertson, also on this list, had not had the required experience. The Commissioners agreed with the Chief Examiner that the Board must be its own judge as to rating on experience, or any other matter.

A letter was submitted from Superintendent Constable, dated October 22, relative to Inspectors of Carpentry and Masonry.

The matter was referred to Commr. Olcott.

Dear Sir:-

At a meeting of the New York City Civil Service Commission, held December 8, 1896, I was instructed to communicate with the several heads of City Departments, calling their attention to Regulation 36, concerning probation.

This Regulation provides that all appointments shall be provisional, and that the candidates shall not be considered as permanently appointed until they have served the probationary term of six months. And, further, when their services are dispensed with during the probationary period for cause prejudicial to themselves, they shall not be eligible for appointment in the municipal service in any Department for one year from the date of discharge. I desire particularly to bring to your notice this portion of said Regulation.

Cases have arisen where persons have been dismissed during the probationary term, and this Commission has not received notification of such dismissal, and the persons so dismissed have again filed application, and as there were no entries upon the records in the form of charges against said persons, we were unable to debar them from examination.

In some instances where they have obtained a position on the eligible list and have been certified to a Department, the Department has informed us that the person certified was dismissed at a previous date for some cause.

To obviate this difficulty we would, therefore, request that you give this matter your close attention, and that whenever a dismissal occurs you will duly notify this Commission of the same, giving the cause thereof, in order that we may have a complete record and be in a position to enforce Regulation 36, and thus greatly expedite matters and avoid unnecessary delay.
