Gentlemen:

I have examined the papers submitted by Mr. Wm. J. O'Brien, President of the Workingmen's Assembly, including the complaint against Mr. Flynn, contractor for the New York Pier foundation of the New East River Bridge, and the affidavits of Thomas J. Russell, John M. Smith, Angelo Tomasine and Patrick K. Coyle.

The complaint against the contractor is that he is paying the stone cutters employed by him at the quarry at Saugerties less than the prevailing rate of wages in that location. The complaint asks that the commissioners take prompt action either to compel the contractor to comply with the law in this respect or that they revoke his contract. The claim of Mr. O'Brien is that the contractor is violating Chapter 385 of the Laws of 1870, as amended by Chapter 622 of the laws of 1894. Chapter 385 of the Laws of 1870, as amended by Chapter 622 of the Laws of 1894, provides that all mechanics, workmen and laborers employed by the state or any municipal corporation therein through its agents or officers or in the employ of persons contracting with the state or such corporation, for the performance of public works shall receive not less than the prevailing rate of wages in the respective trades or callings in which such mechanics workingmen and laborers are employed in said locality. It further provides that every contract hereafter made by the state or any municipal corporation for the performance of public works must comply with the requirements of this section, the requirements of the section being that the rate of wages shall be not less than that prevailing in the respective trades or callings in the locality, and that none but citizens of the United States shall be employed by the state or any municipal corporation therein or by persons contracting with the state or municipal corporation.

The affidavits produced by Mr. O'Brien tend to show that the contractor is paying less than the prevailing rate of wages in the locality of the quarry ~~get~~ stone cutters.

X I am of opinion, however, that this contract with Mr. Flynn is not within the statute. The provision with regard to the rate of ~~w~~ wages is limited to machanics, workingmen and laborors employed by the state or any municipal corporation therein.

X The Commissioners of the New East River Bridge are, in my opinion, neither agents or officers of the state nor of any municipal corporation within the meaning of the act.

Assuming, however, that this is questionable, and that the contract with Mr. Flynn might be regarded as a contract coming within the purview of the statute, I do not think the case is one calling for any action on the part of the Commissioners. The act does not require the public officer or department whose contractor violates the law in this respect to vacate the contract. In many cases such action assuming that it could be taken under the statute might be, and in the present case it would be, highly detrimental to the public interest in delaying the construction of the bridge. The statute provides a penalty upon the contractor, in case he violates the law, of not ~~16~~ less than \$100. nor more than \$500. It is open to any person having knowledge of the violation of the law to make a criminal complaint against the contractor for the enforcement of the statute.

The contract with Mr. Flynn expressly provides that the contract or shall comply with all the laws of the state in the matter of wages and the class of labor to be employed. It reserves to the Commissioners the right to avoid the contract if the contractor violates any of the conditions or covenants of the contract.

The act further provides that any officer or officers or agents of this State or such (municipal) corporation who shall openly violate misfeasance in office and be liable to compensation or removal accordingly by the head or Governor of the department to which such officer is attached.

It is claimed by Mr. O'Brien, as I understand, that the Commissioners should take some affirmative action against the contractor to prevent further violation of the statute by him, but I know of no process or proceeding by which they can compel obedience to the statute on the part of the contractor, even if it were clear that his case is within the statute. If he violates the law he subjects himself to prosecution therefor, and this seems to be the appropriate remedy. And especially in view of the doubt that exists whether the case is one within the statute, it is my opinion that the Commissioners are not called upon to take any affirmative action in the matter-

To the Commissioners of the New East River Bridge.

Gentlemen:

During the two weeks ending August 3, 1897, progress on the tower foundations has been as follows:

New York tower foundations.

At Pier 58 work has gone on intermittently. The laying of the masonry was resumed on the afternoon of July 31st and stopped at noon of August 3d. Two courses are finished. The third lacks a few stone and the fourth has been started. It is not probable that any more stone will be laid this week. During the month of July about 850 cubic yards of masonry were completed, making a total of 920 yards laid. The prospect of receiving stone more rapidly than heretofore is not encouraging. In one pier there will be 5,250 cubic yards of limestone and if the present rate of supplying limestone continues, assuming the granite to be delivered as fast required, it will take the contractor fully five months to finish the north pier and six months more to finish the south pier.

On July 31st a blow-pipe with connections was rigged up and on Monday, August 2nd, the excavation of material was started. But a small gang of men is at work inside. They are getting out the soft river mud which underlies the sand. The discharge empties into the river, which may cause difficulty with the authorities controlling the deposit of material in the river. The Contractor is not yet ready to lower the caisson and his object appears to be to keep the half-dozen pressure men at work.

The south caisson is progressing at the usual rate. The chords for all the trusses are in place and many of the diagonals. The working chamber is being sheathed.

Brooklyn Tower Foundations.

The present state of the work on the Brooklyn tower foundations is as follows: The contractor has leased from the B. & N. Y. Ferry Company the South 6th street pier and has built a high fence separating it from the street. He has an office building half completed. He has also obtained from the American Sugar Refining Company possession of 100 feet of bulkhead to a depth of 80 feet next to South 6th street. He is taking down a portion of the building thereon. He is beginning the construction of launching ways on this area. He has leased the rights of the City in the South 5th street pier. He has received and unloaded on the pier about 150,000 feet B.M. of timber and has driven nine piles as a start toward the construction of an extension of the South 6th street pier.



To the Commissioners of the New East River Bridge.

Gentlemen:

At the close of the two weeks ending August 17th ult. the condition of the work was as follows:

The north New York caisson was carried down so that the average elevation of the cutting edge was 26 $\frac{9}{10}$ feet. The soft mud had been removed. The riprap and other trash had not yet been hoisted out. The pressure men struck or were called out by the Union because the wages paid were \$2.25 instead of \$2.50 per day. This has not interfered with the work, as the masonry is not in a condition to allow sinking to proceed rapidly. The fourth course of masonry had not yet been finished; the fifth course was about half laid. Some stones for the sixth course were on hand. A small gang of men can easily take care of the supply of stone.

At the quarry there is no material change in the conditions.

The south caisson is progressing slowly. The trusses are in place, but some of the rods have not yet been put in. The chamber is planked and partially calked. Some calking has been done on the outer walls. Nine courses of timber are yet to be added to the walls and cribbing.

On the Brooklyn tower foundations, launching ways have been completed, considerable timber has been delivered, and much of the iron. Framing and building of one caisson has begun. I understand that a contract has been closed for the limestone.
