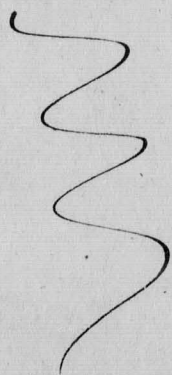



Sir:

I have the honor to acknowledge the receipt of your communication of the seventeenth instant, stating that the American Numismatic and Archaeological Society, desiring properly to mark the dedication of the Grant Monument by the issue of a suitable medal, had invited designs therefor, and asking that the one submitted by Tiffany & Company, and preferred by your Society, should be formally recognized by the Municipal Grant Monument Committee and be declared to be the official medal struck in commemoration of the event which it was organized to celebrate.

At a meeting of the Executive Committee of the Municipal Grant Monument Committee held on the seventeenth instant, your communication was read, and in view of the fact that the design of the proposed medal was not before the meeting, it was unanimously

GEN. GORDON MAY NOT COME.

Presence of ex-Confederates on Grant Day in Some Doubt.

RICHMOND, Va., April 1.—There is considerable interest manifested here by ex-Confederates at the fact that no announcement has yet been made that Gen. J. B. Gordon will participate in the Grant Monument ceremonies. Gen. Gordon is the head of the United Confederate Veterans, which covers the entire South and Southwest.

The belief is expressed in prominent circles that if other Confederates have been invited and the chief of the organization omitted there will be no considerable number of Southerners in line at the Grant ceremonies. Gen. Grant was held in high regard by the Confederates in this State. Gov. Fitzhugh Lee was one of the first Southern Executives to manifest the determination to be present at his funeral.

My dear Colonel:

As you doubtless know, Mr. Henry Treat Chittenden, a well known citizen of Columbus, some years ago purchased the house in which your distinguished father was born and removed it from Point Pleasant, Ohio, to this city, where it is now located on the grounds of the Ohio State Fair Association, being protected by a handsome and artistic glass covering and being thus preserved presumably for all time to come. This generous and appropriate act on the part of Mr. Chittenden has been greatly appreciated by the citizens of Ohio, who love to remember that Ulysses S. Grant was born in this grand state. So much by way of preface.

I have been advised by friends of Mr. Chittenden that he would like very much indeed to attend the ceremonies incident to the formal transfer of the Grant Monument to the City of New York, and I now inform you of the fact, thinking that you would be glad to recognize a man who performed so gracious an act for his state in connection with the memory of your father. If you would suggest to the Committee on Arrangements that Mr. Chittenden should be invited, I am sure that it would greatly please him and that he would attend. Of course, I do not mean that he would expect to be a guest of the city or anything of that kind. He would undoubtedly expect to pay all his expenses, and perhaps would only deem it proper that he should be invited, with a place to listen to the words by which formal transfer of the monument is effected.

I trust you will forgive me if this suggestion is not in good order. It seemed to me entirely proper that you should be notified of Mr. Chittenden's desire, and for that reason I have taken the liberty of addressing you.



Sir:--

Referring to your letter of the 13th. instant. I have the honor to state, that at a meeting held yesterday I was instructed to state that the expenses of this Committee would not exceed one thousand five hundred dollars. It is impossible at this date to make out an itemized statement, but the expenses include stationery, and services of stenographer at meetings, and typewriter, printing all orders by the Marshall of the water parade, the placing of a stakeboat at the turning point of the water parade, the use of a steamer for transporting the artillery and naval reserve of the various states. This steamer will be necessary, as the Naval Militia of the various states will have a long march and the artillery must be taken back to the transfer steamers before the troops leave on their return in the afternoon. The use of all steamers in the parade will be given free, except this one, and there will probably be some three hundred vessels in line.
