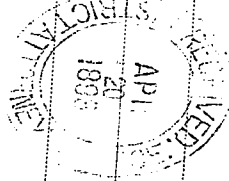

Indictment for grand larceny in second degree.

Court of General Sessions. Part I
Before Judge Leving. May 3, 1893

William B. Trimble, sworn and examined.
I am a graduate of medicine and am
attached to the Government Hospital in
this city. You were attached there on the
15th of April last? Yes. Do you know
this defendant? Yes. Was he about the
Hospital employed in any capacity? Yes,
as a general helper around the Hospital.
The Matron of the Hospital hired him.
I don't know how long he had been there
on the 15th of April, but several months
I should say. I sent him down to
Fulton street on the 15th of April. I
gave him an order on S. Holman
& Co, tailors 116 Fulton St. for a coat
and vest worth thirty two dollars.
What time of day was that? About half
past three o'clock in the afternoon. He
went away with the order. When did
you next see him? I saw him
the next day about the same time
at the Seventh Precinct Police station
in charge of the Police. He did not
return that night and I went the
next morning to the Police Station
and made a complaint about my

loss. I saw Officer Herlich the next afternoon in the Police station in charge of the defendant. I did not find my clothes when I got to the station house. The prisoner was then taken to the Essex Market Court. I went there with the prisoner and the officer. After the affidavit was made the officer went and got the clothes from a Bowery lodging house. I went with him

Cross Examined. I paid thirty two dollars for the clothes. I have bought clothes for the past three or four years and I think I am a pretty good judge of the value. I did not overpay when I paid thirty two dollars. I think I got them extraordinarily cheap.

Henry Herlich, sworn and examined. I am attached to the Seventh precinct. I got a complaint at the station house against the defendant on the 19th of April. I made a search for him. I found him at 149 Allen street in a furnished room house; it was between one and two o'clock in the afternoon. He was not in bed at the time; he was sitting talking to a young lady. I asked him his name. He said, McQuire. I

says. "That aint your name; you will answer for McGuire, you work in Gouverneur hospital, I want you." He says, "yes." I says, "you are just the man I want." He told me, "I took the clothes. I got an order from Dr. Trimble to go down and get a suit of clothes. He said, 'I was up in a lodging house in the Bowery between Third and Fourth streets. He said he went there last night and slept there.'" I said, "Why didnt you go home where you slept last night? You have been in Gouverneur hospital for a month or so. He says, 'I got five dollars from the nurse to pay something and I spent it. I went down to the house in the Bowery that he indicated and found the coat and vest. I signed a receipt for it and gave it to Dr. Trimble; he identified the clothes as his."

Frank Yager, sworn and examined in his own behalf. I did not intend to steal the coat and vest. I was down town for a suit of clothes for the doctor. I had five dollars from the station to get something off the plumber, but there was a fire of some kind and I got mixed in the crowd and

where I got out of it. I went to look for my five dollars in my top vest pocket and it was gone. I got frightened. I was afraid to go back. I was going up the Bowery to see if I could not get something of a friend of mine. He had a parcel; at the end of the parcel he says, "I will fix you for all this." He asked me what I had in the bundle and I told him I got the loan of a quarter off a fellow. I went over to the lodging house and slept. I left the clothes there, not intending to steal them or do anything to them. The next day I went to see if I could not borrow five dollars, off even I used to work for in the New York Biscuit Co. As I returned I went to the wife of a friend of mine and I asked her and she refused. I was sitting there and in came the detective. I got told by the wife that he went to the doctor and suspected I intended to pawn the clothes. They were found in the office where I left them for safe keeping. I was afraid I would get discharged and that is the reason why I did not go back to the Hospital. The jury rendered a verdict of guilty of petty larceny.
