My Dear Sir:-

I have the honor to inform you that during my examination of the affairs of this office, I have remedied many irregularities of a minor character, but have now before me an irregularity of such a magnitude that I deem it incumbent upon me to draw your attention, at once to the same, for such action as you may, in your judgment, deem proper.

The records of this office show, that in the year 1894, there was allowed by the Board of Estimate and Apportionment, the sum of \$34,100 to pay the salaries of the employees, and for contingent expenses. I find upon examination, that the sum of \$32,345, was expended for salaries, and \$1754.74 only was actually disbursed for contingent expenses, while a positive liability was incurred on contingent expenses of \$2760.26, thereby exceeding the appropriation of 1894 in the sum \$1005.26.

In other words, out of the appropriation of 1895, there was paid to Martin B. Brown on Feb. 28th 1895, the sum of \$374.99 for supplies furnished during the year 1894, and a bill of \$630.53 just received by me, for supplies furnished my predecessors, from March 10th. 1894, to and including August 9th. 1894,--not as yet paid--making a total of \$1005.26, clearly chargeable to. the appro-

priation of 1894, and for which provision should be made.

By a hasty examination of the books previous to 1894, I am inclined to believe that similar irregularities existed as far back as 1891.

Should you so desire, I will, at your pleasure, produce the papers for your inspection.



Dear Sir:-

I am in receipt of a letter dated Dec. 3rd. 1895, signed by Job E. Hedges, Secretary to your Honor, directing me to send you a comprehensive, though brief statement, of the condition of this department on the first of January 1896, and what has been accomplished during the current year; and any pertinent suggestions I may have for the work to be done during the coming year.

In reply, I beg to say, that upon assuming control of this office on March 1st. 1895, I found it in a condition not altogether sanitary, and immediately began its renovation, and to-day it is in good order. The business methods heretofore in operation, have been changed materially, and I think for the best interests of the City.

Irregularities of a greater or less extent prevailed; one in particular, ~~to~~ which your attention was called at the time, to wit: exceeding the yearly appropriation.

I was informed that it had been the practice for years to allow the eleven District Court Judges of this City to select their own Jurors from the list of Petit Jurors recorded in this office, and this, in direct violation of section 1684, Consolidation Act. I remedied

this evil by simply complying with the law, (which was mandatory) in selecting the Jurors myself.

I herewith submit a brief statement showing the work performed in 1895 in comparison with that of 1894--

Number of names added during 1894 to the lists of those liable to serve as Jurors	----- 6,139
Number of names added during 1895 (to Dec. 15.)	----- 7,694
Number of Enrollment Notices serve in 1894	----- 48,549
Number of Enrollment Notices sent out (to Dec,15,1895.)	-- 82,964


During the past nine months complaints have been made by many Jurors now on the list, that they have been called for Jury duty every year, often at a time when it seriously interfered with their legitimate business. This matter has been discussed in the public press and by eminent lawyers, looking to a relief of that class of our citizens. Realizing the courts must not be impeded in any way for want of Jurors, it is also manifest that citizens now serving as Jurors should have some consideration; and to that end, I am using every possible means to secure a sufficient number of good men to swell the lists to 40,000 or 50,000 Jurors, by which means we may possibly call upon Jurors once in two years, instead of every year.

The Bar association has appointed a committee to devise ways and means to improve the Jury system, and their subcommittee has been in consultation with me during the past few months, and have partly formulated a plan for the betterment of the system, and if agreed upon, will require legislation to perfect it. In brief, I herewith submit the following suggestions:-

1. Call Jurors to serve once in two years, instead of every year.
2. Notice for Jurors to appear in Court should be served by the Commissioner of Jurors, and not by the Sheriff's office.
3. A system devised whereby proof can be established of a personal service.
4. The wheel containing the names of Petit Jurors, and the wheel containing the names of Grand Jurors should be placed in a safe, or some enclosure under lock and key, and not opened except in the presence of a Judge, the County Clerk, Sheriff and the Commissioner of Jurors.
5. The payment of Jurors should be made by check through the Commissioner of Jurors, and not in cash by the clerks of the several courts.
6. Drawing of all Jurors should be made at this office if it will not materially interfere with the duties of the Judges.
7. The Jury year as now constituted should be changed so as to conform with the calender year.
8. To secure a perfect Jury system, everything pertaining to that branch of the service should be conducted in the office of the Commissioner of Jurors. At the present time it is scattered throughout other departments .

During the week my attention was called to two instances where persons have been approached by imposters who attempted, by representing themselves to be jury servers, to extort money for relief from jury duty. In one case a witness subpoena blank improperly filled in and the names thereon incorrectly spelled was used, for instance; "City Court General Term, Part 2." No such court exists and the name of Judge on said notice is given as Ingrihim. There is no Judge of that name in the city, but there is a Judge Ingraham. Except for one well acquainted with the names of the Judges and with legal papers, this instrument appears on its face to be a true one.

The other case is where a man calling himself George Kelly called upon one Walter J. Lee who was informed by Kelly that he was wanted the next day as a juror in court, but Kelly intimated that if Lee should be too busy at the time for a small sum the affair could be arranged without Lee's being compelled to go to court. Lee being an alien did not accept the offer, but he did not inform Kelly that he was not a citizen. When Kelly was leaving he gave Lee a slip of paper endorsed,

Dear Sir:-

Prompted by a desire to have you fully informed of the improvements made in this office during your administration, I beg to offer a brief report.

In studying over the Jury systems of the different States of the Union, I am convinced that the system now prevailing in this City and County is one of the most compact and useful extant, and yet in my opinion there is room for improvement.

Probably no year has been more productive of changes in the Jury system than the year 1893. Improvements have been made; Territorial limits have been increased; and an entirely new Jury department has been established for the trial of criminal cases.

IMPROVEMENTS.

--oOo--

Numerous complaints were received at the beginning of my term of office to the effect that all classes of our citizens having served on Jury duty during the previous year were called upon for the same duty the following year, an injustice from which it was asked if relief could not be had.

The Bar Association of this City appointed a committee to

confer with me looking to such relief, and if possible to modify the system to such an extent at least as to make it homogeneous. A bill was prepared and passed by the Legislature of 1896, providing for "a juror who serves a term in Court, is now relieved of service until the Second Jury year"; when, under the old law, he would in all probability have been called each and every year. This change has, and will lighten, the burdens of the business man.

Chapter 874 of the laws of 1896 was also enacted, requiring the ballots for trial jurors to be returned by the County Clerk to the Commissioner of Jurors on the last day of each month or immediately after the term of court for which they have been drawn. Heretofore the ballots were retained by the County Clerk. This radical change is labor saving, and precludes the possibility of making errors.

Another bill was enacted and passed the Legislature of 1896, considered by learned legal minds a step towards the betterment of the service, and bringing everything pertaining to the Jury system under one responsible head. The Commissioner of Jurors has now been charged with the notification of Jurors to attend at Court. This change was made with a view to prove "personal service" on a juror, so that when he appears before the Judge he cannot claim "non-service" and subsequently, the fine imposed on him, be remitted.

In this connection I beg to say that the Commissioner of Jurors prepared a notice with a coupon attached requiring the signature of the Juror drawn, thereon, but a refusal to sign was met in many cases. No law exists, I find, to compel signature and it is therefore the inten-

tion of the Commissioner to prepare a bill to be presented to the present Legislature covering that point. Such a law now exists in the State of Connecticut.

Territorial Extension.

--oOo--

There was annexed to the City a large part of Westchester County, which is very sparsely inhabited. I believe this territory comprises 28 Square miles, and to deliver notices in this district is not only expensive so far as car fare is concerned, but the difficulty in covering that part of the country in the serving of notices presents loss of time that does not occur in the City proper--hence a very small additional appropriation was asked for this purpose.

Increase of Courts.

--oOo--

The consolidation of the Superior, the Common Pleas, and the Oyer and Terminer Courts, with the Supreme Court into the present Supreme Court requires more Jurors than heretofore. The Court of General Sessions was increased one part. The necessity of a larger number of Jurors is shown by the fact that in 1894 there were drawn 27,370 Jurors; and in 1896 32,182 being an increase of 4812--a remarkable increase in two years.

Two new Civil Courts were also established in 1896 which is a further demand on the present Jury system.

New Jury Departure.

During May of 1896 a new law went into effect requiring the establishing of a special list of over 4000 names. These Jurors are intended for trial of cases in the criminal branches of our Courts. The names must be taken from the trial Jurors; consequently extra efforts must be made, not only to regain the number lost, but to secure Jurors of the same calibre in all respects so that the general average of the trial list shall not be lowered.

Suggestion.

-0-

A modification of the system by which the collection of fines imposed on delinquent Jurors is collected.

Previous to October 1889 the fines imposed by the Courts upon Jurors for non-attendance was disposed of and the fines collected by the Commissioner of Jurors.

Upon the recommendation of a Senate Investigation Committee the Legislature of 1889 passed a bill taking effect October 1889 transferring the disposition and collection of fines to the Counsel to the Corporation; the hearing of the fines taking place before a Judge of the Court in which the fines were imposed. I understand that at this time the Counsel to the Corporation received an extra appropriation of \$8000 in order to carry out the provisions of this act, and it was hoped that this modification of the Jury system would produce no inconsiderable revenue to the City; but from my knowledge of the result of the seven years of this system it has been a failure, and for many reasons.

First: As a comparison with moneys turned into the City Treasury, the following statement will show the workings of the old and the new law.

The amounts in the column "Old Law" since 1890 to date, represent moneys collected for judgements obtained under the old law, consequently, they must not be accredited to the present law.

Under the old law for the years 1884 to 1889 inclusive the Commissioner of Jurors collected \$11,229.85, and for the years 1890 to 1895 inclusive the Corporation Counsel collected \$10,610.84

The number of fines imposed by the Courts from 1884 to 1889 under the old law was 19016; and the amount of money collected was \$11,229.85. or an average of fifty nine cents for each fine. While in the years 1890 to 1895 under the new law there were fines imposed to the number of 24,568 and the amount of money collected was \$10,610.84. or an average of forty three cents for each fine. In other words there was an increase in the number of fines imposed under the new law of 29%; and a decrease in the amount of money collected of 6%. Placing the conditions of the new law on the same basis as the old law, the collections should have reached at least \$14,561.15.


Under the old law the Commissioner of Jurors had almost exclusive control over the fines and could remit at pleasure. This ought not to obtain. The Commissioner with one or more Judges of the Courts should sit at stated times and dispose of these cases; by such a method no reflection could possibly be cast on either the Judges or the Commissioner.

As before stated it is very essential that the jury system should be made homogeneous and to that end the Commissioner of Jurors should furnish the Sheriff's Jurors either in the same manner as they are now furnished to all the other Courts in the County, or selected as are the Grand Jurors.

Numerous improvements in the office proper have been made to secure promptness in the transaction of business and to add to the comfort of the employees. Trusting this may meet with your approval







The Commissioner of Jurors, acting as Clerk of the Board, presented a memorial signed by Mr. Michael Kelly, as secretary of a body styled "District Assembly 49" suggesting the addition to the lists of seventeen persons named in the memorial.

The Commissioner in the same connection reported to the Board that but one of these persons, is eligible; that the other sixteen are not upon the trial jury lists and are consequently disqualified.

Justice Barrett thereupon moved the following resolutions:-

RESOLVED, that in the selection of grand jurors this Board should not act upon the motion of any corporate or organized body; should not select representatives of any special vocation, business, trade or interest as such; should select, as required by the Statute, solely upon the basis of intelligence and good character as represented in the trial jury lists; and is not authorized by law to apportion its selections geographically, that is, to particular wards, districts or other special localities within the County.

Justice parrett moved that the Commissioner of Jurors as the Clerk of this Board transmit to Mr. Michael Kelly as secretary of the memorialists a copy of the above resolution. And that he also, at the same time, inform the memorialists that their memorial has received respectful consideration and that the Board, while believing that the accompanying resolution properly expresses its legal duty in the premises, would be glad, at ^{a suitable} any time before the lists are signed, to receive, consider and act upon the suggestions of individual citizens with regard to the selection of qualified persons of whatever occupation as grand jurors.
