The appropriations for the Board of Education included in the Final Estimates for 1895, 1896 and 1897 were as follows:

1895.....	\$4,962,423.14
1896.....	\$5,679,302.59
1897.....	\$5,931,239.89

The amount of School-house Bonds authorized to be issued by Chapter 88 of the Laws of 1895 is \$5,000,000. Of this amount the Board of Estimate and Apportionment has authorized, up to January 1, 1897, \$3,525,707.53; and of this last named amount \$2,879,003.56 have been issued up to January 1, 1897.



I have received notice from your Secretary that there will be a public hearing at your office on April 14 at 2:30 P. M., on Assembly Bill No. 1860, entitled "An Act relating to the Brooklyn and New York Ferry Company."

This bill authorizes the Brooklyn and New York Ferry Company to establish a ferry across the East River from the foot of Broadway to the foot of East Forty-second Street, in the city of New York.

It seems to me that this is a most indefensible interference by the Legislature with the vested rights of the corporation of the City of New York in its ferry rights.

It is true that section 4 of this bill provides that nothing therein "shall be so construed as to take away or impair any "rights or franchises owned by the cities of New York or Brooklyn",

but the fact remains that the very creation of this ferry is in derogation of the ancient rights of the city of New York relating to ferries, and a serious infringement of the principle of home rule.

One of the ablest writers on law affecting the city of New York has maintained that the right of the city of New York to establish ferries is exclusive, and not subject to interference by the Legislature. In Hoffman's Treatise on the Corporation, p. 136, this question is summarized as follows:

"The lowest possible form in which the compact with the State can be presented, is this: that the Corporation shall have the first privilege of establishing new ferries within the limits fixed in their grant. No statute can then take away this franchise on the ground of taking private property for public good, unless upon a judicial conviction of the Corporation, working a forfeiture for neglect. The Corporation should first be called upon to fulfill the public duty with which its right of property is connected. When its refusal is declared in a legal judicial manner, the right of the State to confer the franchise upon another may arise. But the fact of public necessity or high utility must first be made out, and the culpable neglect of the Corporation first declared, upon a hearing, in a competent tribunal."


In the present case there has been, so far as I am informed, no neglect or refusal on the part of the Corporation to establish a ferry at any point where the public convenience may demand it. I have no doubt that the Board of Aldermen would, if application were made, establish, with your Honor's approval, a

ferry between Broadway, Brooklyn, and the foot of East Forty-second Street, New York. But such a ferry franchise would, according to law, be offered at public auction to the highest bidder and would be for a term not exceeding ten years.

Assembly Bill No. 1860, however, confers its privileges, without limitation of time, exclusively upon the Brooklyn and New York Ferry Company, a private corporation. To create a monopoly of this kind, free from the control of the local authorities, would be grossly unfair to the other companies now operating ferries under franchises obtained from the Common Council and the Commissioners of the Sinking Fund. The result of such special legislation would inevitably be that these other companies would obtain similar privileges from the Legislature and the ferry rights of the corporation would ultimately be wholly lost.

This bill is more than unnecessary and unjustifiable: it is one of the most pernicious attempts at legislation that I have noticed since holding the office of Comptroller of this city, and I therefore earnestly request that you refuse to give it your official approval.

Mr. J. A. W. Pine of 130 Pearl Street has made certain allegations here in regard to the legality of the letting of certain asphalt contracts by the Commissioner of Public Works, and also as to the legality of the specifications under which the contracts are let.

I regret to be forced to ask your help in the following matter:


The moneys which are deposited by contractors with their bids are always sent promptly by the Departments to this office, from which they are deposited in the Security Deposit account, and are promptly returned to the contractors as soon as the bids have been opened.

Since April 7 representatives of Messrs. Blake & Williams and other business houses have been calling here for the return of the security deposits put up by them for bids for repairing the building occupied as quarters of Hook and Ladder Co. No. 9, and for furnishing a new boiler and pumping apparatus, which I am informed were opened by the Fire Department on April 7. These moneys

should have been here on April 7 or 8, but have not yet been received by this Department. On being called upon for the return of the moneys here, we have endeavored to obtain the same from the Fire Department, but without result. I wrote to Mr. Sheffield on April 14 about the matter, but can get no answer. The rule of all the Departments has been to transmit these moneys on the day of the opening of the bids, in order to guard against possible loss by reason of the failure of the banks on which the checks are drawn.

I therefore ask that you will communicate with the Fire Department, to the end that these moneys may be received and deposited in the usual way, and paid back to the gentlemen who are entitled to receive them and are waiting impatiently to get them.

I have the honor to report as follows in regard to Assembly Bill No. 753, entitled "An Act to create a division of notification in the Department of Finance in the city of New York":


I believe there is merit in the idea of notifying property owners of assessments for local improvements as soon as the same shall have been confirmed, and the list relating thereto filed in the office of the Comptroller. If it were necessary however, to register each application on a separate folio of a volume, and to begin operations with a sufficient number of volumes to include every lot number in New York, I would consider the advantages of this Bill to be more than offset by the great expense entailed; since to comply with the law in this matter would require about three hundred volumes of 1,000 pages each, costing about \$ 20,000.

I believe, however, that substantial compliance with this law will be made and practical effect given to it by starting with a small number of volumes; using only so many folios as may be required by the applications which may be made from time to time; but starting also

with a complete set of indices upon which shall appear consecutively every lot number in the city of New York, and against which cross-references can be entered of the folio numbers of applications for registrations made pursuant to this law.

If, as I believe, this can be done, the proposed law would, in my judgment, prove to be an excellent piece of legislation.

SUGGESTIONS.

1. The Police Department.

This Department is practically independent of the supervision of the Comptroller, the financial officer of the City.

The funds required to defray the expenses of the Department are paid in bulk on requisition of the Commissioners, to their Treasurer; and no examination or audit is made by the officers of the Department of Finance of claims against the Police Department.

The Legislature should unify and harmonize the financial administration of the City by making the bills of the Police Department subject to audit and examination by the Finance Department, and make them as well as salaries payable by the Comptroller by warrants drawn by him on the Chamberlain and countersigned by the Mayor.

2. THE DEPARTMENT OF DOCKS.

This Department is in need of remedial legislation. Its important functions are necessary to the commercial supremacy of the City; but limitations upon expenditures and safeguards for due economy may well be provided. At the

same time its operations should be certain and uniform, and it should not be crippled for want of necessary means or by reason of defective laws.

This Department was limited by the Charter of 1870 which created it to an expenditure of three hundred and fifty thousand dollars per annum; and the powers and duties of the Commissioners governing it were such as were established and defined by the Commissioners of the Sinking Fund. The Legislature subsequently in the same year elaborated a plan for the government of this Department by which its functions were made exceedingly important and which plan is substantially unchanged to the present time. These important functions it is not now necessary to detail; the financial features of the legislation is all that needs comment.

To meet the expenses of the Department bonds were authorized to be issued by the Comptroller under the direction of the Commissioners of the Sinking Fund; and the interest on these bonds was to be met by taxation each year and when the principal sums became due in not less than thirty years after issue of the bonds they were also to be included in the tax levy.

It was provided that no more than three million dollars of these bonds should be issued in any one year.

Under this system the annual expenditure has varied greatly as appears by the following statement of Dock Bonds annually issued from 1870 to 1884.

Under the operation of the recent Constitutional Amendment restricting municipal indebtedness, these bonds can no longer be issued. Legislation now becomes necessary to meet the changed condition of things.

The expenditures of this Department should be provided for in the annual tax levy and should be limited to a reasonable sum. I do not think that it should exceed a million dollars per year, and might well be half that amount.

3. THE DEPARTMENT OF PUBLIC WORKS.

This Department is a consolidation of functions which were formerly separated, mainly relating to our water supply and to the lighting and paving of streets and care of the sewers and public buildings of the City. Its annual expenditures are large; and its employes and officials numerous.

In my judgment its operations should be much simplified. The collection of revenues derived from the sale and use of water should be entrusted to the Finance Department.

A Department should be created which would have sole control not only of the structures and property connected with the present water supply, but also of the New Croton Aqueduct now entrusted to a special Commission.

Another Department or a single Commissioner should have all or nearly all the other powers of the present Department of Public Works. Here should be massed all those duties connected with the paving, repairing, repaving and lighting of streets. The care of public buildings and the maintenance of the public sewers. If a Bureau of Incumbrances is to appropriately remain in such a Department, the duties of the Bureau of Permits connected with the Mayor's Office should also go there. The present powers of the Department of Public Parks in relation to tunnels and bridges, streets, and avenues and sewerage and drainage in the 23rd & 24th Wards, would be more consistently lodged in the

new Department.
