EXTRACT FROM U.S. NAVY REGULATIONS, 1900.

Article 913. "Every person who deserts the naval service of the United States shall, upon conviction thereof, be forever incapable of holding any office of trust or profit under the United States, or of exercising any rights of citizens thereof."

Article 914. Every person who entices or aids any person in the naval service to desert, or who harbors or conceals any such person, knowing him to be a deserter, or who refuses to give up such person on the demand of any officer authorized to receive him, is liable to punishment by imprisonment and fine, to be enforced in any court of the United States having jurisdiction.
