Dear Sir :

Referring to Assembly Bill No. 199 entitled "An Act to amend chapter one hundred and twenty of the Laws of eighteen hundred and ninety-four", I beg to furnish you with the following information :

The assessment list for regulating etc. Tenth avenue from 155th to 194th streets was confirmed December 20, 1878. Since that time payments amounting to \$ 8,189.48 have been made and assessments amounting to \$ 121,552.90 have from time to time been cancelled by orders of court.

There remain of record unpaid assessments amounting without interest to \$ 54,827.75.

I may add that while the invalidity of these assessments seems to have been established by the Court of Appeals in the matter of Deering 85 N.Y. 1, the decision was based on grounds of a technical nature and there is no reason to doubt the fact that the property assessed did in fact receive benefit by reason of the execution of the work. While the assessments have been declared uncollectable, their presence on the books of the Bureau of Arrears, have been regarded by some lawyers and Title

Companies as a cloud upon title. On this account payments have from time to time been made by property-owners. When the Act of 1894 was passed I construed it to be permissive only and not mandatory, and declined to direct the cancellation of these assessments unless so directed by order of court, on the ground that a public official should not voluntarily assist in preventing the city from obtaining some return of money expended, to which it seemed to be entitled equitably if not legally.

The purpose of the proposed amendment seems to be to change an apparent authorization into a plain mandate.
