

As this could be done without any cost to the city, I at once inaugurated said tests and same are now being carried on in the lots at the N. E. Corner of 68th St. and Avenue A and Corner of 82nd Street and Western Boulevard, under the direction and supervision of this Department and the Board of Examiners, representing the Fire Department, the Board of Fire Underwriters, the New York Chapter American Institute of Architects, the Mechanic and Traders Exchange, the Society of Architectural Iron Workers, the Real Estate Owners and Builders Association and the Real Estate Exchange, Limited.

As you will readily realize the importance of this to the public and to the different manufacturers and builders of the city, I know you will appreciate my action.

Dear Sir:-

I received this morning from the Chief of Police copies of papers forwarded by you to the Police Board, in regard to careless blasting in the neighborhood of #179 West 76th St., indicating the desire to have the matter investigated by the Police Board.

The legal action in this matter would require that the contractor doing the work should obtain a permit from the Bureau of Combustibles in the Fire Department, filing bonds, etc. with the said Department, who also issue a direct specification covering the method of blasting, chaining, logging, etc.

I thought it might be interesting to Your Honor to have these points, in case you desire to look further into the subject. I would further add that I try to obtain through my inspectors any information in regard to blasting, as it is frequently the cause of racking or cracking or making dangerous adjoining buildings, and in several cases I have been forced to make complaint to the Bureau of Combustibles in regard to reckless blasting.

As I reported to the Board of Apportionment, in regard to this class of building, there are hundreds of them in the city in which from age, change of occupancy and use, improper repairs, etc. the slightest overloading is liable to cause just such an accident, and as already there have been a number since I have been here, and likely to be many more, you can readily see how important this matter is, and proves the importance of a block to block inspection, especially in certain sections, as soon as possible.

I find the adjoining buildings, #31/3 Vesey Street, also in unsafe condition and am taking immediate measures to prevent accident there.

Of the sixty-two unsafe buildings reported during the week, eight required immediate attention by the Department and necessitated the calling out of the Emergency Corps. Two of which, 110 Bleecker Street and 278 Spring Street, were very important and by the prompt and efficient action and work of the Emergency Corps, working on Bleecker Street all day Sunday, a very serious accident was averted. On Spring Street, by working from 7 at night until 11 and continuing by additional work for two or three days, a serious accident was averted.

Mr. Dahlgren, Attorney for the Department, went before the Raines Law Investigating Committee, as it seems very evident that Dr. Parkhurst does not fully understand the law. I think if the Doctor will get the assistance of good legal advice, he will find that the action of this Department is in accordance with the Building law, and when he considers all circumstances surrounding the matter, has been pretty thoroughly, reasonably and carefully carried out. I have advised said Committee that any further information or evidence that this Department can furnish will be willingly given.

I have decided, owing to the importance of the case and the

chances that there will be many suits in regard to the #1078 Madison Avenue disaster, that a regular soil test be made, which will be started on the 8th instant. This will prove positively the bearing capacity of the soil, etc..

I have suggested to Civil Service, as there have been great delays in getting Inspectors for this Department, that they have their examinations far enough ahead to always have a number of men to draw from. Also that the Building Inspectors of this Department be divided into Mason Building Inspectors, those who are accustomed to build and superintend such buildings as are now being built throughout the main portion of the City and in which masonry, iron work and fireproof construction are the most essential and prominent parts, and Carpenter Building Inspectors, those who have been accustomed to build frame structures and lighter class of buildings, which are built beyond the fire limits and the outlying districts and annexed territory, so as to be able to place in both classes of buildings, men thoroughly competent to handle the men under them. I suggested this some months ago but the Commissioners, for some reason or other, have been unable to get them to act upon the matter. They have now promised to do it and I hope that if I can pay the proper wages, I shall be able to secure the most com-

My dear Mr. Roosevelt:-

In compliance with your request of yesterday, I herewith desire to briefly state to you the requirements of the Building Laws in their relation to hotels in this city:

1. No building HEREAFTER erected that is over thirty-five feet in height can be used as a hotel unless it be fire proof. (See Section 20, Chapter 275, Laws of 1892). This requirement of law applies to all buildings put up subsequently to April 9th, 1892.

2. Buildings ALREADY erected, namely: Prior to April 9th, 1892, that are five stories in height, or are four stories in height with a basement above a cellar, must comply with the provisions of Section 16, Chapter 275, Laws of 1892, if the same are altered to be used as hotels. The provisions of this section comprehend certain fire proof changes in the building. If the building exceeds five stories in height there are additional fire proof requirements.

I notice that it is claimed by the Society for the Prevention of Crime that this section applies to all buildings. I have consulted, however, with my Attorney, Mr. Dahlgren, in regard to this matter, and he informs me that there can be no doubt that the Society is mistaken in its construction of the statute.

With regard to fire escapes I would say that that is a matter left by the law entirely to the discretion of the Superintendent of Buildings (See Section 34, Chapter 275, Laws of 1892), and that this discretion is only to be exercised when that official deems the means of egress insufficient.

The above are the main provisions of law applicable to hotels in this city. There are several others of minor importance, such as

2. To Hon. Theodore Roosevelt.

the provision that all hotels shall have a stop-cock in the sidewalk to shut off the gas (See Section 26, Chapter 275, Laws of 1892), a compliance with which is always easily secured on account of the small cost arising therefrom.

The provisions of law applicable to other hotels are such as apply in general to all buildings over the city.

I would here add that this Department has no jurisdiction over the light and ventilation of hotels. From what I have herein set forth, you will readily see that there are hundreds of buildings which may be used as hotels without any interference on the part of this Department. In quite a number of cases where I attempted to act, the owners denied my right, the matter was referred to Mr. Dahlgren, and he decided that the provisions of law did not apply.

In closing I would beg to say that while I am ever ready, as a citizen, to aid in the enforcement of the law, that the main object of the creation of the Department of Buildings was the physical safety of the people and not their moral security; that, therefore, while I am ready to aid to the best of my endeavor in the enforcement of the Raines Law, yet I cannot see how it is just for this Department to be held responsible in any way for the non-enforcement of that law.

Dear Sir:-

The Executive Committee of the Society for the Prevention of Crime has received a communication from your Department regarding "Raines law" hotels. We do not agree with your construction of Section 480 of the Consolidation Act, as amended. We believe that it applies to all buildings that have been altered in any way to become hotels regardless of height. The making of bedrooms by partitions or otherwise is a sufficient alteration.

May we urge your use of the power to bring actions in courts of record and to obtain injunctions preventing the continuance of business in premises where the fire and building laws have been disregarded?

We have in mind the instituting of proceedings of this nature and other proceedings, but we prefer to wait and give your Department the opportunity of commencing.

From our observations it appears that many of the "Raines hotels" made their alterations and are doing business without any permit from you. A comparison of the list of hotels with your list of permits issued will show the places that we mean. These offending places are subject to your visitation.

Will you kindly remember that our communications to you are entirely impersonal?

We respectfully request you to proceed by actions for penalties and by actions for injunctions to compel compliance with Section 480 of the Laws of 1882, as amended (page 28 of your Manual), at the hotels Nos. 74 Stanton Street, 139 Chrystie Street, 61 Forsyth Street, 65 Mott Street, 75 Mulberry Street, 22 Baxter Street, 89 Park Street,

Dear Sir:-

Kindly advise me whether the following provision of law applies to ALL buildings which are hereafter altered to be occupied as hotels, or only to such as are five stories in height, or have a basement and four stories in height above a cellar. The requirement in question reads:

"Every building hereafter altered to be occupied as a hotel, and every building hereafter erected or altered to be occupied as a lodging-house, and every tenement-house, apartment house and dwelling-house five stories in height, or having a basement and four stories in height above a cellar, hereafter erected or altered to be occupied by one or more families on any floor above the first, shall have the first floor above the cellar or lowest story constructed fireproof with iron or steel beams and brick arches." (Section 16, Chapter 275, Laws of 1892)

As it is extremely important for this Department to be properly posted with regard to the above question, I would request your views at an early date.

I enclose an opinion written by my Attorney on the 13th day of May last, in which on Pages 6 and 7, he discusses the above matter. As his interpretation, however, has been disputed by the Society for the Prevention of Crime for this City I hereby, pursuant to Section 215 of the Consolidation Act, refer the matter to your office.
