If transportation is required to effect the delivery of this deserter or straggler, application should be made to the Bureau of Navigation, Navy Department, Washington, D. C., setting forth that he is in custody and identified, and that this offer of reward has been received by you. In such case the prisoner should not be taken from place of arrest until the transportation furnished by the Bureau is received, as no reimbursement will be made for any expenses of transportation incurred without the consent of that Bureau. Transportation furnished by the Bureau includes sleeping car for night rides only, and meals en route for officer and prisoner from place of arrest to place of delivery and return of officer under same conditions to place of arrest. No expenses of officer at point of delivery will be allowed.
