

Dear Sir:--

In reply to your communication of May 26, enclosing a letter from Agnes G. Troup, of #131 East 66th street, complaining of the new roof on the 7th Regiment armory, I desire to state that I have had this matter investigated by the Superintendent of this Department.

He assures me that the material selected for this roof was due to long and exhaustive tests, and we had rather taken pride in it, as it had all the requirements necessary for the upkeep of this immense roof. The material is known as asbestos roofing, put on in sheets. It is rather light when first applied, but will darken in time.

This material was selected principally because it was plastic and would give and take with the expansion and contraction of the steel structure. It is also fireproof as well as waterproof.

The tar substance that Mrs. Troup suggested this roof might be covered with would leave the roof a fire menace to the building, and the buildings in the neighborhood. I have hopes, however, that after another winter's snow, the color will tone down and not be objectionable to Mrs. Troup.

Inquiry was made at apartment houses, asylums, hospitals, etc., in the immediate vicinity, and in place of complaining they all thought that the roof was a magnificent one, and much prefera-

Dear Sir:--

In reply to your communication of June 2, enclosing inquiry from Robert Murray Lincoln Brown as to where a boy could practice rifle shooting within the law, I desire to state that several high schools of the City of New York have rifle clubs which practice in the various rifle ranges of armories of the National Guard, with the permission of the commanding officers, under such rules and regulations as they may prescribe.

I inquired as to Master Brown's age, school, etc., and find that he is a boy sixteen years of age, a pupil of Morris High School Annex. I would suggest that he get in communication with the rifle club attached to his school, or in the event of the club being full, that he organize another club, and that some teacher who is interested in their practice apply to the commanding officer of the organization most convenient to the homes of the members for permission to use the rifle range. I have no doubt but that the commanding officer's interest in promoting rifle practice will gain the required permission.



Communication from the Commanding Officer of the 2nd Company Signal Corps requesting that the present lease of the Bedford Riding Academy for the mounted drills and storage of equipment of this Company be renewed; also that provisions be made for the storage of the following additional carts and wagons: 1 lance truck, 1 field wagon, 2 instrument wagons, 4 wire carts.

(Present lease expires November 1, 1913. Terms \$1600. per annum; lessor pays taxes and water rates, makes all necessary repairs and alterations and furnishes light and heat; accommodations include the use of the riding ring two entire evenings each week, suitable locker and toilet accommodations and the storage of one escort wagons, and one wire reel cart.)

(A clause in the original specifications allowed the contractor to use the old gas piping, but, upon a test, this piping did not stand the test required by the Department of Water Supply, Gas and Electricity; the Armory Board will practically have new gas piping in the entire building, at a much smaller sum than it would cost to do the work in another manner.)


