Dear Sir:-

I beg to call your attention to Senate Bill No. 779, introduced by Mr. Page, which seeks to amend Subdivision 3, Section 86 of the Consolidation Act.

I find that the amendment adds in Section 3 the words "and the erection of steps, porches and approaches."

If this becomes a law it may result in the obstruction of the sidewalks of our streets to even a greater extent than they are to-day; and it is particularly on that account that I enter my protest against the approval of this Bill.

Many of the streets of this city are even now too narrow for the volume of business conducted, and to permit any further encroachment thereon would be simply depriving the citizens of this city of part of a highway, which, as a matter of right, belongs to them, and without any compensation to the city therefor.

Dear Sir:-

As Superintendent of the Department of Buildings of the City of New York, I have examined the provisions of Senate Bill, Print No. 946, and in so far as the same relate to the Department of Buildings, I deem it my duty to call your attention to certain features of the bill.

First: I desire to inform you that if Section 480 of the Consolidation Act, as amended, is construed by the courts in accordance with the opinion of the Counsel to the Corporation of this city, then, at one blow, the use of most all of the buildings as hotels, under the Liquor Tax Law, must necessarily be declared illegal and discontinued.

Section 480 of the Consolidation Act, as amended to date, provides:

"Every building hereafter altered to be occupied as a hotel, and every building hereafter erected or altered to be occupied as a lodging-house, and every tenement house, apartment house and dwelling house five stories in height, or having a basement and four stories in height above a cellar, hereafter erected or altered to be occupied by one or more families on any floor above the first, shall have the first floor above the cellar or lowest story constructed fire proof with iron or steel beams and brick arches."

The construction put upon this section prior to the opinion of the Counsel to the Corporation was that the requirement as to having the first floor fire proof applied to hotels only when the same were five stories in height, the words "five stories in height", in the part of the section above quoted, being deemed to be applicable to hotels, lodging-houses, tenement houses, apartment houses and dwelling houses.

Upon submission of this question to the Counsel to the Corporation, he held that the words "five stories in height" applied to tenement, apartment and dwelling houses only; and that every building hereafter (April 9th, 1892) altered to be occupied as a hotel, must have its first floor fireproof, irrespective of height. If this interpretation is correct, I am advised by my present attorney, that Section 484 of the Consolidation Act, as amended, must be construed to mean that every

building hereafter (April 9th, 1892) erected to be used as a hotel must be entirely fire proof, no matter what the height of such building may be. Section 484 just referred to, as amended, reads as follows:

"Every building hereafter erected to be used as a hotel, and every building hereafter erected or altered to be used as a theater, hospital, asylum, institution for the care or treatment of persons, or in whole or in part as a school or place of instruction, the height of which exceeds thirty-five feet, except buildings for which specifications and plans have been heretofore submitted to and approved by the superintendent of buildings, and every other building the height of which exceeds seventy feet shall be built fire proof."

Section 480, as amended, you will note, refers to buildings altered after April 9th, 1892, while Section 484, as amended, refers to buildings erected after April 9th, 1892.

Plans for buildings to be altered to be used as hotels are not now approved by this Department, unless the first floor is fire proof in accordance with the opinion, above referred to.

Actions for permanent injunctions, with the usual order to show cause for an injunction pendente lite, have been commenced by this Department, and my attorney informs me that the orders to show cause will be argued soon.

If the court sustains the opinion of the Counsel to the Corporation, you can readily see that in a very large number of buildings now used as hotels, such hotel use must cease for the reason that a very great number of these hotels are situated in buildings erected prior to April 9th, 1892, which have not the first floor fire proof.

Second: Section 31, subdivision 2, of the Liquor Tax Law, as now proposed to be amended, page 49, provides that a hotel shall mean a building in which the only other dwellers besides the guests, shall be the family and servants of the hotel keeper. If this definition is retained in the Act, it will wipe out a great number of hotels and work grave injustice to many.

Third: The word "area", used in the proposed amendments at page 49, is inaccurate, and means in the building law something entirely different from what it appears to be intended to mean in the proposed amendments. An open area under the Building Law is open space adjoining

the cellar or basement of a building. In the proposed amendments it is evidently intended to mean a light shaft, court, well or open air, and if so should be properly expressed.

Fourth: The proposed partitions of four inch thickness would be impracticable in many buildings now used for hotels exclusively, and also in buildings that could be properly utilized hereafter for hotel purposes. Many such buildings used as first-class fire proof hotels have partitions less than four inches thick, and a requirement making such partitions of four inch thickness would render them useless for hotel purposes, -- the Hoffman House, the New Manhattan, the Empire, the Imperial, and many others in which the partitions are from two to two and one-half inches thick.

Fifth: Under Section 498 of the Consolidation Act as amended, the Superintendent of Buildings has discretion in regard to the requirement of fire escapes and means of egress, etc. The proposed amendments would make it incumbent upon the Superintendent to add many requirements in this regard to those now in force, and would necessitate extensive alterations to provide additional means of egress, such as additional stairways, halls, fire escapes, etc.

The effects of the amendments, in so far as they relate to building construction as controlled by this Department, would be to wipe out practically all of the smaller hotels, and even affect many of the large hotels in this City.

If you desire further detail, I shall be pleased to furnish same at your request.

As numerous temporary structures will be erected for standing or sitting purposes to review the parade of the 27th, and as thousands of people will make use of said structures, and the law in the interest of public safety requires that permits for same should be applied for and approved by this Department, I have deemed it advisable to issue through the press a circular calling attention to this fact, copy of which I enclose herewith. I have also notified the Police Commissioners upon the subject, asking for their co-operation in seeing that stands are not allowed to be erected without the said permit and inspection of this Department.

As it is considered that the Board of Alderman have the right to permit the use of sidewalks and public thoroughfares for these temporary structures, it is also considered that the Park Department have the same right over property outside of the building line under their jurisdiction; but in all cases this Department has control over the method and form of construction, and therefore must issue a permit for the same.



The Department of Buildings must in all cases pass upon the safety of such structures. Any violation of this requirement is strictly forbidden.

Where any such structure is to extend beyond the building line into the area of a public street or avenue, permission of the Board of Aldermen or of the Park Department must also be obtained.

This notice is given to facilitate the obtaining of permits for the erection of stands, etc., for the review of the parade which is to take place on April 27th instant.

In accordance with your wishes expressed in a communication to me of the 7th inst. from your secretary, I respectfully beg to report that I ordered an examination of premises #100 East 26th Street, in order to determine if same came within the scope of the statute for fire escapes, and enclose herewith a copy of my reply of even date to complainant.

My inspector reports further that the four story brick building in question, 20' wide by 80' deep, is occupied, 1st story as a store; and the upper floors are rented out as furnished rooms-- there being sixteen of them, including the apartment occupied by the house-keeper, who alone cooks upon the premises.

By referring to the Statute mentioned you will see that I have no jurisdiction excepting in relation to the buildings therein mentioned.

Section 34 of Chapter 275 of the Laws of 1892 requires that certain buildings therein named shall be provided with good and sufficient fire escapes, as shall be directed by the Superintendent of Buildings.

The buildings in said Statute mentioned are as follows:

Every dwelling house occupied by, or built to be occupied by three or more families above the first story;

Every building more than three stories in height, occupied and used as a hotel or lodging-house;

Every boarding-house having more than fifteen sleeping rooms above the first story;

Every factory, mill, manufactory or work-shop, hospital, asylum or institution for the care or treatment of individuals;

Every building in whole or in part occupied or used as a school or place of instruction or assembly; and

Every office building five stories or more in height.

The building No. 100 East 26th Street does not fall under any of these definitions. It is not a lodging-house, for the reason that the law defines a lodging-house to be any house in which persons are harbored, or received or lodged for hire for a single night, or for less than a week at one time; or any part of which is let to any person to sleep in for any term less than a week.
