

And this deponent further saith , that this postal card was received by him *from Mr. T. B. Jackson who had been a sub-tenant of this deponent at the office of this deponent viz #50 Bond St, New York City shortly after its date*

And this Deponent further saith that he is familiar with *The hand writing of* said Hermann Engelhard, and that *address and message upon the* postal card above referred to and hereto attached is in the hand writing of the said Hermann Engelhard.

And this Deponent further saith that he made numerous efforts subsequent, to ~~the~~ time first mentioned to find the said Hermann Engelhard, but that at no time during the entire period, did this Deponent hear of the


