Dear Sir:-

As a Member of the Board of Estimate and Apportionment, I desire to call your attention to the fact that for the year 1912, there was appropriated for the use of this Department to be expended in salaries, the sum of \$114,000. of which approximately, \$5,300.00 remains unused; this was an increase over the estimate of 1911 of \$11,100.00, and was occasioned by a desire on the part of this Board to secure additional clerks to assist the present force in this office. A question has arisen since last year as to which Civil Service Commission, State or Municipal, has jurisdiction over the employees of this Board.

This matter is now in litigation, and an appeal has been taken to the Court of Appeals from the recent decision of the Appellate Division, (See New York Law Journal, August 19th, 1912, People ex rel Werner vs. Prendergast et al), and as soon as this question is determined by the Court of Appeals, we will make the appointments desired by us.

The same amount, (\$114,000.00), has been requested in our appropriation for the year 1913, and we respectfully ask you under the circumstances and by reason of the explanation made herein, to provide for the use of this Board the sum of \$114,000.00, to be expended in salaries as asked for in the schedule submitted to you for the year 1913.


