I was seated 8 or 9 rows from front on extreme left. I usually sit in front row with bass. I arrived around 2:15 PM 2-21-65 - at Audubon Ballroom. C. Spiker spoke & MacArthur X came on stage & sat down. Benjamin finished talk. MacArthur X shook hands with Benj. Hale X came forward & said "Sholem Aleicher" someone shouted from audience "Get your hands out of my pocket." It was stated on the right & front of me. I heard a man yell twice "Get your hand out of my pocket" I glanced over, he was crouched over. I didn't get a good look at his face, wearing dark suit well built. I saw his mouth say something with words "Get your hands out of my pocket" Shirts ran out I couldn't tell where they came from. It sounded like a string of firecrackers. I went down to the floor. Spring continued it seemed to come from all kinds of different places. I looked up later & saw rockets lying there. After shot & everything was over I saw a man run down left aisle & kick a chair over. I don't think he had anything to do with it. Center was clear almost everyone had run out the rear, by then. The man I saw start were dark skinned. I cannot say from the pictures of the man shown to me (Butler Hayes, + Johnson) I cannot say for sure he is or is not the man.

I was seated 8 or 9 rows from the front stage on the extreme left side. I usually sit in the front row with the press. I arrived at about 2:15 P.M. on 2-21-65 at the Audubon Ballroom. A speaker spoke and his name is Benjamin, he finished and then introduced Malcolm X. They shook hands and then Malcolm X stepped forward and greeted crowd with "Salaam Aleichem", someone then shouted from the audience "Get your hand out of my pocket". He was seated on the right and in front of me. I heard these words Get your hand out of my pocket, twice, I glanced over in that direction and saw a man get to his feet crouched over. I did not get a good look at him. He was wearing dark clothes and was well built. His mouth was moving when I heard the words Get your hand out of my pocket. Shots rang out, I couldn't tell where the shots came from. It sounded like a string of firecrackers. I went down to the floor. Shots continued it seemed to be coming from all kinds of places. I looked up later and saw Malcolm X lying on the stage. After the shots and everything was over I saw a man run down the left aisle and kick a chair over, I don't think he had anything to do with it. The center was clear almost everyone had run out the rear by then. The man I saw was darkskinned I cannot say from the photos shown me that it was or was not the people in the ~~XXXXXX~~ photos.
