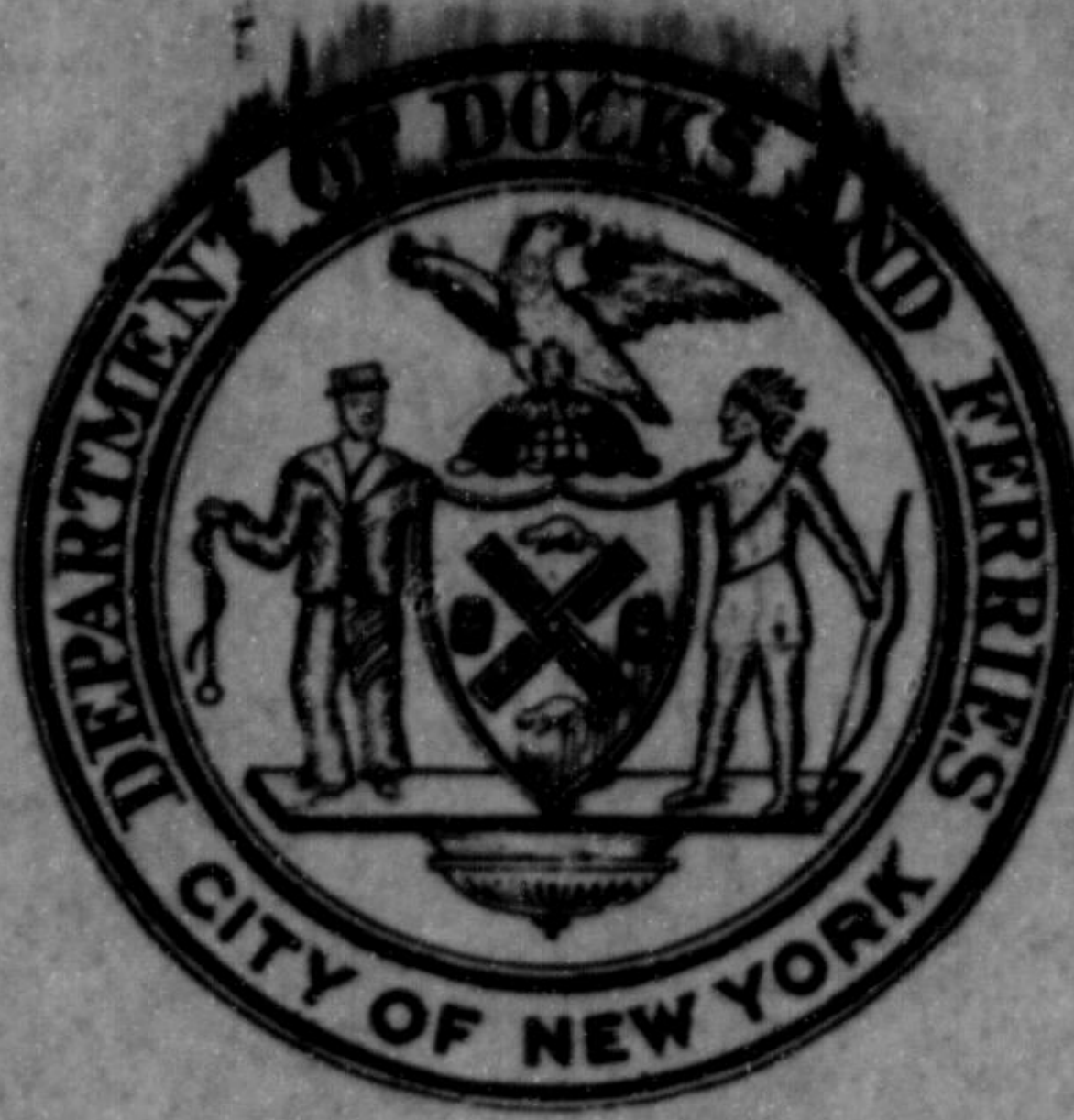

With further reference to your communication of August 13th, relative to and enclosing anonymous letter of complaint with regard to alleged unsatisfactory service furnished by those in charge of the ferry plying between Sheepshead Bay and Rockaway Point, I beg to quote you below letter received from Messrs. G. T. Charlton and J. L. Crone, Local Inspectors, Department of Commerce, Steamboat Inspection Service, received in answer to this department's inquiry of August 28th requesting that an investigation be instituted regarding this matter:


"This office is in receipt of your letter of August 28th enclosing copy of letter received from the Mayor's office which you state complains of overcrowding conditions prevailing on the ferry-boats plying between Sheepshead Bay and Rockaway Point. We find on investigation that the complaint concerns boats between Canarsie and Rockaway Point belonging to people named McAvoy, on Sunday, August 10th.

You are informed that three inspectors from this office were stationed at Canarsie to note the

passengers carried by the steamers NAIAD and FRANK & HELEN McAVOY, which are probably the vessels referred to in the complaint. Neither of the vessels carried a greater number of passengers than is allowed by the certificate of inspection and both vessels have been recently reinspected by this office and found to be in seaworthy condition and fully equipped.

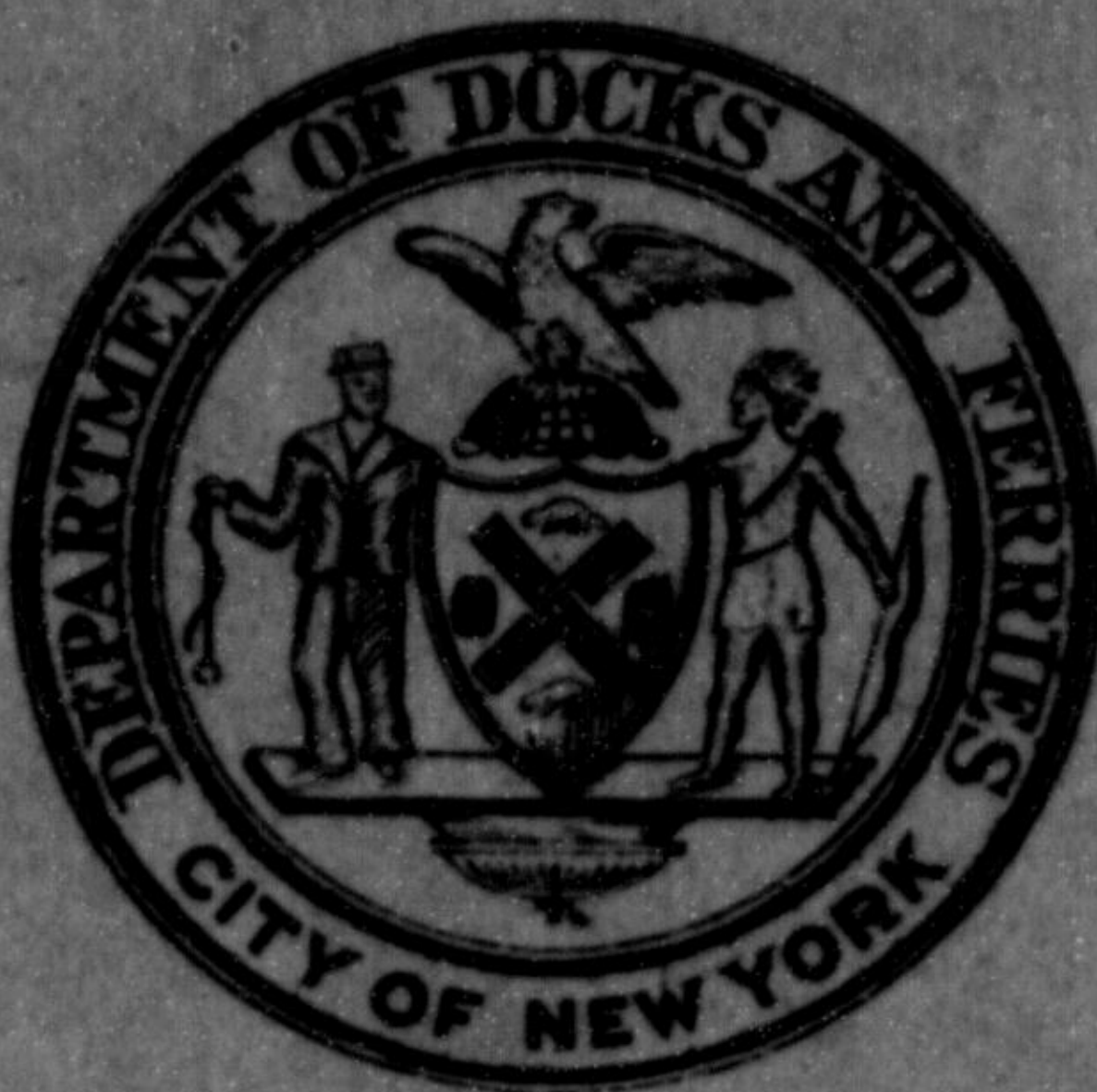
The matter complained of seems to be in the nature of disorder on the dock or landing and would seem to be under police jurisdiction. No report of anything unusual has been received by this office."

Sir:-

On July 26, 1913, Frank B. Walsh, a Machinist in this Department, was at work removing brackets and gearing from a metal shutter at the St. George terminal of the Staten Island Ferry. The shutter slipped from its gearing and fell, striking and breaking Walsh's right arm. He was removed to St. Vincent's Hospital at New Brighton for treatment and is still unable to report for duty.

Full pay has been allowed to Walsh for the period of his absence beginning July 27th and continuing up to and including August 25th, 1913, thirty days.

His right arm is still in a plaster cast and it will be some time before he is able to return to duty.

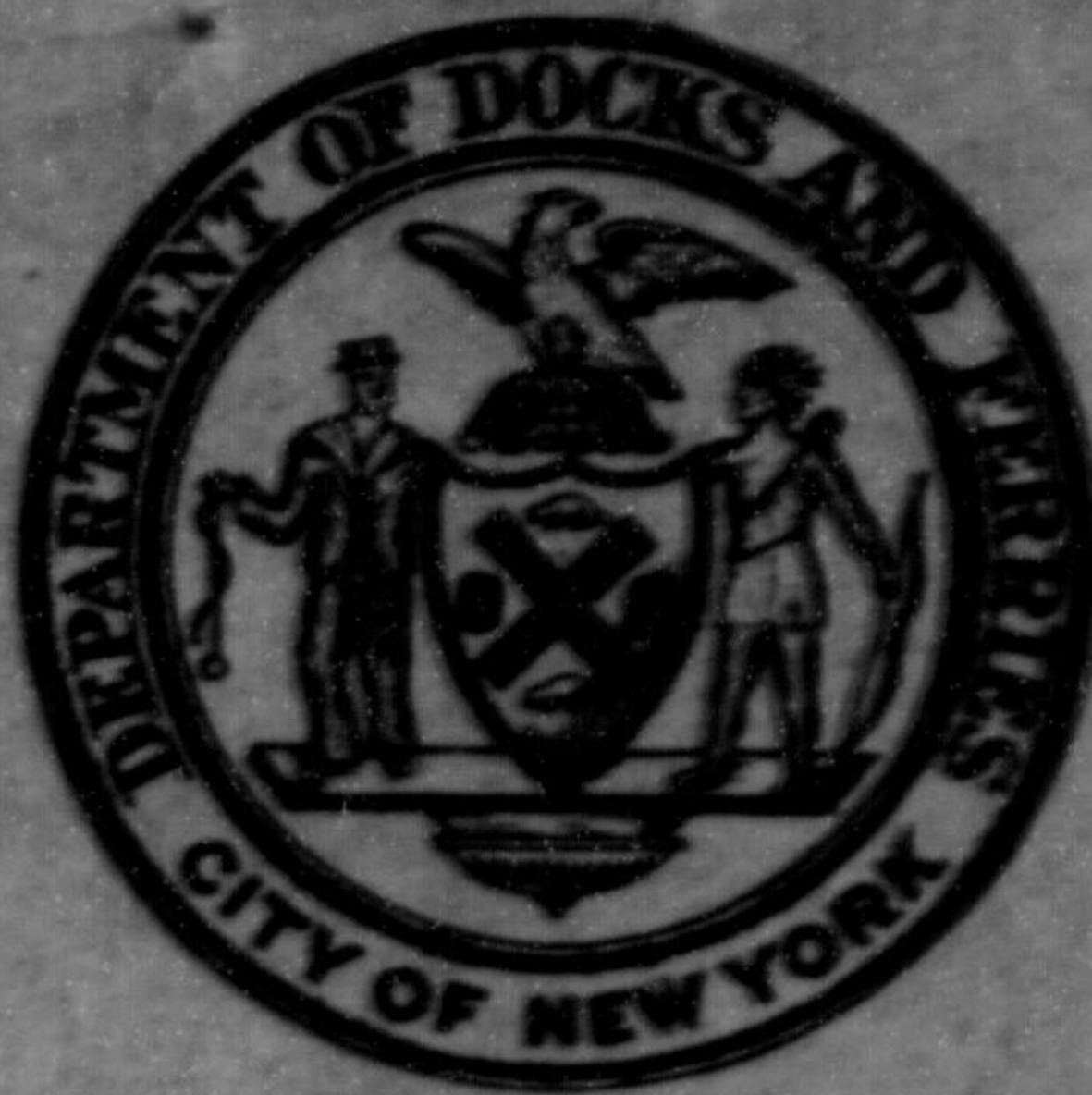
I request your approval for an allowance of full pay to Walsh for an additional period not to exceed thirty days beginning August 26th, 1913.

Sir:-

In August of last year it was reported to the former Commissioner of Docks that Frederick Stolzenhale, a Dock Builder, assigned to work at the St. George Ferry Terminal on August 16, 1912, absented himself from duty without leave for about three-quarters of an hour, from about 11:15 A.M. to noon. Before action was taken on the said charges, Mr Stolzenhale was given an examination before the then Second Deputy Commissioner. Subsequently Frederick Stolzenhale was discharged from the position of Dock Builder on September 5, 1912.

Mr Stolzenhale now submits two affidavits; in one affidavit he waives all claim for back pay; in the second affidavit he states he left the work with permission from the foreman of the gang in which he was employed, that he did not know he would have been permitted to call witnesses at the examination in his behalf, and that his failure to submit full explanation at the time of the hearing was due to the mental strain under which he was laboring. He also submits an affidavit from the foreman to the effect that permission was granted to him to leave the work.


Frederick Stolzenhaler was a very good Dock Builder, and I am given to understand that since his dismissal from the City's service he has been continuously employed by the private concern with which he was employed prior to his entering the service of the City and his conduct has been exemplary.

The Chief Engineer, to whom the application for reinstatement was referred, states it seems to him clear that owing to ignorance Stolzenhaler failed to state in detail the full facts which, had they been brought out at the hearing, would have resulted in much less drastic punishment.

Mr Stolzenhaler seeks reinstatement under the provisions of Section 1543-B of the Charter.

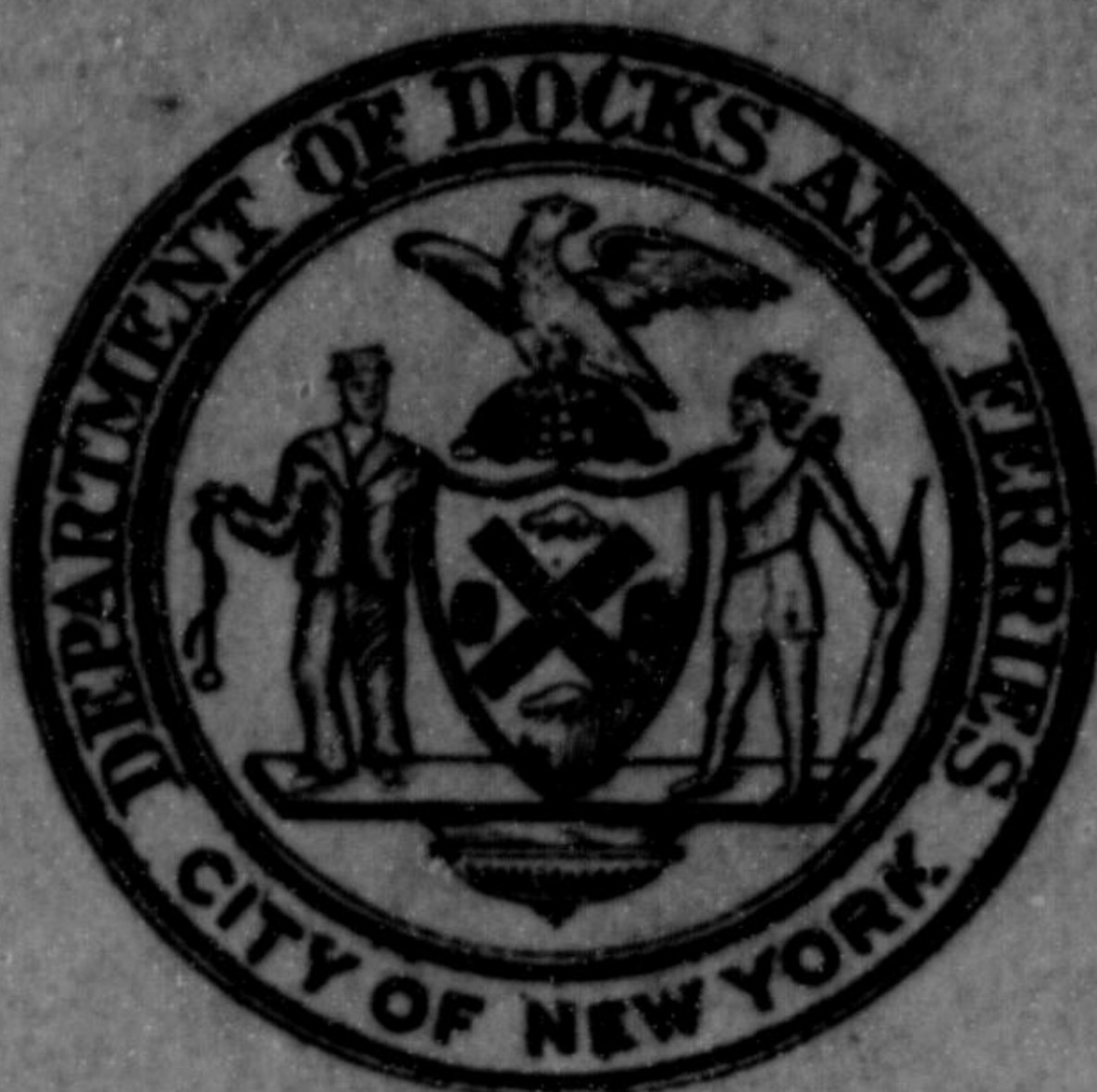
After due consideration of all the facts in this case, I request your consent, pursuant to the provisions of the said Charter section, to take up and consider the matter of the reinstatement of Frederick Stolzenhaler as Dock Builder.

At a meeting of the Commissioners of the Sinking Fund held July 17, 1913, a resolution was adopted approving of and consenting to the execution by the Commissioner of Docks of a lease to the Delaware, Lackawanna & Western Railroad Company of an extension to Pier new 41, North River, at an annual rental of 27-1/2 cents per square foot for the area of land under water covered by said extension, and, in addition, 5-1/2% of the cost of construction of said extension, said area and cost to be as shown by the surveys and books of this Department.

The Company has requested this Department to fix a definite limit to the cost of extending the pier upon which the rental of 5-1/2% is to be paid, but this Department is unable ~~to~~ and has declined to do. The Company has received an offer from a private contracting concern, and now requests that the resolution of the Commissioners of the Sinking Fund be amended so as to permit the Company to build the extension at its own expense.

I can see no objection to this and therefore beg to recommend that the aforesaid resolution of the Commissioners of the Sinking Fund of July 17, 1913 be amended so as to provide that the company shall build, or cause to be built, at its own expense upon the land under water described in the resolution of July 17, 1913 an extension to said Pier new 41, North River, and that the charge of 5-1/2% of the cost of construction of said extension be eliminated.

I beg to recommend that a resolution be adopted by the Commissioners of the Sinking Fund approving and consenting to the execution by the Commissioner of Docks of a lease to the Ocean Steamship Company of Savannah, a corporation organized under the laws of the State of Georgia, of an extension to Pier New 35, North River, Borough of Manhattan, City of New York, upon land under water described as follows:

Beginning at a point in the southerly side of present Pier New 35, at the outer end of same; running thence westerly and along the westerly prolongation of the southerly side of said pier, a distance of 173.44 to the pierhead line modified by the Secretary of War March 1, 1913; running thence northerly and along said pierhead line to the westerly prolongation of the northerly side of said pier; running thence easterly and along the westerly prolongation of the northerly side of said pier to the outer end of said pier; running thence southerly and along its outer end to the point or place of beginning.

The Department shall build or cause to be built at the expense of the City of New York, upon the land under water described above, the extension to Pier New 35, North River. The lease of said extension shall commence on the date the Chief Engineer of this Department shall certify that said extension is completed, and shall be for a period coterminous with the existing lease of said pier, dated January 31, 1913, the term of which began May 1, 1913 and expires May 1, 1923.

The lessee shall have the right to erect upon said extension and to maintain thereon during the term of the lease, a shed which shall be built in accordance with plans and specifications to be submitted to and approved by the Chief Engineer of this Department. The extension to said pier and the shed to be erected thereon shall revert to and become the property of the City of New York at the expiration or sooner termination of the lease.

The lease shall provide that the lessee shall at all times during the term thereof keep and maintain all sheds or other structures erected or to be erected under the provisions of said lease in good condition and repair to the satisfaction of the Commissioner of Docks.

The annual rental shall be at the rate of $27-1/2$ ¢ per square foot for the area of land under water covered by said extension, and in addition, $5-1/2$ ¢ on the cost of construction thereof, said area and cost to be as shown by the surveys and books of this Department.

The remaining terms and conditions of the lease, except insofar as they are inconsistent herewith, shall be similar to those contained in leases of wharf property now used by this Department.

It is understood and agreed that this lease shall be of no force or effect unless the surety on the lease of the existing pier shall file in this Department its written agreement that its obligations under the provisions of said lease shall in no manner be affected or impaired by reason of the extension to said pier.

I beg to recommend that a resolution be adopted by the Commissioners of the Sinking Fund approving of and consenting to the execution by the Commissioner of Docks of a lease to the Baltimore & Ohio Railroad Company, of an extension to Pier New 22, North River, Borough of Manhattan, City of New York, upon land under water, described as follows:-

Beginning at a point in the southerly side of Pier New 22, North River, at the outer end of same; running thence westerly and along the westerly prolongation of the southerly side of said pier a distance of 120.28 feet to the pierhead line modified by the Secretary of War, March 1, 1913; running thence northerly and along the said modified pierhead line to the westerly prolongation of the northerly side of said pier; running thence easterly along the westerly prolongation of the northerly side of said pier to a point in the outer end of said pier; running thence southerly along the outer end of the present pier to the point or place of beginning.

The Department shall build or cause to be built at the expense of The City of New York, upon the land under water above described, the extension to Pier New 22, North River. The lease of said extension shall commence on the date the Chief Engineer of this Department shall certify that said extension is completed. The lease shall expire September 1, 1914.

The annual rental to September 1, 1914, shall be at the rate of 27-1/2¢ per square foot for the area of land under water covered by said extension, and, in addition, 5-1/2¢ of the cost of construction thereof; said area and cost to be as shown by surveys and books of this Department.

The lessee shall have the right to erect upon said extension and to maintain thereon during the term of the lease a shed which shall be built in accordance with plans and specifications to be submitted to and approved by the Chief Engineer of this Department. The extension to said pier and the shed to be erected thereon, shall revert to and become the property of The City of New York at the expiration or sooner termination of the lease. The lease shall provide that the lessee shall at all times during the term thereof, keep and maintain the said extension and all sheds or other structures erected or to be erected under the provisions of said lease, in good condition and repair to the satisfaction of the Commissioner of Docks.

The remaining terms and conditions of the lease, excepting so far as they are inconsistent herewith, shall be similar to those contained in the present lease of Pier New 22, North River.

Beginning at a point in the southerly side of Pier new No. 20 at its outer end as it now exists; running thence westerly and along the westerly prolongation of the southerly side of said pier to the pierhead line modified by the Secretary of War, March 1, 1913, a distance of 108.38 feet; running thence northerly and along said modified pierhead line to the westerly prolongation of the northerly side of said pier; running thence easterly and along the westerly prolongation of the northerly side of said pier to a point in the outer end of said pier; running thence southerly and along the outer end of said pier to the point or place of beginning.

Beginning at a point in the southerly side of Pier New No. 21 at its outer end as it now exists; running thence westerly along the westerly prolongation of the southerly side of said pier to the pierhead line modified by the Secretary of War, March 1/1913, a distance of 116.99 feet; running thence northerly and along said modified pierhead line to the westerly prolongation of the northerly side of said pier; running thence easterly and along the westerly prolongation of the northerly side of said pier to a point in the outer end of said pier; running thence southerly and along the outer end of said pier to the point or place of beginning.

The Department shall build or cause to be built at the expense of The City of New York, on the lands under water above described, the extensions to said Piers new 20 and 21, North River. The lease of said extensions shall commence on the date the Chief Engineer of this Department shall certify that said extensions, respectively are completed.

The lease shall expire May 1/1923, at an annual rental of 27-1/2¢ per square foot for the area of land under water covered by said extensions, and, in addition, 5-1/2¢ of the cost of said extensions, said area and costs to be as shown by the surveys and books of the Department of Docks and Ferries.

The lessee shall have the right to erect upon said extensions, and to maintain thereon during the term of the lease, sheds which shall be built in accordance with plans and specifications to be submitted to and approved by the Chief Engineer of the Department of Docks and Ferries; said sheds shall revert to and become the property of The City of New York at the expiration or sooner termination of the lease.

The lease shall provide that the lessee, shall at all times during the term thereof, keep and maintain all sheds or other structures erected or to be erected under the provisions of said lease in good condition and repair to the satisfaction of the Commissioner of Docks.

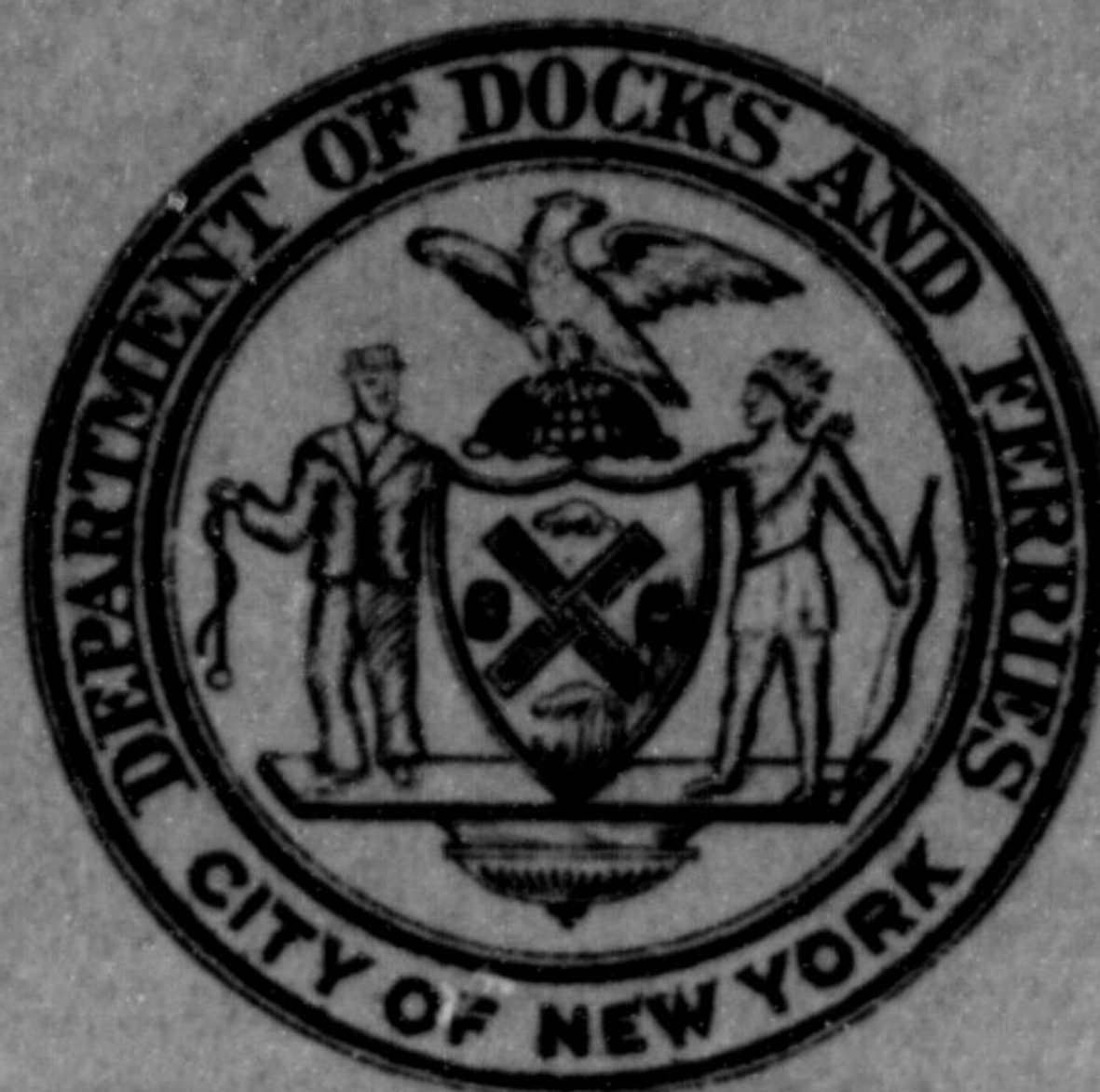

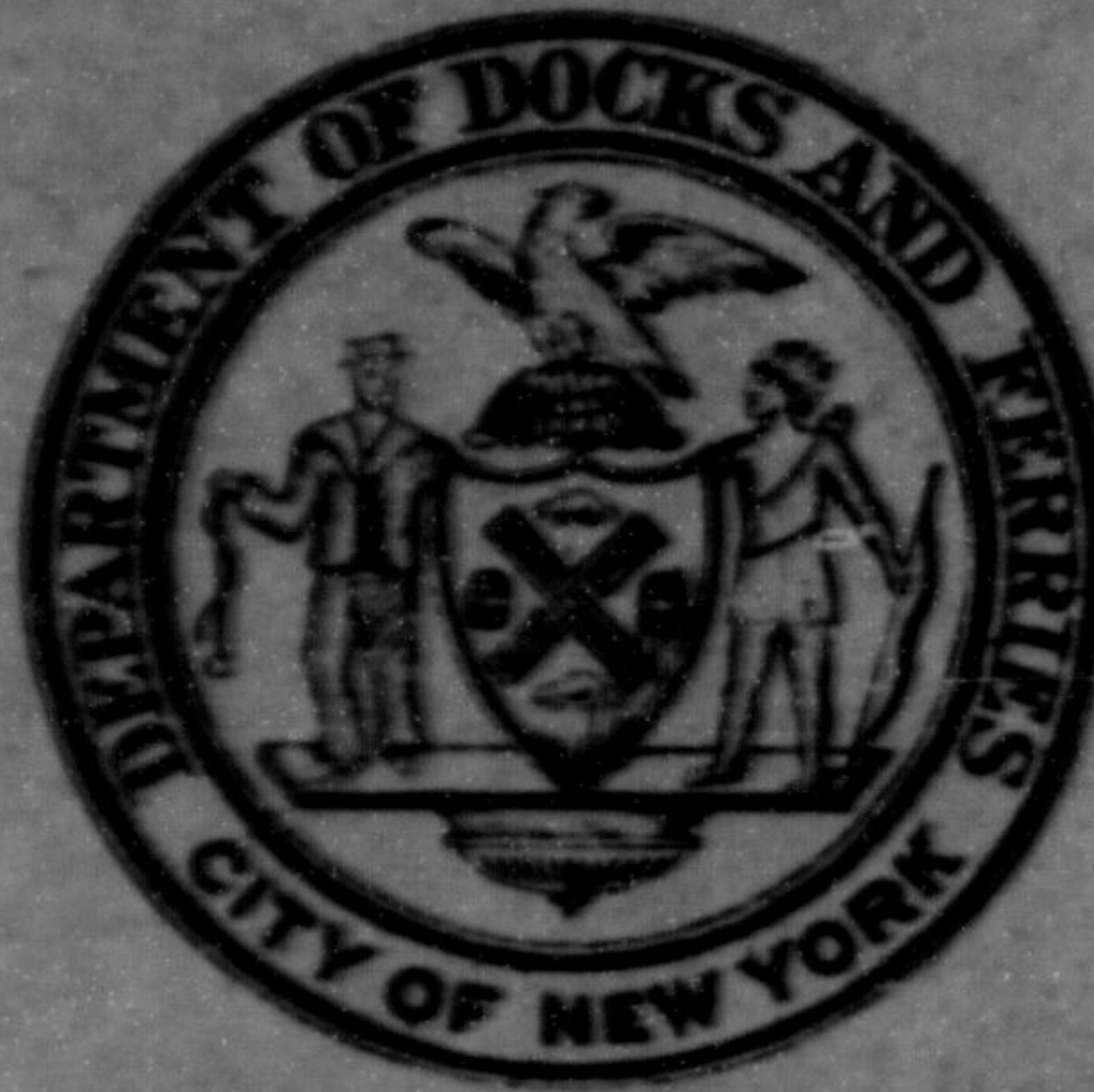

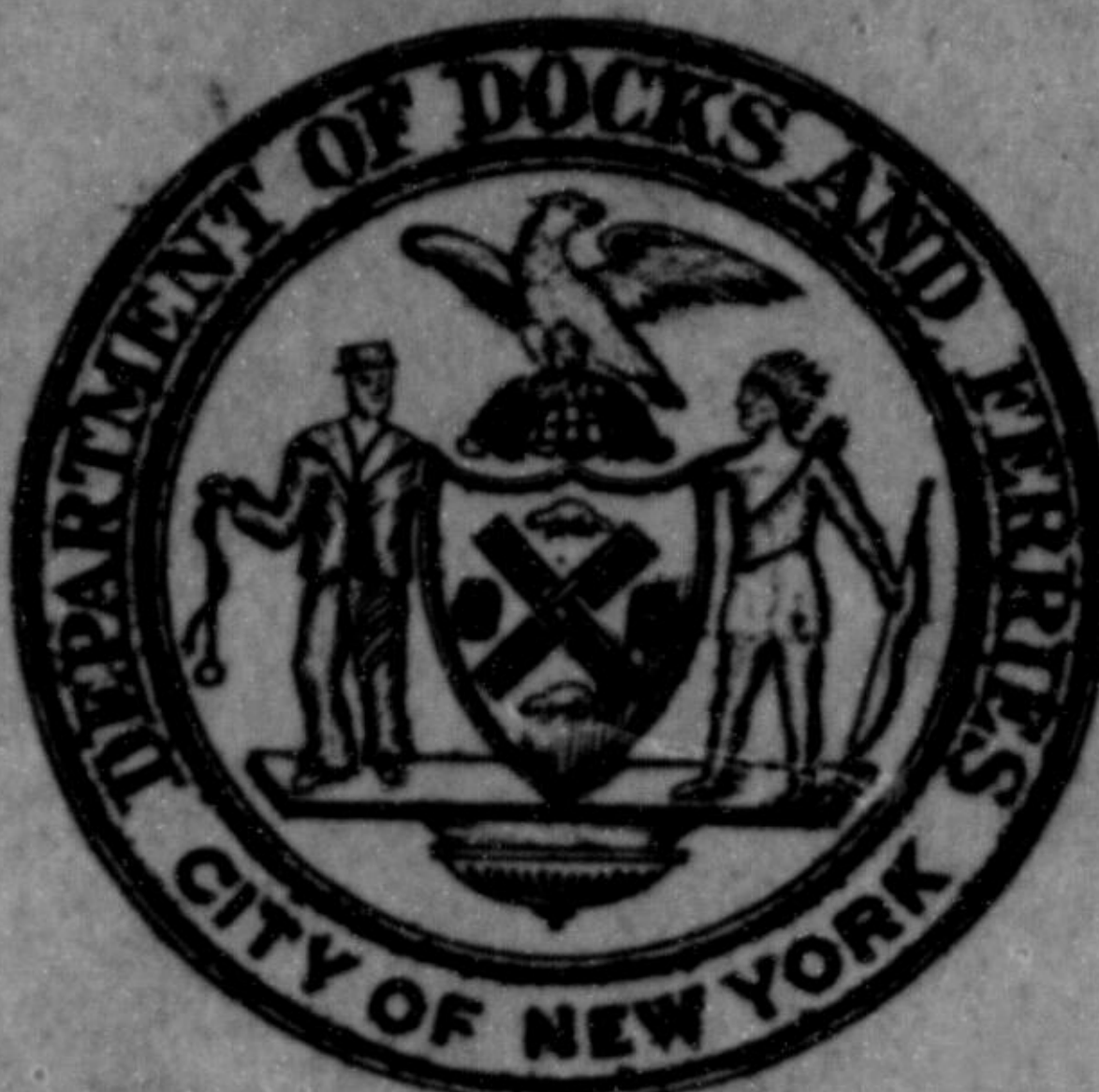

Sir:-

I transmit herewith plans, specifications and form of Contract 1382, for removing the present piers Old Nos. 27 and 28, East River, for dredging at the location, and for building a new pier at the foot of Dover street to be known as Pier No. 21, East River, Borough of Manhattan, and for depositing rip-rap thereat. This contract is proposed to be awarded in two sections.

One section will cover Class 1, for removing the existing piers and for the necessary dredging at the location. This work is estimated at \$27,000.

The second section will embrace Classes 2 and 3, for the construction of the new pier and the furnishing and depositing of the necessary rip-rap at the outer end of such new pier. The estimate on this second section is \$65,500.

Section 1 of the contract is to be a charge against Corporate Stock Funds C.D.D. 35 "Removing Old Piers 27 and 28, East River."

Section 2 of the contract will be a charge against Corporate Stock Funds C.D.D. 9 B "Construction of Pier No. 21, at Dover street, East River."

I request your approval of the plans, specifications, form of contract and estimates as above.

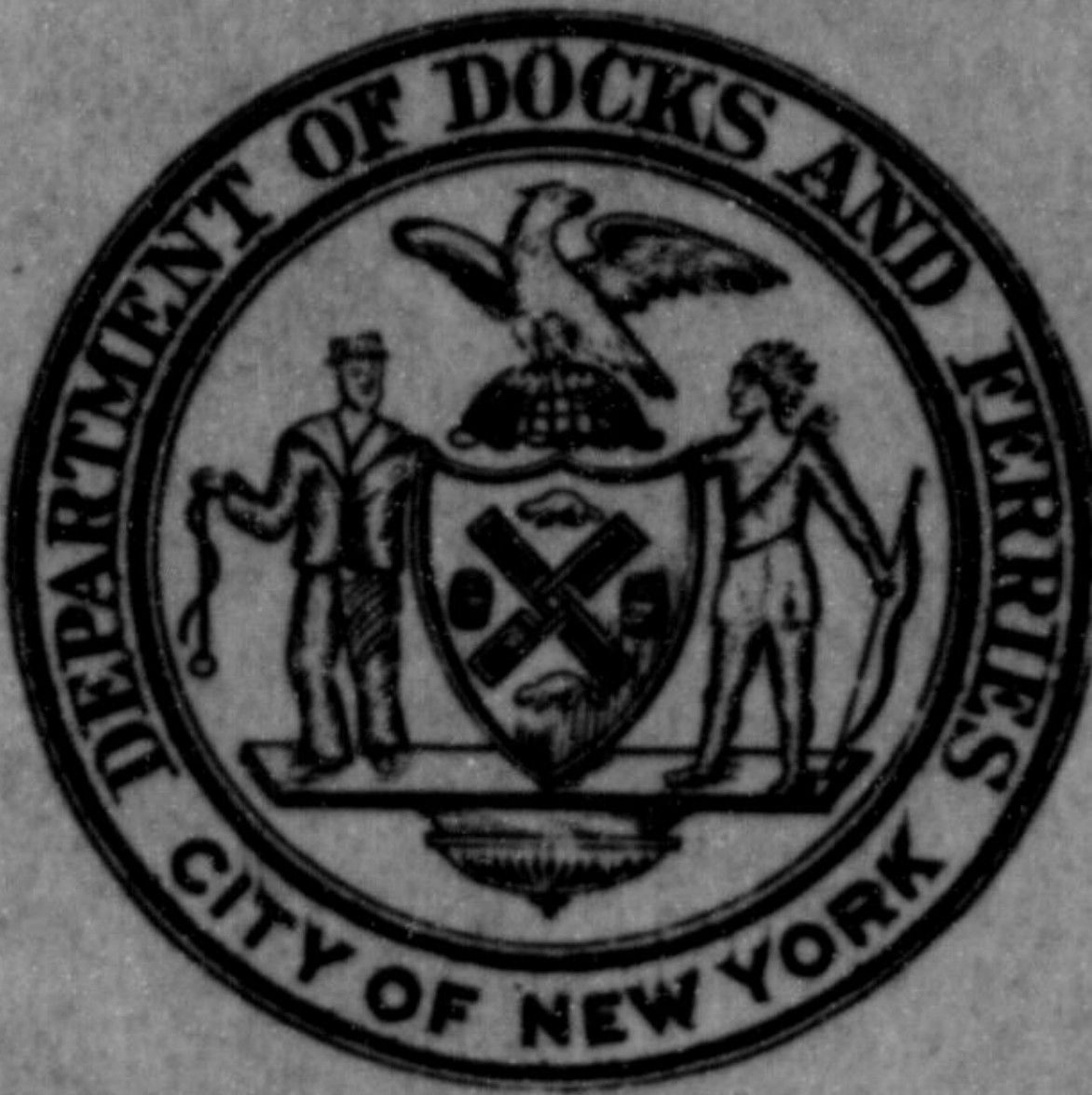

The Consolidated Gas Company has since vacated the structures which it occupied.

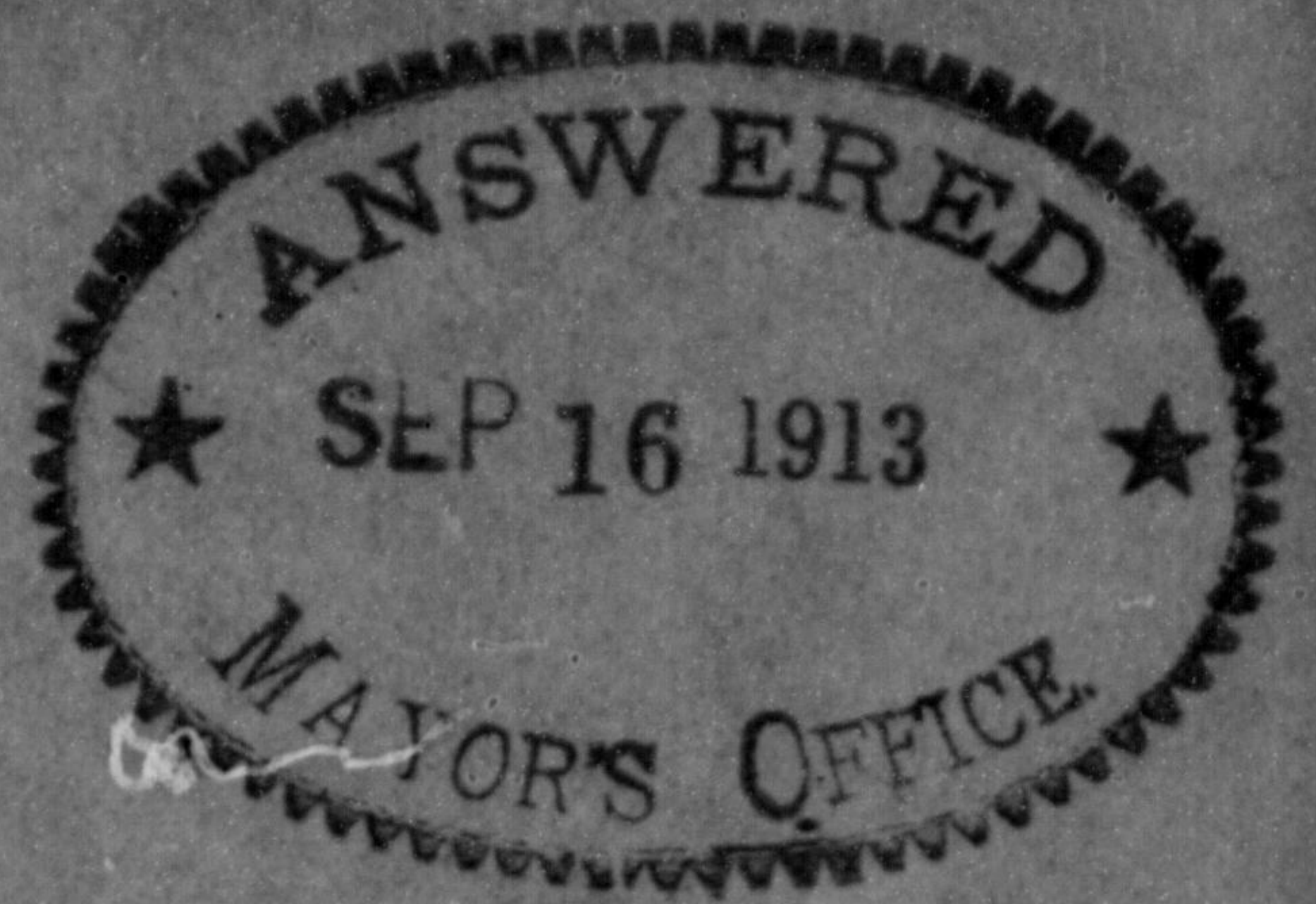
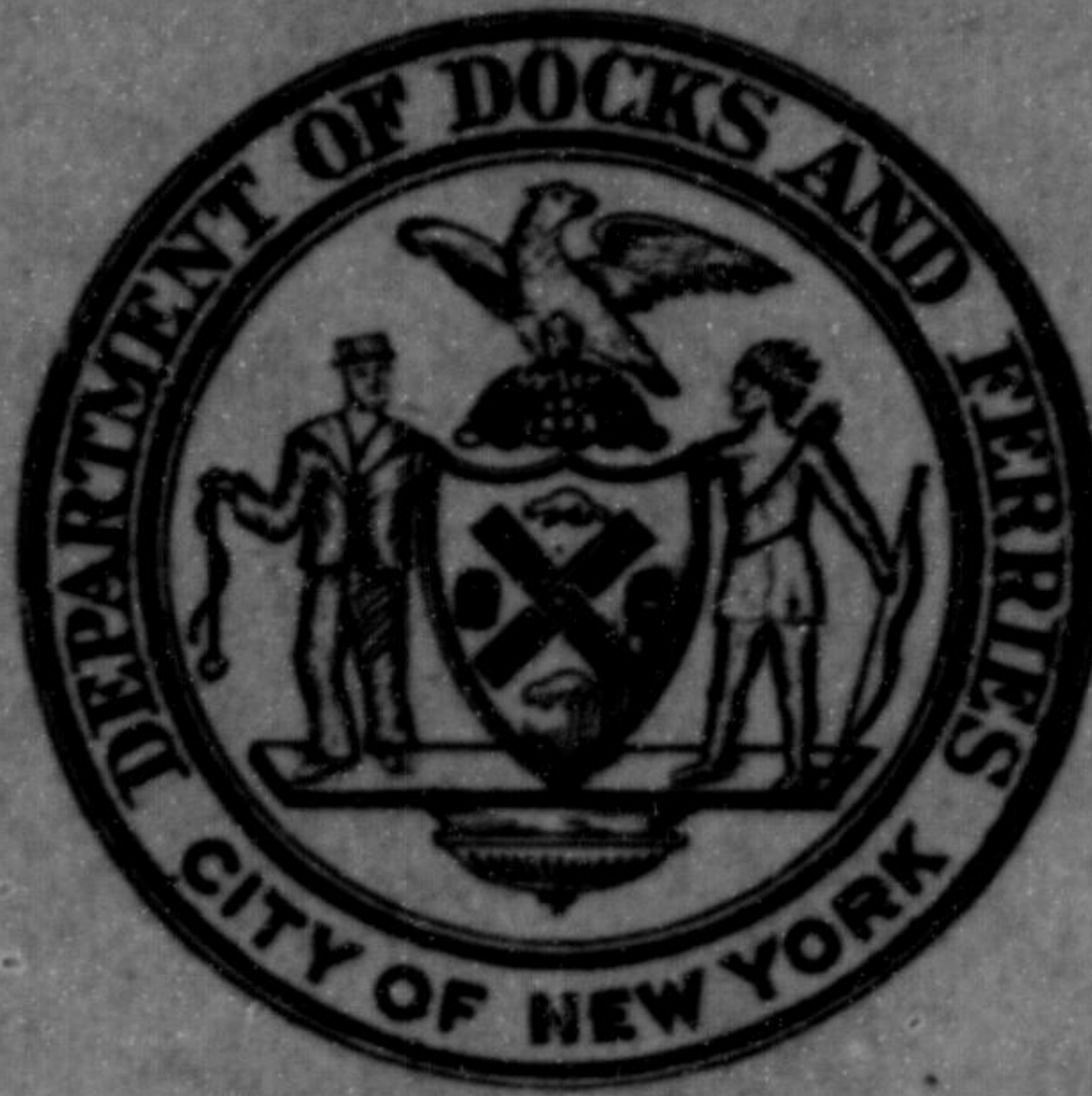

Sir:-

As a citizen interested in all that concerns the welfare of New York City, I am profoundly impressed with the loss we have sustained in the untimely death of Mr. Gaynor. As an individual admirer of the man and the recipient of many confidentially expressed thoughts, I am more than grieved by the loss.

After conferences with him, which began early in his administration, I always left him with the conviction that he had no other thoughts than those directed to the solution of the problems attending the hugeness of the administration of the City for which he was as ambitious as any man I know.

When he thought it necessary to ask me to take the place I now occupy as a City official, he gave me little opportunity to show my reluctance to do so by saying, "If men who are capable of doing the things to be done will not take the responsibility, how can they expect anything better. I am only one man even though I am Mayor".

He meant to do the things that must be done now if the City is to hold its commercial prestige, and there has been a recompense for loss in personal matters while doing this work in the knowledge that I was helping a man who was doing in a large way what was so necessary and requiring patience and force to convince the citizens that the supremacy of New York lies in its ability to care for all the trade that may be brought to its doors.

Mayor Gaynor made great progress in Port improvement and expected to do much more, and would not listen to any break in the continuity of it. He gave personal attention to the work which has reached a stage where it should not be permitted to lag. However, I herewith tender you, to take effect at your convenience, my resignation as Commissioner of Docks and Ferries.

Let me assure you that the only thought that inspires this is consideration, that you may be quite free so far as this Department is concerned, to plan your administration on your own lines.

Let me also assure you that in any event you will have my entire support so far as I am able to give it to you, and I want you to know that you have my earnest wishes for success in meeting the exactions of your high office.
