



In the name of the National Consumers' League I beg to be placed on record in favor of the creation of a Mayor's Commission on Congestion of the Population.

After ten years of effort to protect the shopping public from the dangers and the evils incidental to the sweating system, the National Consumers' League has become convinced that thorough-going measures must be taken promptly, particularly with a view to preventing the spread in other boroughs of preventable evils from which Manhattan has long suffered.
