As requested, I transmit herewith report on the following resolutions, passed by the Board of Aldermen and now awaiting your action:

✓ No 957. To pave Pleasant Avenue, from East 114th to East 115th Street, with asphalt.

✓ No 958. To pave with asphalt 22nd Street, from 6th to 8th Avenue.

✓ No 980. To repave 71st Street, from Central Park West to the Boulevard, with asphalt.

X ✓ No 981. To repave 32nd Street, from 1st to Madison Avenue, and 30th Street, from 4th to 1st Avenue, with asphalt.

All these improvements are necessary, except the repaving of 32nd Street, from 1st to Madison Avenue, provided for in resolution No 981, which work has already been authorized and a contract entered into.

✓ No 978. To repave 62nd Street, from 2nd to Madison Avenue, with asphalt.

✓ No 959. To pave 22nd Street, from 10th to 11th Avenue, within land grants, with asphalt.

The improvements provided for in these two resolutions are necessary, and it is recommended that they be approved.

✓ No 985. To permit M. C. Spencer and Co. to lay a crosswalk from Nos 144 and 146 West 125th Street to the opposite curb.

There is no objection to this resolution, as the

crosswalk will be laid at the expense of the applicants therefor, and under the direction of this Department.

✓ No 990. To permit Julius Dolgner to erect an iron awning at No 277 Avenue A.

There is no objection to this resolution. The awning will be in accordance with the ordinance passed by the Common Council in April, 1886.

✓ No 930. To regulate, grade, etc., Isham Street, from Kingsbridge Road to 10th Avenue.

✓ No 956. To fence vacant lots south side of 98th Street, 100 feet east of 2nd Avenue.

✓ No 982. To flag, etc., the south side of 91st Street, between Amsterdam and West End Avenues.

✓ No 983. To flag, etc., south side of 80th Street, between the Boulevard and West End Avenue, etc.

The regulating and grading, fencing and flagging provided for in these resolutions are necessary. It is recommended that the resolutions be approved.

✓ No 931. To lay water-mains in 164th Street, from Amsterdam Avenue to Edgecombe Road.

✓ No 940. To lay water-mains in Teller Avenue, between 162nd Street and 164th Street.

✓ No 942. To lay water-mains in Decatur Avenue, from Brookline Street to Isaac Street.

✓ No 944. To lay water-mains in West 94th Street, between West End Avenue and Riverside Drive.

✓ No 945. To lay water-mains in Pelham Avenue, from Washington Avenue to the Southern Boulevard.

✓ No 948. To lay water-mains in Crotona (Franklin) Avenue, between 175th Street and Tremont Avenue.

✓ No 949. To lay water-mains in Valentine Avenue, between the Southern Boulevard and Garfield Street.

✓ No 950. To lay water-mains in Anthony Avenue, from Burnside Avenue to a point 300 feet north.

✓ No 951. To lay water-mains in 109th Street, between the Boulevard and Riverside Drive.

✓ No 952. To lay water-mains in Giles Place, between Boston Avenue and Sedgwick Avenue.

✓ No 953. To lay water-mains in Taylor Avenue, between Kingsbridge Road and 187th Street.

✓ No 944. To lay water-mains in Wadsworth Street, between Jerome Avenue and Hampden Street.

The water-mains provided for in the twelve preceding resolutions are necessary, and it is recommended that the resolutions be approved.

✓ No 932. To erect and light three lamps in front of Grammar School No 75, in Norfolk Street.

✓ No 933. To lay gas-mains, etc., in Fulton Avenue, from Pelham Avenue to a point 250 feet north.

✓ No 936. To lay gas-mains, etc., on the east side of Park Avenue, from 97th to 99th Street.

✓ No 960. For two additional lamp-posts and lamps in front of St. Celia Church Parish School, 218 and 224 East 106th Street.

✓ No 961. For gas mains and lamps in 111th Street, from 8th to Manhattan Avenue.

✓ No 962. To light 109th Street, from Central Park West to Columbus Avenue, etc.

✓ No 964. For gas mains and lamps in Riverview Terrace, from Powell Place to Cedar Avenue.

✓ No 968. For gas mains and public lamps in Eastburn Avenue, from Walnut Street to 173rd Street.

✓ No 970. For gas mains and public lamps in Anthony Avenue to a point about 300 feet north from Burnside Avenue.

✓ No 972. For lamps in Union Avenue, from 149th to 152nd Street.

✓ No 973. For gas-mains and lamps in Hoe Avenue, between Jennings Street and Cooke Place.

✓ No 974. For gas-mains and lamps in Locust Avenue, from 132nd to 138th Street.

✓ No 975. For gas mains and lamps in 134th Street, etc.

✓ No 977. To light 135th Street, from the Southern Boulevard to the tracks of the Newhaven Railroad.

The gas mains and lamps provided for in these 14 resolutions are necessary. It is recommended that the resolutions be approved.

✓ No 984. To permit James Linden to keep an ornamental lamp-post and lamp in front of No 169 Amsterdam Avenue.

No 988. To permit Francis J. McNamara Association to place transparencies on unused lamp-posts, etc.

No 994. To permit Leon Flouret to keep an ornamental lamp-post and lamp in front of Nos 126 and 128 5th Avenue.

These three resolutions for ornamental lamp-posts and transparencies are unobjectionable, and their approval is recommended.

No 992. To permit Thomas J. Brennan to keep a watering-trough on the sidewalk at 1550 Madison Avenue.

This resolution should be amended to provide for an iron watering-trough.

No 995. To permit the American Art Association to erect a canopy at the entrance to their public Art Galleries.

The ordinance of 1886 does not provide for the erection of canopies, but permits the erection and maintenance of iron awnings across sidewalks, supported at the curb. The resolution does not specify whether the supports are to be placed on the sidewalk or not. It would be illegal to place the supports on the sidewalk, but if it is intended to place them at the curb, there is no objection to the resolution.

No 991. To permit the Hebrew Institute to keep a sign board in front of their premises.

This resolution is opposed on the ground that a bulletin board of the character described in the resolution, placed on the sidewalk, would constitute an illegal obstruction.

No 941. To lay water-mains in Cambreling Avenue, from Pelham Avenue to 187th Street, etc.

No 943. To lay water-mains in Anthony Avenue, between 173rd and 174th Street.

No 946. To lay water-mains in Franklin Avenue, from East 175th Street to Crotona Park North.

X ✓ No 947. To lay water-mains in East 173rd Street, from Eastburn Avenue to Jerome Avenue.

X ✓ No 955. To lay water-mains in Dawson Street, from Westchester Avenue to Leggett Avenue.

These five resolutions for water-mains are opposed on the ground that the avenues and streets named in the resolutions are not regulated and graded. They should be regulated and graded before water-mains are laid.

X ✓ No 934. To lay gas-mains in Giles Place, between Boston and Sedgwick Avenues.

X ✓ No 935. For gas-mains and lamps in St. John's Avenue, from Pelham Avenue to Crescent Avenue

X ✓ No 963. For gas-mains, etc., in 185th Street, between Washington and Vanderbilt Avenues.

X ✓ No 965. For gas-mains, etc., in West Street, from the Southern Boulevard to 1st Street.

X ✓ No 967. For gas-mains, etc., in 183rd Street, between Valentine and Jerome Avenues.

X ✓ No 971. For gas-mains, etc., in 181st Street, from Prospect Avenue to Clinton Avenue.

X ✓ No 976. For gas-mains, etc., in Dawson Street, from Westchester Avenue to Leggett Avenue.

These seven resolutions for gas-mains, etc., are objected to because the streets are not regulated and graded. The regulating and grading should be done before gas-mains are laid.

X ✓ No 966. For two lamp-posts and lamps in front of Morris Heights M. E. Church.

X ✓ No 969. To place lamps on the two lamp-posts on Washington Avenue, near 176th Street.

The lamps provided for in these two resolutions have already been placed and lighted. The resolutions are therefore unnecessary.

X ✓ No 993. To permit the Young Men's Christian Association to place transparencies on lamp-posts.

This resolution is objectionable inasmuch as it

does not specify the time during which the transparencies shall remain in place. It should be amended to fix the time at two weeks, or not to exceed 30 days.

No 14. To permit John McGinnis to keep a watering-trough at No 205 Greenwich Street.

There is no objection to this resolution.

This resolution is objected to on the ground that signs on the public sidewalks are illegal.

No 15. To permit Nichola Galgano to place and keep a barber's pole in front of No 260-1/2 Bowery.

No 5. To regulate, grade, etc., 111th Street, from the Boulevard to Riverside Drive.

This resolution is defective inasmuch as it makes no provision for grading the sidewalks. It should be amended to read:

"That 111th Street, from the Boulevard to Riverside Drive, be regulated and graded, the curb stones set and sidewalks flagged a space four feet wide through the centre thereof."

✓ No 34. To regulate and grade 180th Street, from Amsterdam Avenue to Kingsbridge Road.

This improvement is necessary, and it is recommended that the resolution be approved.

✓ No 37. For water-mains in 168th Street, from 3rd Avenue to Boston Road.

✓ No 36. For water-mains in Briggs Avenue, from the Southern Boulevard to Garfield Street, etc.

✓ No 39. For water-mains in Locust Avenue, from 132nd to 138th Street.

✓ No 40. For water-mains in 134th Street, from the Southern Boulevard to a line 270 feet east of Locust Ave., etc.

✓ No 41. For water-mains in 112th Street, from Lenox to 7th Avenue.

The water-mains provided for in these five resolutions are necessary. It is recommended that the resolutions be approved.

✓ No 22. To erect two lamp-posts at the Chapel of the Church of Heavenly Rest, Nos 114 and 116 East 47th Street.

There is no objection to this resolution.

✓ No 32. To pave a part of a street with Australian wood pavement.

It is recommended that this resolution be approved

and that 20th Street, between Broadway and 5th Avenue, be selected to be paved.

✓ No 36. For water-mains in 111th Street, between the Boulevard and Riverside Drive.

The Chief Engineer reports that the street should be graded and a sewer constructed therein before water-mains are laid.

✓ No 38. For water-mains in Vanderbilt Avenue, between 158th and 168th Streets.

The Chief Engineer reports that water-mains have already been laid in that part of Vanderbilt Avenue which has been regulated and graded. The remainder should be regulated and graded before additional water-mains are laid.

✓ No 29. To permit Joseph P. McHugh and Co. to place and keep a lamp on the unused lamp-post at 42nd Street and 5th Avenue.

This resolution is objectionable inasmuch as it would permit the use of a City lamp-post for a private purpose, it being the evident intention of Messrs McHugh and Co. to use the lamp for advertising purposes.

✓ No 43. To pave Manhattan Avenue, from 106th to 110th Street, with asphalt blocks.

The Water Purveyor reports that it is desirable to pave Manhattan Avenue between 106th and 110th Street, but the resolution should be amended to except from the repaving that part of the avenue between the rail-tracks of the Metropolitan Traction Company (between 109th and 110th Streets) and to omit crosswalks except those of asphalt block because crosswalks of other material would be a detriment and would mar the appearance of the pavement.

✓ No 50. For two additional lamp-posts in front of the Home for Aged and Infirm Hebrews in 106th Street, between Columbus and Amsterdam Avenues.

✓ No 63. To permit Henry Emde to keep two ornamental lamp-posts and lamps in front of No 229 Grand Street.

✓ No 64. To permit Wilson and Co. to keep an ornamental lamp-post and lamp in front of No 152 East 23rd Street.

The Superintendent of Lamps and Gas reports that there is no objection to these resolutions. I recommend that they be approved.

✓ No 66. To permit Susie Kirwin to place and keep a carriage-step in front of No 253 West 22nd Street.

I recommend that this resolution be not approved because a stepping stone on the sidewalk, at the curb, would constitute a dangerous and illegal obstruction.

✓ No 68. To permit Edwin Evans to place and keep a sign at No 871 Park Avenue.

Signs of this description are illegal obstructions, and it is therefore recommended that the resolution be not approved.

✓ No 69. To permit Charles Harnishfeger to erect an iron awning in front of No 1031 Second Avenue.

The erection of awnings of this character is permitted

by the general Ordinance of May, 1886. The present resolution is therefore unnecessary.

No 67. To permit G. B. Seeley's Sons to lay a 6-inch iron pipe along West 15th Street, from No 311 to 319, for the purpose of conducting water from a private well at 319, as shown on the accompanying diagram, etc.

The Chief Engineer reports that it is not good policy to permit the laying of private pipes for water or steam in front of property not belonging to the applicants for the privilege, and that the consent of the owners of Nos 313, 315 and 317 should be obtained before granting the desired permission.

The Superintendent of Lamps and Gas reports that there is no objection to these resolutions, and I, therefore, recommend that they be approved.

No 154. To pave 98th Street, from Lexington to 3rd Avenue, with asphalt block pavement on concrete foundation. ✓

This improvement is necessary, and the Water Purveyor reports that asphalt block pavement on concrete foundation is probably the most acceptable pavement that could be laid there. It is recommended that the resolution be approved.

No 159. To lay a crosswalk across 137th Street, within the westerly sidewalk of 7th Avenue. ✓

This resolution is based on my certificate that a crosswalk is necessary. The resolution should be approved.

No 155. To pave 100th Street, between Madison and 4th Avenues, with granite blocks on concrete foundation, etc. ✓

The Water Purveyor reports that the grade of this part of 100th Street is not too steep for an asphalt pavement, the first cost of which would be less than that of a granite pavement on concrete foundation. The latter pavement would be maintained by the contractor only six months, while the former would be kept in repair for five years at the contract price. Under these circumstances, it appears that the interests of the property owners to be assessed for the cost of the improvement would be served by amending the resolution so that it shall provide for an asphalt pavement instead of a granite block pavement. I respectfully recommend that the resolution be amended accordingly.

✓ No 187. To lay gas-mains, etc., in Wendover Avenue, from 3rd Avenue to Webster Avenue, etc.

✓ No 188. To lay gas-mains in Bailey Avenue, from Kingsbridge Road to Sedgwick Avenue.

✓ No 189. To lay gas-mains, etc., in Bronx River Road, from Grand Avenue to McLean Avenue.

✓ No 194. To lay gas-mains, etc., in Mile Square Road, from 4th Street to City Line.

✓ No 195. To lay gas-mains, etc., in Columbine Avenue, from Jackson Avenue to Taylor Avenue.

The Superintendent of Lamps and Gas reports that there is no objection to either of these resolutions, and I recommend that they be approved.

✓ No 178. To lay water-mains in Vanderbilt Avenue West, between 158th and 168th Street.

✓ No 179. To lay water-mains in Union Avenue, from 149th Street to the Southern Boulevard.

The Chief Engineer reports that water-mains are necessary in these two avenues. It is recommended that the resolutions be approved.

✓ No 213. To repave 24th Street, from 5th to 10th Avenue, with asphalt on the present pavement.

I have certified to the Board of Aldermen that this improvement is necessary for "the safety, health and convenience of the public."

✓ No 172. To permit the Fountain Grove Vineyard Co. to use an unused lamp-post in front of No 58 Vesey Street.

The Superintendent of Lamps and Gas reports that it is the intention of the Fountain Grove Vineyard Co. to use the lamp-post referred to for advertising purposes. I, therefore, recommend that the resolution be not approved.

✓ No 180. To lay water-mains in Anthony Avenue, between 174th Street and Gray Street.

✓ No 181. To lay water-mains in Monroe Avenue, between Columbus Street and 187th Street.

✓ No 182. To lay water-mains in Spuyten Duyvil Road, from opposite Johnston's Foundry to the Spuyten Duyvil Station.

The Chief Engineer reports that the sections of Anthony and Monroe Avenues, and of Spuyten Duyvil Road, specified in the three preceding resolutions have not been regulated and graded, and should be regulated and

graded before water-mains are laid.

✓ No 200. To permit the erection of an improved drinking fountain at 161st Street and Sedgwick Avenue.

There is no objection to this resolution on the part of this Department, but as the location of the proposed drinking fountain is within the district over which the Commissioner of Street Improvements of the 23rd and 24th Wards has jurisdiction, it might be well to refer the resolution to Commissioner Haffen as a matter of courtesy.

✓ No 208. To pave 95th Street, from Madison to 5th Avenue, with trap block pavement on concrete foundation.

According to the minutes printed in **THE CITY RECORD**, the Board of Aldermen, at the meeting held December 30th ultimo, passed a resolution and ordinance (General Order No 207) to pave this street "with asphalt, on concrete foundation"; whereas the one received from your office, and herewith returned, provides for "trap block pavement, on concrete foundation". I am unable to account for the difference. An asphalt pavement is necessary, and I report in favor of the resolution and ordinance as printed in **THE CITY RECORD**.

No 212. To fence vacant lots on the south side of 102nd Street, between West End Avenue and Riverside Drive.

No 217. To fence, etc., the south side of 80th Street, from the Boulevard to West End Avenue, etc.

The Consulting Engineer reports that it is necessary to fence these vacant lots, and it is recommended that the resolutions be approved.

No 215. For crosswalks on the north and south sides of 179th Street, across Audubon, 11th and Wadsworth Avenues.

The regulating and grading of 179th Street has only just been completed. The Water Purveyor reports that there is only one house on the street between these avenues. On 11th Avenue there is a new Macadam pavement, which affords good crossing and would be injured by placing crosswalks in it. There is no present need of crosswalks on the line of this street, as there is little occasion for foot-travel over it. For these reasons it is recommended that the resolution be not approved.

No 216. To lay crosswalks across Dyckman Street at its intersection with Kingsbridge Road, Prescott Avenue, B Street and C. Street.

A resolution and ordinance are now pending in the Board of Aldermen to reset the curb stones so as to narrow the roadway of Dyckman Street, and to pave it with asphalt. This improvement could be accomplished about as early in the coming season as the laying of crosswalks, and would make the latter unnecessary. An assessment for crosswalks would prohibit a subsequent assessment for asphalt pavement for the space occupied by the walks. I recommend the disapproval of the resolution and ordinance.

When this passage-way is made, over one-third of the street will be paved by the railroad company, thus saving the owners of abutting property more than one-third of the expense of the improvement.

✓ No 472. To lay water-mains in 124th Street, from Columbus to Amsterdam Avenue.

✓ No 470. To lay water-mains in Ryer Avenue, from Riverside Avenue to a point about 450 feet north.

✓ No 471. To lay water-mains in Dawson Street, from Prospect Avenue East to Leggett Avenue.

✓ No 468. To lay water-mains in 179th Street, between Amsterdam Avenue and Kingsbridge Road.

✓ No 467. To lay water-mains in 135th Street, from the Southern Boulevard to Locust Avenue.

The Chief Engineer reports that the water-mains called for in the six preceding resolutions are necessary. It is recommended that the resolutions be approved.

✓ No 466. To lay water-mains in Samuel Street, from Prospect Avenue to Mapes Avenue, and in Mapes Avenue to a point about 500 feet north.

Neither Samuel Street nor Mapes Avenue, between the points mentioned, is graded. The grading should be done before water-mains are laid.

✓ No <sup>457</sup>~~475~~. To permit George Hopper to replace a hitching post and stepping stone at No 1136 Tinton Avenue.

Stepping stones and hitching posts constitute the worst kind of obstructions on the sidewalks of this City, and numerous complaints are made against them by citizens. Hitching posts should in all cases be replaced with rings and staples fastened to the sidewalks at the curbs. These serve the same purpose as hitching-posts and are less objectionable and dangerous. It is recommended that the resolution be not approved.



As requested, I respectfully submit reports on the following resolutions, passed by the Board of Aldermen and now awaiting your action:

No 507. To lay water-mains in 10th Avenue, between 21st and 38th Streets, and in 29th Street, between 9th and 10th Avenues.

No 503. To lay water-mains in 136th and 137th Streets, between Willis and Brook Avenues.

No 502. To lay water-mains in 114th Street, between Western Boulevard and Riverside Drive.

The water-mains provided for in these three resolutions are necessary, and it is recommended that the resolutions be approved.

No 539. To pave 11th Avenue, from 20th to 27th Street, with asphalt, within land grants.

No 540. To pave 23rd Street, from 10th Avenue to the Hudson River, with granite blocks, within land grants.

No 533. To pave 21st Street, from 10th to 13th Avenue, with asphalt, within land grants.

No 537. To pave 22nd Street, from 11th to 13th Avenue, with asphalt, within land grants.

No 517. To pave 111th Street, between 5th and Lenox Avenue, with granite blocks.

No 523. To pave 111th Street, between 7th and Manhattan Avenues, with asphalt block pavement.

No 511. To pave 158th Street, from the Boulevard Lafayette to New York Central and Hudson River Railroad.

No 518. To pave 25th Street, from 10th to 13th

Avenue, with asphalt, within land grants.

The paving works provided for in these eight resolutions are necessary. It is recommended that the resolutions be approved.

No 510. To regulate, grade, etc., 139th Street, from 7th Avenue to the Harlem River.

No 525. To regulate, grade, etc., 182nd Street, from Amsterdam Avenue to Kingsbridge Road.

No 526. To regulate, grade, etc., Nagle Avenue, from Kingsbridge Road to 10th Avenue.

The City having acquired title to the streets named in the three preceding resolutions, and the improvements called for being necessary, it is recommended that the resolutions be approved.

No 519. To fence vacant lots on the north side of 102nd Street, between Amsterdam and Columbus Avenue.

It is necessary to fence these lots, as they are in the vicinity of dwelling houses, and dirt from the lots falls down on the sidewalks to the inconvenience of pedestrians. It is recommended that the resolution be approved.

No 506. For water-mains in Crotona Avenue, from Lebanon Street to Oakland Place.

Crotona Avenue is partly graded, but there is no water-main to connect with between Lebanon Street and Oakland Place. It is therefore recommended that the resolution be amended so as to read, "between Tremont Avenue and Oakland Place."

No 505. For water-mains in Bronx Terrace, between 12th and 14th Streets.

This location is in Wakefield, part of the newly annexed territory. The City has no water-mains within a mile of Bronx Terrace, and there is no appropriation

for obtaining water from other sources for the supply of this district. It is recommended that the resolution be not approved.

No 504. To lay water-mains in Sheridan Avenue, between 158th and 161st Streets.

Sheridan Avenue should be graded before water mains are laid. At present it is neither on line nor grade. It is recommended that the resolution be not approved.

No 544. Permitting Herman Bischoff to place an iron watering-trough at No 79 East 103rd Street.

This location is an inconvenient place for a drinking hydrant, and it is recommended that the resolution be not approved.

No 529. To place an improved iron drinking fountain on the east side of Macdougall Street, fifty feet north of Prince Street.

As there is a new asphalt pavement on Macdougall Street it is deemed inadvisable to tear it up for the purpose of placing a drinking fountain, particularly as there is a fountain on the corner of Varick and Spring Streets and another at Houston Street and West Broadway. It is recommended that the resolution be not approved.

No 512. To pave Hamilton Place, from the Boulevard to Amsterdam Avenue, with asphalt block pavement.

This resolution should be amended so as to provide that the pavement shall be laid on concrete foundation.

No 542. To permit the N. Y. Life Insurance Co. to extend a vault on Catherine Lane.

According to the accompanying diagram, it is intended to extend the vault to the centre of Catherine Lane. The resolution is opposed on the ground that the space to be occupied by the vault will hereafter be

required for water-mains, gas-mains, sewers and other sub-structures. It is recommended that the resolution be not approved.
