INTERVIEW OF ORBETT BEY

On May 3, 1965, at 7 PM, the assigned and Det. Confrey did meet by pre-arrangement one Orbett Bey at the Jerome Cafeteria, 161 St. and Jerome Ave. in the Bronx.

Subject stated that he had been talking to quite a few of his friends who are at present members of Mosque # 7, and had informed them of his intention to return to the Nation of Islam and was received enthusiastically. He also stated that the Mosque is in the process of setting up a new temple in the Bronx on Prospect Ave.. As of this date he has not made any formal application for membership to Capt. Joseph. Informant says that numerous Muslims appear dissatisfied with things that Capt. Joseph has done and are talking against him.

INTERVIEW OF O.B.

On May 11, 1965, the assigned and Det. Cavallaro, did meet with the above named person.

He stated that the person who is training the young kids in the 29 Pct. is one CLARENCE 13 X SMITH, E# 39300, AKA-PUDDING- this subject is a former Member of Mosque # 7. He left because of a disagreement over the religion. Has stated that he has the true religion. Meets these kids at night on 127 St. & 7th Ave.

Further states that DOROTHY 12X is the one that is married to the numbers man, first name " BOB" and she lives in the 241 St. area of the Bronx. He doesn't belong to the Mosque because of his business but is a heavy contributor. He contributes \$300. every year for Saviours Day.

BOSS identifies DOROTHY 12X STOKES, 835 Stebbins Ave., BX, residing there in August, 1960. No further information.
