

In re temporary approaches to bridge erected by the Long Island Railroad Company under an Order of the Public Service Commission, for the temporary elimination of the THOMSON AVENUE Grade Crossing of the Long Island Railroad tracks near Winfield, Borough of Queens.

Honorable Ardolph L. Kline,
Mayor and Chairman,

S I R:-

The approaches to the above described structure over the Long Island Railroad tracks have been built with grades of eight per cent (8%). This was done under specific orders of the Public Service Commission but against my advice and protest. Such grades are perhaps not too steep for ordinary automobile traffic but are excessive for horse drawn vehicles and heavy automobile trucks.

This bridge has been in use only three weeks but already several accidents have occurred on the approaches thereto which, though not serious in themselves, indicate clearly dangerous possibilities.

This condition could be improved by reconstructing the said approaches and increasing their length so as to obtain lighter gradients, adding considerably to the cost.

An alternative measure would be to grade and pave a detour by way of Hicks Avenue to the adjacent grade crossing at Laurel Hill Boulevard by which traffic unsuitable to pass over the steep grades of the bridge might conveniently be diverted from Thomson Avenue. This has been tentatively proposed to the Long Island Railroad Company who have replied that they are unwilling to contribute in any way towards the temporary grading and paving of such a diversion.

There are now no available City funds for such purpose. The Long Island Railroad Company has erected the bridge at its own expense but in the event of accidents to traffic passing over it the City might be held liable.

It is urgently necessary to relieve the present serious condition in some manner as above suggested or else by the entire removal of the structure forthwith.

I accordingly recommend that a special committee of this Board be appointed with authority to take this matter up with the Public Service Commission and the Long Island Railroad Company and report upon a plan of relief.





Dear Sir:-

On the 27th day of June, 1913, JOHN T. BURNS, #60 Henry Street, Corona, Borough of Queens, a Laborer assigned to one of the gangs under the supervision of Francis X. Kestler, a Foreman in Charge of the Maintenance Division of the Bureau of Sewers in the Fifth Ward, Borough of Queens, while at work in an excavation on Central Avenue, Far Rockaway, Borough of Queens, met with an accident which resulted in the dislocation of his right knee and also received other injuries to his body which required his removal to St. Joseph's Hospital at that place where he was confined until August 2nd. last.

The above facts are attested to by a report of the said Francis X. Kestler and the certificate of Dr. A. S. Tepper, House Surgeon of said Hospital, copies of which are herewith enclosed.

As a result of his injuries, he has been invalided and unable to perform manual labor and as his family is dependent upon him for support and in view of the fact that he is an old and valuable employee, I would recommend that his regular wages, during his incapacity be paid him and would request the Board for a certificate of approval of the same as provided in Section 1568 of the Charter of the City of New York. I have already granted to this man a thirty days leave of absence, with pay, from June 27, 1913, but I am unable, under the law to make a further grant of a leave of absence.

In response to your letter of recent date, informing me that his Honor, the Mayor, received my communication of date October 22, 1913, requesting his consent to a leave of absence with pay pursuant to Section 1568 of The Greater New York Charter, for JOHN T. BURNS, Laborer in the Bureau of Sewers, this Department, who was injured while in the performance of his duties, and asks to be further advised as to the duration of said leave of absence, I desire to inform his Honor, that as a result of his injuries, the said BURNS, was unable to perform his usual duties from the date of the accident on June 27th to November 30, 1913, inclusive, having been under the constant care of Dr. C. W. Brunner, during his incapacity, excepting the period from June 27th to August 2nd, 1913, while he was confined in St. Joseph's Hospital at Far Rockaway, L.I.

As stated in my previous communication, I granted him a leave of absence with pay for thirty (30) days from June 27th, and for the reasons ascribed therein, would request that his Honor, the Mayor, give his consent in the form of a certificate to a further leave of absence with pay for the said BURNS, covering the balance of the period of his incapacitation from August 6th to November 29th, 1913, inclusive, as provided for in Section 1568 of The Charter as aforesaid.

The facts of the case are certified to, by a report from his Superior, John R. Higgins, Superintendent of Sewers, and the certificate of Dr. C. W. Brunner, on file in this office, copies of which I transmit herewith.

I return herewith letters from Honorable William A. Prendergast, Comptroller, and Honorable Julian Beaty, Secretary to the Mayor, relative to your request of October 22nd for a leave of absence with pay for John T. Burns, laborer in this Bureau, who was injured in the performance of his duty on June 27th, 1913.

Agreeable with the suggestion made in both of these letters, I am forwarding herewith certificate in duplicate signed by C. W. Bruner, M. D., which testifies that he had been in attendance on the said Burns from the time of his discharge from the hospital to the date of the said certificate, November 29th, and now declares him able to resume light work.

I, therefore, desire to recommend that the application be modified so that the request may cover a leave of absence from August 6th to November 29th, inclusive, a total of 89 days.

In connection with this matter I desire to state that I saw Mr. Bruner personally and can testify that his injury was quite serious and resulted in his being confined for a considerable length of time to his bed, and up to the last week he could not get around without the aid of crutches.


