In reply to your letter of the 22nd inst. in reference to citizenship of one Benjamin Hoffman of 30 Amboy Street, Brooklyn, will say, that Mr. Hoffman was not granted his second papers or he would now be a citizen. I give you here our Court records:

Court Record of Benjamin Hoffman, Petition #1732.

Petition filed February 24, 1909

Return day - June 17, 1909 - Examined by Justice Kelly and set over to allow petitioner to bring his wife from Europe.

Sept. 8, 1909 - Examined by Justice Aspinall, wife still in Europe - set over to March 21, 1910.

March 21, 1910 - No answer on call of calendar - petition dismissed by Justice Kelly.

The only remedy for Mr. Hoffman is to file a new petition.

His declaration is on file in this office and need not be renewed.

You will see that it is Mr. Hoffman's own fault as he neglected to appear when called. Hoping this will be satisfactory, I am
