

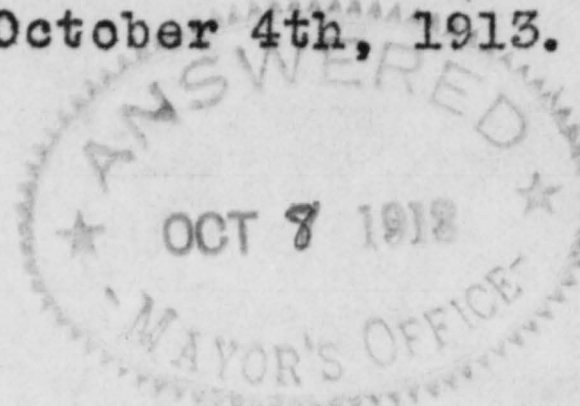

S i r :

I beg to acknowledge the receipt of your communication of the 2d inst., enclosing letter received by the Comptroller from Thomas F. Bulger, 649 6th Ave., city, requesting a re-hearing in the matter of the revocation of his license to conduct an employment agency.

Various complaints were received at this office wherein it was alleged that Thomas F. Bulger unlawfully retained fees after failure to provide employment; that on several occasions he was intoxicated and assaulted applicants for employment when they demanded refunds. A hearing on these charges was held at this office on Sept. 23d, 1913; notice of said charges was presented and reasonable opportunity given to said licensed person to defend himself. Evidence was produced under oath sustaining the charges aforesaid, as a result of which I revoked his license.

Under subdivision 3 of section 191 of the Employment Agency Law I am prohibited from issuing another license to any person whose license has heretofore been revoked; but my determination may be reviewed by writ of certiorari to the Supreme Court.

I was about to make a claim on behalf of these complainants against the bond of the said agent when the defendant called here and deposited \$22.50 to cover claims against him.






