Dear Mr. President:

The pall-bearers at the funeral of the late Mayor Gaynor are asked to assemble in the Mayor's office at the City Hall next Monday morning, September 22nd, at ten o'clock. The casket is to be taken from the City Hall to Trinity Church followed by the pall-bearers and the citizens escort, arriving at the church at about eleven o'clock.

I have made arrangements for an automobile and an escort to be sent to convey you from your stopping place in this city to the City Hall on Monday morning and from Greenwood Cemetery after the interment. If you will be good enough to let me know where you will stop while in the city I will see that the automobile is sent for you in time for you to arrive at the City Hall at the appointed hour.

I enclose a card of admission to the City Hall for Monday morning, not that it will be necessary for you to use it as you will have an escort, but simply as a precaution in the event that I might not hear from

you in time for the escort to be sent for you.

I gave your kind and thoughtful message to Mrs. Gaynor who, it is needless for me to say, appreciated it highly. She told me on Saturday when selecting the pall-bearers that she desired to select only those personal friends of the late Mayor whom he himself would have selected for such a service, and she spoke of you particularly as a friend whom her husband greatly prized.


My dear Mr. Adamson:-

I am rather disappointed not to have been named on the Citizens Committee to attend the funeral services of our late Mayor, William Jay Gaynor, but I presume demands upon you are great.

I called a meeting of the National Board of Steam Navigation and had a resolution passed requesting all shipping to display their flags at half staff on Monday, and so far as possible stop all operations during the hour of the services. I also appointed a committee of three from the Board to attend the funeral. This committee consisted of Mr. Eugene F. Moran, Mr. Edgar F. Luckenbach and myself.

I forwarded this information to my friend *Com.* R.A.C. Smith but as yet have not received cards of admission or assignments. Would it be possible to have me assigned on one committee of the other.

Societies and Delegations south of Murray Street. All organizations should be in position by 9.45 A. M. The assignments made are as follows :

The Grand Army of the Republic, Manhattan and Brooklyn, Pine Street, facing west, head of column resting on Broadway.

The United Spanish War Veterans, Pine Street, facing west, head of column resting on Nassau Street.

The Marshals' Association of New York City, Pine Street, following Spanish War Veterans.

The Federal and State Civil Service Employees, in the order named, Thames Street, facing east, head of column resting on Broadway.

The Democratic organization of Kings County (Executive Committee), Cedar Street, facing east, head of column resting on Broadway.

The Eureka Democratic Club of Bronx County, Cedar Street, facing east, following Democratic Organization of Kings County.

NOTE — Societies and delegations are requested to parade, so far as possible, 12 files abreast. Organizations not mentioned, who expect to participate in the procession, have been assigned to positions to be announced later.

Representatives of the Fire Department, Chambers Street, facing east, head of column resting on Broadway.

Representatives of the Department of Street Cleaning, Reade Street, facing east, head of column resting on Broadway.

Representatives of the Department of Health, Duane Street, facing west, head of column resting on Broadway.

Representatives of the Department of Docks and Ferries, Pearl Street, facing west, head of column resting on Broadway.

Representatives of the Department of Finance, Thomas Street, facing east, head of column resting on Broadway.
