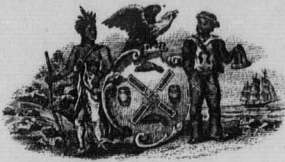

tion for promotion."

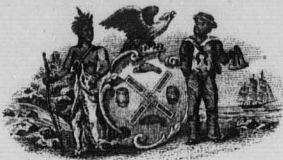

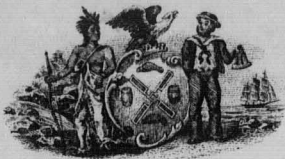
I wish to apologize for any irritation which I may have manifested last night. My nerves are somewhat worn with this subject, and the attitude of the Board was at once developed when, on attempting to open the meeting with my statement, I was interrupted by Mr. Godkin in order that the matter first considered might be, not my charges, but a complaint against me. When I first brought charges against Mr. Phillips, it was, to my surprise, assumed that I, and not Mr. Phillips, was to be put upon trial, and the nerves of a more stolid man might excusably be affected by nine months of effort for good administration under such conditions.

I will pass over Mr. Godkin's frankly expressed opinion of my capacity. I was favored with it last April, and valued it so highly that I at once showed it to Mr. Carl Schwarz, of the Civil Service Reform

association. I do not entertain the slightest feeling  
against Mr. Godkin for holding it or expressing  
it. Its value as a guide to the action of others  
is to be measured by the opinions which Mr. Godkin  
has expressed, and is daily expressing, of every  
man whose character comes under his observation.  
I am quite willing to take my place with the good  
among those who have heretofore been honored with  
his disapproval. He made however a charge last  
night which was entirely new to me. He charged  
that I had attempted to secure the appointment  
of a man of worthless character as Labor Clerk,  
and I request that this charge be considered as  
part of the whole case. I have all the papers,  
and still maintain that the man in question  
was proved to possess an unblemished character,  
the record of the trial quoted not even purporting  
to reflect upon it. The man who was <sup>first</sup> appointed  
Labor Clerk was, <sup>and because of</sup> appointed on Mr. Godkin's recommen-  
dation. I have no hesitation in saying that had  
he been retained, the administration of that Bureau  
would have been rightly suspected. It was only because  
of my <sup>recorded in the minutes of the Board</sup> protest that this man, tainted with Tammany methods,  
was not appointed, and it was on my motion that Mr.  
Briscoe was so appointed.

I last night, made five charges against Mr. Phillips;  
 1<sup>st</sup> That I had personally seen him conducting a  
 fraudulent examination. This was met with  
 the statement that the Board had considered  
 the matter and decided it by passing a vote of  
 censure upon an innocent man. <sup>Before</sup> ~~then~~ that  
 vote was carried, I was asked to state my views  
 and, as Mr. Phillips was present, declined to do  
 so on the ground that I had already communicated  
 them <sup>in writing</sup> to Mr. Wheeler. Mr. Olcott was absent  
 from the <sup>meeting at which</sup> ~~meeting~~ <sup>when</sup> ~~the~~ charge was first made, and although  
 the letter containing it had been in Mr. Wheeler's  
 possession several weeks it had not been shown him.  
 He therefore voted in ignorance of the merits of  
 the case from my point of view. Mr. Wheeler's  
 response to the charge, which I have over his signature,  
 was that "the whole discussion on the subject had  
 failed to show to his mind, the slightest fault on  
 Mr. Phillips' part" and the resolution of censure  
 upon Mr. Williams, <sup>which was passed</sup> had been prepared by Mr.  
 Wheeler before the meeting at which Mr. Williams  
 was examined, and before he had been heard. But  
 for Mr. Williams' refusal to mark the papers, and thereby  
 to participate in the fraud, the examination would

have been completed and the fraud effected. If I had not been in the city the Board would have then been as ignorant of the whole matter as it was of the fraudulent examination upon which I based my fifth charge <sup>made below</sup>. I particularly request that this charge be examined into, as its treatment by the Board illustrates the methods against which I have had to contend whenever questions relating to Mr. Phillips' conduct have been raised.

My second charge related to the M<sup>c</sup> Laughlin Examination. It has not been considered at all. I refer to Mr. Roosevelt for evidence upon the subject.

My third charge was that eligible lists existing when we were appointed were fraudulent for the reason that the examinations ~~at~~ upon which they were based were fraudulent; - that candidates at those examinations had taken the questions home with them and returned next day to answer them. Mr. Wheeler's reply to this (over his signature) was that "I had evidently made up my mind and seemed to him hardly in a position to act as judge." "He never asked me for my evidence, and I had no opportunity to present it until Nov. 4, one month and three days after the charge was made. If it was <sup>the charge</sup>

true it was evidently improper that Mr. Phillips should be continued in office a single day.

My fourth charge was that Mr. Phillips' previous reputation, as indicated by a quotation from a letter written in 1892, was detrimental to the interests of Civil Service Reform. This charge was made on Oct

14th <sup>but</sup> ~~and~~ I have never been asked to produce the letter or who was its author. When I did

produce it last night, Mr. Wheeler, its author, at once ~~assumed~~ <sup>advanced</sup> the proposition that the responsible

head of the Civil Service Department at the time that it was written was in no way affected by the ~~charge~~ <sup>statement</sup> contained in it that "a critical examination will show that the successful parties must have had information in advance as to the character of the examination." In reply to that proposition I

wish to say that, although the police department shared at that time in the marking of the papers it was not then, and never has at any time

been legally permitted to have ~~any right to do so~~ <sup>or custody of</sup> the preparation of the questions. Information, <sup>in advance</sup> upon

the character of the examinations could therefore have been obtained only from the Civil Service Board.

My fifth charge was that Mr. Phillips had conducted to completion a fraudulent examination on Aug 16<sup>th</sup> 7<sup>th</sup> and that, at that examination, he had, in contravention of a resolution of the Board, and of one of the regulations, ~~marked the papers~~ <sup>permitted</sup> the Secretary of the Fire Board to share in the marking of the papers. Mr. Wheeler's reply was that the Secretary was possibly a man of high character, and ~~his~~ <sup>his</sup> inference was that in that case it was proper (notwithstanding <sup>and in violation of</sup> the resolution and the regulation) to ask his aid. Mr. Wheeler is of course aware that collusion between the Secretary of the Fire Board and candidates <sup>for Civil Service Examination</sup> in the employ of that Board has been justly suspected, and that previous knowledge by said candidates of questions prepared by him has been proved.

I apologise for burdening you with so lengthy a communication, but I think I am justified in asking your attention to the difficulty I have had in obtaining a consideration of the charges I have made, and to the continuous effort to evade the issues raised. I am aware that some of my colleagues have had conferences which presumably affected their action upon these questions at meetings of the Board. I, on the contrary, have never made charges except to the Board as a whole, nor attempted

to influence the opinion or action, of one of its members<sup>my</sup> except by arguments in open meeting, or letters to be laid before all. As it was intimated that my interference had been detrimental to the proper administration of the office, I would suggest that inquiries be made of all the Examiners and of the Labor Clerk. I wish to say that there was only of them with whom I was acquainted at the time of his appointment.

I also request that you read the minutes of the Board since Feby. 1895, and the arguments on file which influenced the adoption of the amendments to the rules promulgated by the first Civil Service Board. (Messrs. Wheeler, Godkin & Johnson)

I wish to say that Mr. Olcott should not be included in any reflection upon the ~~Board~~ action of the Board which the evidence I present may justify. He was uninformed upon the subject of Civil Service Reform when he was appointed, and it was quite natural that he should side with the majority. Upon all questions where he was not so biased he has shown himself just, conscientious, and disinterested.

In conclusion I hope, that in justice to me, you will give this matter the time necessary to determine the truth. My resignation is at your service whenever you think it in the public interest to accept it. Yours Very Respectfully

Dear Sir:-

In view of the opinions expressed at our meeting Saturday evening in reference to the men on the eligible list of the Fire Department, I requested our new examiner, Mr. Ireland, to go over the papers of the nine persons who would be sent to the Fire Department under the pending requisition, instructing him to examine specially for any indications of collusion or unjust marking. He has given me a report this morning, a copy of which I enclose.

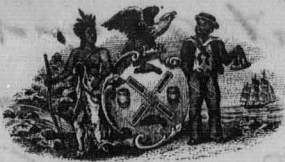

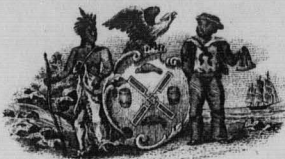
upon whose objection, nor upon what ground

Your letter of the 26th inst., addressed to Mayor Strong has been referred to this office for reply. I have to state that there is no dispute about the facts set forth in your letter, but under the Civil Service rules, examinations are held from time to time as the needs of the service require, and it has always been the custom to call new examinations for the purpose of replenishing existing eligible lists whenever a considerable number of those obtaining the higher percentages have been appointed. Regulation 13 provides, "Where an examination for any grade takes place before the eligible list for that grade is exhausted, a new eligible list shall be prepared after such examination, to take the place of the former eligible list." The same regulation further provides that the names of those on the old list shall be placed upon the new list in the order of their percentages etc.

Your son's name stood very near the foot of the list of January 22nd, being No. 76 thereon, and as 47 men had been appointed from said list in the order of their rating, and the Fire Department has several times requested that a new examination be held, such examination was called and the new eligible list perfected on Nov. 26th last. The name of Frank B. Florence now stands No. 46 on the revised list

There seems to be no good reason why applicants who have not been examined may not have the right under such circumstances to compete with those already on an eligible list as well as with one another. There are now nearly 1000 new applicants awaiting examination, and examinations will doubtless be held within a month or two when the list will be again revised.

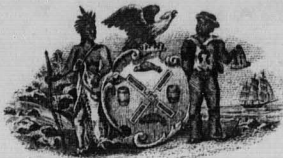

In response to your request of the 3rd inst., for a statement from this Board as to the condition of the work on January 1st, 1895, and what has been accomplished during the current year, we have the honor to submit the following:

When we took office in February last, we found the service somewhat discredited by the revelations made by the investigation of the Fassett Committee touching the condition of several branches of the City Government, and more particularly of the Police Force. It seemed desirable, therefore, to proceed at once to a revision of the rules and a reorganization of the Board of Examiners and of the force employed in the office of the Commission. The services of the Chief Clerk, which were apparently unnecessary, were therefore, at once dispensed with, as also those of one of the female clerks and of a janitor, and their places were taken by two Junior Clerks and an office boy.

We then addressed ourselves to a revision of the rules affecting the uniformed forces of the Police, Fire and Park Departments in all of which there were long standing possibilities of abuse. The candidate's power to choose whether he would obtain his application papers from the Civil Service Board, or from the Department to which he sought admission, was abolished. He was compelled to obtain them from the Board. The preliminary



medical examination of the candidates was transferred from the police surgeons to the medical and physical examiners of the Board. Another very important change was the assumption by the Board of the duty of making the necessary enquiries as to the character and antecedents of candidates, through its own examiner, instead of relying on the reports of the Captains of the various police precincts, and of the Chiefs of Battalion in the Fire Department, and of the Captain of the Park Police. These amendments were all made for the purpose of securing greater freedom of competition, and diminishing the power of appointing officers over the access to the service, in popular belief, a fertile source of corruption and favoritism. For similar reasons, competition for promotion was opened to all, instead of being, as previously, restricted to those designated as fit by the appointing officer.

To meet the abuses growing out of the practice of making large requisitions on the eligible list, so as to give the appointing officers wide range of choice, which was generally abused, the number certified was cut down to two in excess of the number of vacancies to be filled, and to avoid the practice of delaying appointments with the view to some evasion of the rules, the appointing officer was compelled to make his selection within ten days. When we took office, we found an eligible list in the Police Department containing seven hundred names, no appointments having been made in it from May, 1894 ; owing, it was said, to dissensions in the Police Board,



or suspicions of fraud in the list, based on the detection of fraudulent practices of two candidates at the examination which produced it. It was impossible for us to ascertain the cause of the delay or the validity of the charges against the list, but the hardship entailed on the candidates who stood high in it, was undoubted, particularly as the list ran out on the 1st of April.

A call upon the Police Board, either to fill these vacancies from it, or to state specifically their objections to it, led, however, to thirty-eight appointments from it before it expired. All further difficulty in the matter was ended soon after by the removal of the Police Department from our jurisdiction by the Act of the Legislature, known as the Bi-partisan Police Bill.

With the approval of the Mayor, rules for the registration of all candidates seeking employment in the Municipal Service as Laborers, have been drafted and put in force. Candidates are registered in the order of their application after passing an examination as to physical condition and character. In no Department of the City Government, were the abuses of favoritism and corruption, more flagrant and more debauching to the poorer class of voters, than in this, and it is gratifying to report the complete success of the new system. Since May, 1895, when it went into operation, 6,359 applications have been received, 383 were rejected by the medical examiner, and 580 failed to appear when called for. The applicants belonged to ninety different trades and employments, and the appointees to 44. In only one or



two cases have there been dismissals for cause. The organization of this Department made necessary the creation of the office of Labor Clerk at the head of a Labor Bureau, of an assistant, and of a medical examiner.

The plan of employing public officers of a Department as the official examiners of candidates for admission to it, which was adopted in the earlier years of the service as a measure of economy, was found productive, if not of abuse, of suspicions of abuse, and we abolished it. Under this rule, the examiners taken from the Police Department, from the Fire Department and from the Department of Public Works, were dropped, as were also Mr. George N. Williams, and Mr. John Foord, examiners under the old Board.

The present Board is composed of B. F. Vosburgh, M.D., Medical Examiner; A. H. Brown, M. D., Physical Examiner; Francis Collingwood, Civil Engineer; D.N.B. Sturgis, Architect; John H. Fitzpatrick, Builder; George N. Messiter, Lawyer; Frederick G. Ireland, Teacher; Charles B. Jessup, Examiner as to Character.

In 1894, 139 examinations were held, and 2,039 candidates examined. From January, 1895 to December 15, 1895, 231 examinations were held, and 4,672 candidates have been examined. The plan of filling vacancies in the examining board, by competitive examination, instead of direct appointment by the Mayor, has been tried with much success and we found that by this plan we obtained candidates of a very high order of merit and acquirements. The classification has been extended to the Building Department, and to the employees of the Commissioner of



Jurors; and the employment of laborers for clerical work, an old and ingenious evasion of the rules, has been forbidden.

In the conduct of these examinations we have made special efforts to enforce the requirement of the rule that, "all examinations shall relate to such matters as will fairly test the relative capacity and fitness of the persons examined, to discharge the duties of that service to which they seek to be appointed". To this end we have caused particular enquiries to be made as to the duties and requirements of the particular offices for which examinations were to be held, and have instructed the Examiners to prepare questions adapted to test the capacity of applicants for these positions. The variety of employment in the service of the city is great and unless care is taken, the examinations will not disclose as they ought, who are the most competent persons to be employed in each branch of the service.

In summing up the results of our past year's work, we may be permitted to say that the efficiency of the Commission must always largely depend on the support received from the Mayor in extending and enforcing the rules. Without this, no Municipal Commission under the present law, can accomplish much, and we are glad to testify that it has been given to us without stint. Almost every proposal in the direction of greater stringency or wider jurisdiction has met with his hearty approval.

In our intercourse with the Departments we have had



few difficulties. When appointing officers have desired to fill places of a peculiarly confidential nature, with persons whose fitness was known to them, we have endeavored to meet their views to the extent which the law might allow. As far as our observation will permit any conclusion on the subject, the confidence of the public in the system has grown steadily during the year, and under the extremely useful stimulus of the Constitutional amendment, it has been more cheerfully accepted by the various departments of the City Government.

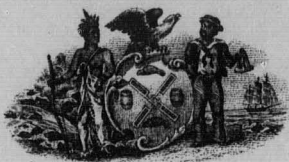

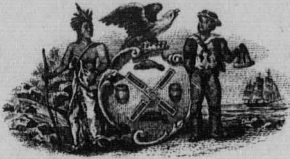

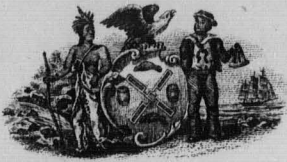

RESOLVED:- That the Secretary be directed to write to the President of the Dock Department that under the rules of this Board there is nothing to prevent the Dock Department from increasing the compensation of the Stenographer to the President to such amount as may seem proper and desirable, and to assign to him all the duties mentioned in the communications from the said Department as required of the incumbent of the position of Executive and Confidential Clerk, and that this Board sees no good reason for creating another exempt office in the Dock Department.

1896.

The Chairman then read a letter from Mr. Lee Phillips, stating that he proposed organizing a Civil Service Preparatory school, and requested permission that he should have access to the Registration List of applicants.

Upon motion of Chairman Wheeler it was  
RESOLVED That the matter be laid over until the next meeting, and an investigation should be made as to the advisability of granting Mr. Phillips' request.

Upon motion of Chairman Wheeler it was  
RESOLVED That this Board express their regret to Mr. Lee Phillips upon his resignation from the office of Secretary, in that he had proved himself of great value to the public service in transacting the business of the Civil Service Boards. And further, that Commr. Olcott be requested to draw up a resolution expressing to Mr. Phillips the regret of the Board at his resignation, and that the Resolution of the Board, as drawn by Mr. Olcott, should be entered in the Minutes and a copy of the same sent to Mr. Phillips. Duly seconded and carried.

RESOLUTION OF COMMR. OLCOTT.

Whereas, Mr. Lee Phillips, for many years Secretary of the Civil Service Commission of the City of New York, has recently resigned his office as Secretary, and his resignation has been accepted by the Mayor of the City of New York,

RESOLVED, That the Board hereby expresses its very



great regret at the necessary severance of the agreeable relations which have always existed between Mr. Phillips and the Commission.
