Sir:

I am directed by the Board of Police to say with reference to anonymous complaint of J. E. Johnson, and forwarded to this Department in yours of the 28th ult., that Captain William S. Devery, of the 30th precinct, reports concerning the same as follows:

"There is a licensed furniture mover named L. F. Boves, who keeps his van standing on the corner of 130th st. and 8th avenue. There is no urine of horses or any sediment of any description collected in the ruts on the street. There are no loafers around said corner, nor have there been. The "loafers" referred to are two or three men who have been working for Mr. Boves, and the horses are never on the sidewalk, and have no occasion to be, as referred to in letter. I personally tried to find Mr. James E. Johnson, of "130th st.," but was unable to do so. Inquiry was made at every house on the block between 7th and 8th avenues. Mr. Boves, the owner of the van, has been standing on the corner complained of for several years past, and there has never been any complaint made at this station or to any member of my command of any such nuisance as complained of. Nevertheless, I have ordered Mr. Boves to vacate the place complained of, and I will give the matter further attention, and use every precaution to prevent any further cause for complaint."

In answer to annexed communication from the Mayor I have the honor to submit the following report:

Leonard Street, from Hudson Street to West Broadway, is taken up almost exclusively by large storehouses with high stoops. These buildings are occupied by Claflin & Co, Faulkner Page & Co, and others, for storage purposes. Gutter bridges have been placed along the entire block, and cart-men in order to load and un-load heavy cases, have been accustomed for years to back their trucks across the side-walk against said stoops. Owing to the vast amount of business done in this block, the practice seems to be somewhat necessary. The street is narrow, measuring only 23 feet 6 inches from curb to curb, and to require of truckmen to entirely discontinue the use of the side-walk would result in blockading said street, thereby seriously retarding business.

I have given this subject my personal, constant attention, and have insisted that platforms must be kept free from obstructions and that truckmen must not, under any circumstances occupy the side-walks unless actually engaged in loading or un-loading heavy, bulky goods. I have personally arrested truckmen in said block who had become careless in this respect.

In the future, as in the past, we will use our best endeavors to regulate the traffic on said block, and prevent, so far as possible any cause for complaint.

All of the Merchants doing business in said block have been notified of said complaint, and all have promised to aid in preventing any unnecessary annoyance to the traveling public.
