



I became acquainted with the said Mrs. Odell under the following circumstances:- The Rev. Mr. Campbell of the City Missionary sent her to me as a person worthy of charity, and we furnished her with crackers. She represented to me that her husband was very sick. I sent our bookkeeper to her rooms, No. 43 College Place, who saw a man lying in bed. Soon afterwards Mrs. Odell informed me that her husband was obliged to be taken to the hospital suffering from Hemorrhage of the bowels. Soon afterwards she represented to me with ^{at} tears in her eyes, that her husband was dead, and wanted money to bury him in Patterson, N.J. I thereupon, gave her ten or fifteen dollars for that purpose. Soon after the alleged funeral of her

husband, Mrs. Odell came to my office and brought a child with her which she said was her child. She told me that she could get her children board in Yonkers, that she needed money to get them there. I gave her money to get her children to Yonkers. Sometime after I had given her money to get her children to Yonkers, she came to my office again, and asked for money to enable her to buy clothing in order to enable her to get a position in an ice-cream saloon in the city. I then gave her money for that purpose. Soon after this she came again to my office stating that she could no longer remain in the ice-cream saloon, and I then gave her money with which to buy a pair of shoes, she at the time having little or no covering for her feet. After this she came again to my office and stated that she had a relative in Cincinnati, and that if she could only get to him she would be all right. I then gave her money to pay her fare to Cincinnati. Two or three months after this payment to her, I received the following letter:

" New York August 19th 1886.

" Dear Friend Mr. Thomas

"You must excuse the liberty I
"take in dropping you these few lines but I was compelled
"as I thought you are the only friend I have in time of
"trouble. Mr Thomas it is with a sad heart I tell you
"that my little girl Maggie is dead she died twelve

The above letter came to my office during my absence and was read by my nephew Mr.Charles W.Thomas, the letter being unsealed. I am further informed that after this letter had been read by my nephew, our bookkeeper, Mr. Retz went to Mrs.Odell's residence at 48 College Place for the purpose of assisting her with money. At her residence, the bookkeeper, as I am informed, found Mr.Odell, the husband, whom she had represented as dead, on the 23rd of October at St.Luke's Hospital, standing in the doorway of said house, and Mrs.Odell in the house. After my bookkeeper had thus ascertained that the husband, for whose burial I had paid, was still alive, he came away from the house without leaving the money, which he had taken to give her, and on my return from Babylon, these facts were communicated to me. I thereupon went to see Mrs.Odell and on my arrival at her house I found Mrs.Odell there. I asked her how it was.

that all the furniture in the room that she had represented to me as having been sold was still there, and she there. She said to me that ^{her} husband's brother had purchased the furniture and was living there; that it did not belong to her. I made inquiries of different persons in the house and found that all her representations to me were false and untrue, that is; that her husband had not died; that she had no children; that she had never sold out her furniture, as she had stated, and that she had not been to Cincinnati but had resided all the time at that place. I thereupon left, and the next day received the following letter from the said Mary Frances Odell:

"Sir Thomas

Indictment for abduction.

Josie Ehrenreich sworn. I live No. 9 First St.,
I saw the Defendant on the 18th of May at about three
o'clock, the 2nd of May was the first time I went to the
Defendant's office, 168 Third Avenue, an intelligence
office, the second time I went to her office was a week
after the 2nd of May, I think on a Wednesday, I asked her
for a situation and she said there was nothing for me
yet and I went home, I went there on the 18th of May be-
tween twelve and one o'clock; the Defendant said she had
a situation for me, that Mrs. Staubsandt would be there
that afternoon and she told me to wait, I heard the De-
fendant say to Mrs. Staubsandt I was a good girl and she
would not have any trouble with me; then she engaged me
as a waitress for twelve dollars a month; the Defendant
said it was a very fine place and that she came there
every Sunday evening. She said to me, you can laugh now
you have got a good situation, I said I was glad to get a
good situation. Then Mrs. Staubsandt took me along with
her to Union Hill, New Jersey; when I got into the house
I saw women over there in tights and there were men there.
I saw the men touch the womens' bodies where they ought
not to touch them; they were drinking over there and they
wanted to give me something to drink; a man that was there
took me upstairs and said he would give me five dollars
and if I was not satisfied with five dollars he would
even give me fifty, he wanted to do something bad with me.

but I would not do it. Mrs. Staubsandt said when I came into the house, "I do not want a girl for work, I want a girl for business", and I told her she ought not to engage me for such a house because I had never been in such a house before; she said, "I have engaged you and you have to stay"; she would not let me out of the house I could not go out, I threw my clothes out of the window and I went out of the window myself. Before I went out of the window the man that went upstairs with me attempted to put his hands on me, I went to New York, I arrived at the house in Union Hill about half past four in the afternoon and got out of there at half past eight in the evening; I went the next day to the office of the Defendant between nine and half past nine in the morning; I said to the Defendant I would not stay in that place you sent me over to for a thousand dollars; she was very rough and insulted me, she said, "how can you make such a scandal in my office before all the girls; there were two girls from Union Hill there and they hit me and her husband threw me down stairs. I never had connection with any man .

Cross Examined.

I testified before the Police Magistrate and signed my testimony. I did not get a place from the Defendant when I went there first on the 2nd of May but when I went there about the 9th I got a situation in Alabama Avenue, Brooklyn, it was a respectable saloon kept by Mr Flettinger, I was there a fortnight and left because I was not able to do the work, then I went back again to the Defendant three days after I left the place but she did not have any situation for me. It was before

I went to Union Hill that she got me the place in Brooklyn. What I said here about going upstairs in the room with a man at Union Hill I said before the Magistrate also. The Defendant said it was a fine place and that she was going there every Sunday and Mrs. Staubsandt said to me in Union Hill, "if you stay here till Sunday you will see Mrs. Horn." I said before the Magistrate that the man offered me five dollars and fifty dollars. I said before the Magistrate, "the men sat next to me and they put their hands on me and one of the men said he was drunk and I can't bump you to-day." I said before the Magistrate that he pulled me upstairs but I did not go with him, I ran away from him, I saved myself from him, he pulled me from the parlor and in another room towards the stairs, I did not go entirely upstairs. I was in the parlor and the other girls were there too when he offered me five dollars and fifty dollars. I did not say anything to the Police Magistrate about jumping out of the window because they did not ask me. I know this young woman now shown me Rosie Kalmavoytz, I saw her at the Defendant's office the day I went to Union Hill. The Defendant has four rooms with a kitchen and one of the rooms is used for the ladies and then there is an office for people who come in to get information about hiring servants. Miss Kalmavoytz was not standing there when Mrs. Staubsandt hired me, I did not hear the conversation between her and the Defendant but I saw them talking together before I was engaged. I did not jump up and say I was willing to go but I said, "all right, I will take the place."

I did not hear Mrs. Staubsan t say to the Defendant, "I do not want her, she looks too fresh." The Defendant did not say to me, "leave your clothes here and go and look at the place and if you like it, staybut if not come back." I am seventeen years old, I know Reinsberg who was employed in the office of the Defendant, I do not know that he had some trouble with the girls in that house, it was not Reinsberg who came and got me to make the complaint against the Defendant, I saw him after I came back from Union Hill but I had no conversation with Reinsberg about making a complaint against the Defendant and having her arrested, I never met ^{him} in the street at night in front of the Defendant's intelligence office .

Charles Reinsberg sworn and examined.

I was born in Germany and next September I will be two years in this country, I know the Defendant, I was in Bloomfield, N. J. At the German Theological Seminary, I met the Defendant in the beginning of May, I answered an advertisement in the Staats Zeitung and went to her intelligence office, she advertised for a clerk speaking German and English. I went in and inquired for the place and she offered me \$1.50 a week and meals, I gave her my references and address. She said to me, "you will get \$1.50 a week and meals and I said that was very little for a man to get and she made it two dollars. I went to Bloomfield and got my trunk. She said I should keep the office clean and do everything that was to be done, keep the books and take the girls to the places

where they were engaged. The Defendant said, this situation is good, I think it will please you, the young man that was here before liked it very well; she said, "you see they are girls that go to bad houses and they are well paid, some pay five, some pay seven and some pay ten dollars and more and for every girl I will get a good commission." I said nothing to that, I kept quiet.

The Defendant said to me, "you must see where those bad houses are, the young man that was here before he knew them all before he came to this office." The Defendant said whore houses, that the young man who was there before knew them all and made lots of money; she said that I should bring the girls to these places. She also said that the man who kept the house of prostitution would pay five, seven or ten dollars, that I was to get half of it and Mrs. Horn the other half. I saw Mrs. Staubsandt from Jersey the day when she engaged Miss Ehrenreich but I had not seen her before that. She came in in the morning and I had a conversation with her, I asked her what kind of a girl she wanted and she would not tell me that, she said, "Mrs. Horn knows what kind of a girl I want;" Mrs. Horn told me to keep still, that she knew what kind of a girl she wanted; the Defendant came in at the time I talked to Mrs. Staubsandt and stopped me saying, "I will fix that business; they talked in German together, the Defendant said, "I have got a good girl for you, a beautiful girl" and then she presented Miss Ehrenreich from the waiting-room; they had some conversation together about the place, Mrs. Staubsandt said it was a good place and she was sure she would like

it and Mrs. Horn would come over there Sunday. The girl did not say anything, then after a little while Mrs. Staubsandt took her away. Mrs. Staubsandt and Mrs. Horn went into the kitchen and talked together and took dinner. After a few days Mrs. Staubsandt came over again and said to me, "Why did you send me that girl, you know what kind of girls I want." Then I said to her, what kind of a girl do you want, tell me, but she would not tell me and went up to Mrs. Horn and I went away, I had some business to attend to, I was away a couple of hours. Mrs. Staubsandt said, "there are two girls in Jersey City and they will come here to Mrs. Horn. While I was working there I saw a girl named Hedwig Kramer known as Lillie Smith, I had a conversation with the girl privately but not in the presence of Mrs. Horn. I went with the girl to Rev. Mr. Dooley of the Broome Street Tabernacle. Mrs. Horn gave me instruction about this girl Hedwig, to put her in a bad place, it was a couple of days after this girl went to Union Hill, Mrs. Horn said to me, she is a whore, that I must take her to 16 Delancy Street, I did not take her there but I took her the next day to the Rev. Mr. Dooley in the Broome Street Tabernacle. I do not know if it was Mrs. Snow that I ever saw at Mrs. Horn's place but I saw a lady that came from Bayard Street and wanted a girl.

Cross Examined.

I do not remember the day of the month I went to Mrs. Horn's house but it was in the middle of May, I was present when Josie Ehrenreich went away to Union Hill, I was there about four days before that and left on a

Thursday towards the end of May, I could not bring the girls to these bad houses, I said I did not like that kind of work. It was after I had been at the Defendant's house one week when she told me to take the girls to these houses of prostitution, I lived in 168 Third Avenue, I slept in the officer on a lounge. I know a girl named Lizzie Paff and a girl named Hedwig Pritz, Lizzie occupied the kitchen room which is on the same floor with the room I slept in, the Pritz girl occupied the same room with Lizzie. I did not go into their room one night about one o'clock in the morning, I never asked them in their room to permit me to go to bed with them, Mrs. Horn did not complaint to me that those girls had stated that I wanted to sleep in their room with them, she did not discharge me and did not tell me that she would not keep me any longer because I tried to sleep with those girls. I know the young man now pointed out to me Urbeinsky, he and his sister came to Mrs. Horns place to get a situation, I got fifty cents from him for expenses, Mrs. Horn did not say to me, "Give it back, you have no right to take it, I bought fifty cents worth of postal cards for the office with it and told Mrs. Horn that. After I left her place I did not go to the house of Josie Ehrenreich, I saw her next in the Tombs. I did not know that Mrs. Staubsandt kept a house of prostitution in Union Hill. I do not remember whether I was present when Josie came back from Mrs. Horn's the next day. I do not remember seeing her until I saw her in the Tombs Police Court; several of the girls told me that she came back from Union Hill and I heard the girls

say so to Mrs. Horn, I did not hear that day why she refused to stay in Union Hill. I know the girl Kalmavovitz I called on her with Miss Ehrenreich one afternoon about the 2nd of June, I guess it was before Mrs. Horn was arrested, I did not say anything to the girl about testifying against Mrs. Horn, I know the girl Maria Steimle, she was at Mrs. Horn's waiting to get a situation, I do not remember at any time she getting a situation from a gentleman who came to that place and I getting the money for it, I do not remember while she was standing in front of Mrs. Horn's place one day that a gentleman came along and was going up to Mrs. Horn's office and that he engaged her as a servant, I never got any money from that girl or from any man who went to employ her at Mrs. Horn's. When I came to Mrs. Horn's she did not buy me a shirt and a pair of shoes. My trunk containing my wearing apparel is still at Mrs. Horn's, I could not get it because I was put in the House of Detention. I have a home at 243 Bowery, a lodging house, the Young Mens' Christian Association rooms. When I came back from Bloomfield in the evening she said I would like the place and I would make plenty of money; she said the young man that was there made fifty dollars and after that she spoke about the girls who go to whore houses and when you bring the girls there you get a commission of five, seven and ten dollars and more and we divide this; she spoke to me in the same week about taking girls to bad houses; we talked together every day about business. Mrs. Horn said I should bring Lillie to 16 Delancey Street and I would not do it. I went to the Young Mens' Christian Association

and told them about it. I told the Rev. Mr. Docley about this employment that was going on in this establishment, he told me to stay in that house till I had the real facts for evidence.

Annie Conradi sworn.

I live at Sheepshead Bay and know the Defendant, I applied to her for employment and she sent me to a house in Thompson Street, New York, I do not know the number; she gave me a little green card, she had it under her table-cloth, it was a ladies boarding house, I remained there from eight o'clock in the morning till four in the afternoon; I saw ladies in short dresses and they had yellow wigs on and beautiful beads, I saw ladies going with gentlemen in a bed-room, they laid down on the bed with the men. When I came I said that Mrs. Horn sent me here for a chamber-maid and waitress; the boss said, "we do not want any girl for chamber-maid or waitress, we want girls for business and Mrs. Horn knew that"; then I said, "I am no business girl"; then he showed me some beautiful silk dresses and diamonds and said he would give them to me if I would stay there with him and do what he wanted me to do but I would not. Then when he saw he could not do anything with me he gave me whiskey and made me drunk, I would not drink it but he forced me to drink it, then I fainted and I do not know what they did with me; he had no wife, he had a house-keeper there, she asked me if I had already had connection with a man and then I said, "No, never", and I did not want to either and then she left. When I awoke from fainting I

was drunk and my face was very much swollen and I had a pain in the back so that after that I had to stay in bed four days, I was so weak I could not stand on my legs, I ran away at four o'clock, I went to that lady where I board 424 East 14th Street. I am eighteen years old.

Cross Examined.

It was in the middle of March in this year that I first went to Mrs. Horn's place; she sent me to this house in Thompson Street, I went back again to her and she got me a place in 17th Street as a laundress, I staid there two weeks and went back to Mrs. Horn and asked her to get me another place, she didnot say to me, "if you could only stay at a place two weeks she would not get me another place; I only took a place by the week. She got me another place in 11th Street in a private house, it was not a good place, I was nursing a child, I say it was not a good place because they didnot pay me, I did not go back to Mrs. Horn again because I was mad with her for she sent me to those houses, I do not know Mr. Renisberg or Miss Ehrenreich.

Emna Schaefer sworn.

I am married and know Mrs. Horn, I applied to her for employment and she sent me to a place sometime in May, it was just two weeks before she was arrested, I wanted a place to cook and to go home every evening; she had a couple of places and she said she had a nice place down at 33 Bayard Street; the lady came up and took me down about ten o'clock to 33 Bayard Street, Mrs. Horn told me it was a ladies boarding house; the lady asked me did I

know what this place was? I then told her Mrs. Horn told me it was a ladies' boarding house. She said, no it was not, it was a fast house, that I would have to do the same business as the other girls in the house were doing, I was in there about ten or fifteen minutes and the door seemed to be locked. I went out when the milk man came and went back to Mrs. Horn, she interrupted me at the time and told me to say nothing, I said to Mrs. Horn that was no place to send me, I was not brought up to be sent to such a place, I wanted to get home at night; she said to me it did not make any difference how I got my money so long as I got paid every week. I told her my mother would not let me do that; Mrs. Horn told me to say nothing about it, there was a lady in the office and that it would ruin her office.

Cross Examined.

I went to Mrs. Horn's to get the position of a cook. When I went back to Mrs. Horn's I commenced to growl, I had a conversation with Mr Meyer, the son-in-law of Mrs. Horn, he told me he would give me fifty dollars if I would not go against Mrs. Horn. I saw Mr Reinsberg at the office. I do not live with my husband but that has nothing at all to do with the Court now. I was told by Mrs. Horn about a place in Park Row but I did not care to go down there, I did not get four or five places through Mrs. Horn, I have no hard feeling against her, I saw Mr Meyer the day that I was sent word to go over to the Police Court at the Tombs, I saw him at the Tombs and he said to me, it was his mother-in-law and he would give me fifty dollars if I would not appear against her and

stay in Jersey. I told him that I could not, they would fetch me over here, he did not say anything more after that. I heard Mrs. Horn have conversation with a man about hiring girls on a Thursday evening, I do not just remember what the gentleman said but Mrs. Horn took him up to her bed-room and took the girl Lillie Smith herself up to 23rd Street and Third Avenue, he told her that he wanted her for a fast house, for the Compton House; she said she would bring her up herself, she went up and I took the 18th Street car for home, I was living in Hoboken. I know Mr. Vaughan and had a conversation with him in Hoboken. I do not know that the Compton House is a hotel, I have never been there, I was upstairs with Mr. Meyer in the next room and the door was open at the time I heard the conversation with Mrs. Horn and the gentleman from the Compton House.

Eugene D. Collins sworn.

I am a detective of the Central Office under Superintendent Murray and under instructions I visited the place spoken of by the witnesses in Union Hill, N. J.; it was called the Staubsandt Fair View Hotel.

Frank E. Vaughan sworn.

I am a reporter for the Star and investigated the facts in this case when it first came up at the Tombs Police Court, I know the house 16 Delancy Street from visiting it in connection with this case, I went there on the 3rd of June to get information about the character of the house.

I saw young women in short dresses and skirts having a

jolly time generally with a company of men, I talked with some of the women and ascertained the character of the house, it was a house of ill-fame.

The Case for the Defence.

Joachim Urbeinsky sworn and examined.

I am in a liquor store in Bleeker Street and know Mrs. Horn, I went there with my sister for the purpose of getting a situation, I remember sometime in the month of May when I left Mrs. Horn's house, she and Mr Reinsberg were in the office, I asked Reinsberg how much it would cost for me and my sister to sleep there on the 25th of May and he said fifty cents, I paid fifty cents, Mrs. Horn said to me, "why didn't you pay your money for sleeping here?" I said, I paid the young man fifty cents. She said to Reinsberg, why did not you give me the fifty cents they paid for sleeping here.

Hedwig Pritz sworn.

I am a servant and work at 309 Seventh Avenue with Mrs. Waltz, Mrs. Horn got me the place, I lived at Mrs. Horn's place 168 Third Avenue in the month of May, I know Charles Reinberg the clerk and Josie Ehrenreich, I was not there when she went to Union Hill, Lizzie Paff occupied the same bed with me, I recollect Charles Reinsberg coming into my room one night in the month of May about one o'clock, he brought ice-cream with him and asked us if we wanted to eat it; we said no, we did not want any ice-cream, we had already been asleep and he woke us up and then he laid hands on the other girl and asked her

something bad, she told him to go out immediately and he did not want to go and then she told me to call Mrs. Horn he said, Mrs. Horn was asleep already and she would not hear anything and then she asked him to get up anyhow and call Mrs. Horn and then when I got out of bed he went out of the room; the next morning I told Mrs. Horn and she said she would put him out of the house as soon as possible. I have been in the habit of going to Mrs. Horn's place for a situation one year and a half, she got me places during that time but she never sent me to bad houses. I did not see Mrs. Staubsandt from Union Hill at Mrs. Horn's place. Neither I or Lizzie Paff asked Reinsberg to get us ice-cream.

Rosie Kalnavoitz sworn.

I am a servant but am doing nothing at present, I got a situation through Mrs. Horn in 60th Street with Mrs. Schlesinger, I don't know the number, it is on the east side of Third Avenue, I was in Mrs. Horn's office during the month of May waiting to get a place, I know Miss Ehrenreich only from being twice at Mrs. Horn's place. I was there when she started to go to Union Hill, I saw Mrs. Staubsandt there that day, she asked Mrs. Horn, have you got a girl for me? Mrs. Horn said the girls have gone to dinner, they were at dinner in the kitchen, Mrs. Horn asked Josie Ehrenreich if she would take that place and then she asked, what work have I to do. Mrs. Staubsandt said she would have to work upstairs and to wait on the table, she said that she thought the girl would be too weak for the work. Mrs. Horn said if she

did not want her she would give her another girl. Mrs. Horn said to the girl that she should go and look at the place and if she liked it to stay there and if she did not she could come back. Then Josie went away with the lady, she took her things along with her, Mrs. Horn said she could leave her things there, she need not take her things along with her but she took the things along and it was not long before she came back, it was the same night, she made a row, she said that Mrs. Horn had sent her to a bad house; then Mrs. Horn said she did not know if it was a bad house or not; she raised such a row that the ladies that were there went away, Mrs. Horn told her to be quiet and not to make such a noise and the next morning the cook came from this lady in Union Hill and said, you must send us another girl, we cannot use that girl, she is too weak to work. Mrs. Horn said, I cannot give you another girl because this girl came back and said I sent her to a bad house and made a fearful noise about it. That was at eight o'clock in the morning and Josie came to get another place; the cook from Union Hill went into the kitchen and asked Miss Ehrenreich if she had been sent to an improper house and she said yes..

Cross Examined.

I do not know Annie Conradi, Mrs. Schaefer was in the intelligence office, when Miss Ehrenreich came back and complained that she had been sent to a bad house she spoke very loud and was very indignant, Mrs. Horn told her to keep quiet and put her out. I only saw Mrs. Staubsandt at the office once, she said she came there for a girl, she took dinner with Mrs. Horn. I was at

that employment office for three weeks waiting for a situation, Mrs. Horn did not board the girls that were waiting for situations, only myself. I never saw anybody that came to engage servants dine with Mrs. Horn except Mrs. Staubsandt; they did not appear to be old acquaintances. I have never been in any office except Mrs. Horn's. I have never spoken with anybody about this case, Mrs. Horn brought me here as a witness but I have not seen her since the 18th of May and never talked to her about what I was going to testify to. Reinsberg was not there at the time Josie Ehrenreich went to Union Hill but he came there after dinner.

E Lizzie Paff sworn and examined.

I am a servant girl and worked last with Mrs. Gessie, corner of Lexington Avenue and 23th Street, a private family, Mrs. Horn got me the place. I know Hedwig Pritz I lived at Mrs. Horn's house in the month of May and occupied the same room with Miss Pritz, I remember one night when Reinsberg came into the room at one o'clock, he brought ice-cream with him and sat down on my bed; then he awakened me and asked me if I wanted to eat some ice-cream and I said no, then he asked me if I wanted to be used by him and I wanted to get out of bed but he held my hands so I could not get up. I told the other girl to get up and call Mrs. Horn, Mrs. Horn said she would send that man away as quick as she could.

Cross Examined.

We slept in the kitchen and the door was not locked, I did not ask that man to fetch us in ice-cream, I did not

say to him, "you spent two dollars for clothes on a girl and that he could afford to spend money on me for ice-cream. I told him to go out of the room and he went out; when the other girl started for Mrs Horn he ran out of the room and then we both went to sleep.

Anna Butt sworn.

I know the Defendant and she always directed me to very respectable places, I never cared to notice or talk with Mr Reinsberg, I talked with Mrs. Schaefer, she came up to the house and told me she was going against Mrs. Horn in some case, that she was in trouble. I asked her what it was about and she said, about sending a girl fifteen years of age to a disorderly house. I says, I did not believe anything of the kind, if a girl did not want to go she was not compelled to and Mrs. Horn never compelled a girl to go to a situation. I was not present when that man came and got the girl for the Compton House Mrs. Horn did not send me to Delancy Street, she always directed me to very fine families, I am not married and I live home with my father and mother.

Doratheia Horn sworn.

I am forty-six years old and am married and have got children, I have kept an intelligence office at 168 Third Avenue four months, I have never been arrested charged with any crime before. I did not send Josie Ehrenreich to Mrs. Staubsandt's place in Union Hill knowing that to be a house of prostitution and did not send here there for that purpose, I did not tell Josie that I had been to

that house every Sunday, I was there once four or five months ago. I sent a girl over there to work in the kitchen. The day that Miss Ehrenreich went to Union Hill Mrs. Staubsandt came in the morning after ten o'clock when the office was open and asked me if I had a girl for her to work as a chamber-maid and upstairs. I said, it is early yet there are no girls here. She said, I will go out shopping and come back again towards noon; she came back and Josie came there, she had been in Brooklyn working for a fortnight and said she wanted a situation. I said then to her that I could not get another situation for a girl who was only a fortnight in a situation. The gentleman from Brooklyn where Josie had been engaged said she was a girl that would not work, she would only read the newspapers and do nothing. Josie was in the office and Mrs. Staubsandt said, that girl is too weak and too small, I have much work in summer time and she is too weak for me; then Miss Ehrenreich came into the kitchen to me and said, "I am strong enough I want such a situation." Mrs. Staubsandt said, I will try her if she insists on going with me, and then she hired her for twelve dollars. The girl sent for her things and then I said when she came back, "if the lady is not satisfied with you you had better leave your things here." She said, "I will like such a situation and will take it and then she went with her, but she came back again the next morning and made a fearful noise there and said that that was a bad house. I said I did not know anything about the house being bad, I had a girl that was seven months in a place and said she had a good situation

and the lady gave her fourteen dollars. Josie went around the rooms and continued to make a noise. I told her to keep still and if the situation did not suit her that I would give her another one, but she did not stop.

During this time when she was scolding the cook came in from Union Hill and said, "we could not keep that girl, she was only half an hour there." She said she was very forward, she sat down there and was reading the papers and the lady took the girl's things and gave them to her and told her, "if you don't like it here, then go in God's name." I hired Mr. Reinsberg to work for me and gave him a pair of shoes when he first came. I never told him that he must look for girls to send to houses of prostitution and never told him that he would get five, seven and ten dollars for every girl sent to a house of prostitution. I said to him that I wanted him to interpret for me as clerk and to speak English to my customers

Hedwig Pritz and Lizzie Paff complained to me about him going into their room one night and I discharged him for that. I know Annie Conradi and got her a place in 17th Street in a French restaurant and also in 106th Street uptown to nurse a child. I never sent her to any place in Thompson Street, I know Emma Schaeffer, I did not send her to 33 Bayard Street; she took six places but did not go to any of them, I was not there when any woman called to take her to a place in Bayard Street. She got a place in Park Row with Mrs. Hoffman for four dollars a week. I never sent a girl to a house of prostitution knowing it to be such. May be I got twelve situations a week for girls, it is in the books.

Cross Examined.

I have been in this country four years, it is seven months since I first knew Mrs. Staubsandt, she came to my office in 22nd Street wanting a girl for housework, I visited her about four months ago because she invited me to go over to see how she lived, she was friendly to me, it was on a Sunday when I went, it is a hotel. I did not write to Mrs. Staubsandt or send anybody to her since I have been arrested. I have seen my husband and daughter since, the lawyer has not spoken to me about having Mrs. Staubsandt as a witness. I do not recollect Mrs. Snow of 33 Bayard Street calling at my office, I do not recollect taking a little green ticket out from under the table-cloth and giving it to Annie Conradi and telling her to take it to Thompson Street and be sure not to show it to anybody but the man there and give it to him. George Brunner is the name of the clerk I had before Reinsberg, he got married and went to another city, the clerk I had before that was Otto, a German, I do not know where he is. I do not know Mrs. Froelich of 16 Delancy Street, I never saw or heard of her. When Josie Ehrenreich came back from Jersey she complained that the house was a bad house, that there were girls and men there. She was very insulting and spoke very loud and was telling all the girls where I had sent her to. The cook came over from Mrs. Staubsandt for another girl. I did not send her another girl, I did not go over to the house in Jersey to see whether it was a bad house or not, it was shortly after that I was arrested and I had not time. I am in prison now nearly six weeks, it was about eight

days after I sent the girl to Union Hill tht I was arrested. The two girls that were on the witness stand complained to me that Reinsberg had been in their room and tried to force'oe of them to do something improper.

I did not complain to the police in the morning about it but I sent him right off that day.

Lewis Boelling sworn.

I am a cigar manufacture at 108 Third Avenue, I am the landlord of 108, the Defendant is a thant of mine, I know her since the first of March, she paid me the rent and I believe she is all right, I found her correct.

Theresa Albrecht sworn.

I keep a restaurant at 33 Park Row, I called at Mrs. Horn's office for girls, I have had three servant girls from her and I always found her honest in her dealings.

I do not know Mrs. Staubsandt, Mrs. Froeleich or Mrs. Snow, but I do know the girl Schaeffer, I engaged her and gave her ten cents car fare and she promised me surely she would come but didnot.

Charles Wolfe sworn.

I am an importer of ribbons at 423 Broadway, I know Mrs. Horn two years and a half personally but I know her daughter four years. I have been in the habit of getting servant girls from her, her character for honesty is good.

Nettie Siegle sworn.

I am married, my husband is a merchant in this city , he has a tailor store at 560 Third Avenue and at the corner

of Spruce and Nassau Streets. I know the Defendant Mrs. Horn from the 15th of June last year, I have got servants from her and her general character is good, she has been very honest in her dealings with me and very staisfactory, I have recommended her to other people desiring servants and people have recommended her to me.

I do not know Mrs. Staubsanit, the proprietress of the Vair View Hotel, Union Hill, N. H.

Lena Siegle sworb.

I am married and my husband is a merchant tailor at 37th Street and Third Avenue and also at the corner of Spruce and Nassau Streets, he is the brother of the husband of the last witness, I know the Defendant for three years and got servants from her and called at her place, she is avery fair woman to deal with and I always found her honest in her dealings, she always sent me good girls and I have recommended her to ladies of my acquaintance. If the girls did not prove to be satisfactory that was not her fault, when they did not suit me I discharged them.

I do not know Mrs. Staubsandt, Mrs. Snow or Mrs. Froelich. I do not believe the Defendant would send girls to disreputable houses

Sarah Kronse sworn. I am married and my husband does business at 383 Bowery, I know the Defendant three years and got servants from her, I know her to be a respectable woman and always found her honorable in her transactions.

The Jury rendered a verdict of guilty with a recommendation to mercy.

I am the person referred to in said affidavit, as Mr. Ernest, and keep a barber shop at 59 Warren Street. In the said affidavit of Mary Frances Odell, occurs the following language:

"I think it was in the month of March or April when
"Mr. Ernest, who keeps a barber shop at 59 Warren Street,
"and who received all the mail directed to us, came up to
"my room with a letter directed to Josie Ehrenrech, the
"letter was handed to her, she at the time was sitting at
"the table. She opened and read it, it consisted of two
"pink and two white sheets of paper. After she finished
"reading the letters she laid them on the bureau, and Mr.
"Ernest who remained in the room all this time requested
"her to get a pint of beer. While she was so doing Mr

The above letter came to my office during my absence and was read by my nephew Mr.Charles H.Thomas, the letter being unsealed. I am further informed that after this letter had been read by my nephew, our book-keeper, Mr. Betz went to Mrs.Odell's residence at 43 College Place for the purpose of assisting her with money. At her residence, the bookkeeper, as I am informed, found Mr.Odell, the husband, whom she had represented as dead, on the 22nd of October at St.Luke's Hospital, standing in the doorway of said house, and Mrs.Odell in the house. After my bookkeeper had thus ascertained that the husband, for whose burial I had paid, was still alive, he came away from the house without leaving the money which he had taken to give her, and on my return from Babylon, these facts were communicated to me. I thereupon went to see Mrs.Odell and on my arrival at her house I found Mrs.Odell there. I asked her how it was

Mary Francis Odell of said City being duly sworn deposes and says: That she is married and resides at No:59 Warren Street in the said city and that she is Janitress of that building. That she has known Josie Ehrenheit the girl whom the above named defendant was charged with having abducted, for the last past five months. That she became acquainted with her under the following circumstances:

That said Josie Ehrenheit called on her at her residence and asked her if she wanted to do a job of scrubbing for her at Mr. Heim's Restaurant, No:43 College Place, where she, said Josie, was engaged as a servant. That she could not do the scrubbing as her foot was sore.

About 15 minutes after this said Josie Ehrenheit came back and said that Mr. Heim had ordered her out because she didn't do the scrubbing and then told deponent that she did not have any place to live or go to. That deponent then told her she might room in her house until she got a place.

Deponent then asked her if she had a trunk and she answered "no," and asked deponent to lend her a sheet to tie up her ~~things~~ clothes in and then said Josie and deponent went to Mr. Heim's house and packed up her things.

Deponent helped her to carry the things around to her house and she came to live with deponent and remained there for three days, when a man came to see her and said he ^{was} ~~said~~ her brother and took her away from my house.

Next night she returned again, saying her brother took her to a place in Ludlow Street where she could not live with the woman residing there, saying it was her brother's girl and she could not stand her.

She then remained with me for about three months and was receiving letters from a man she called "Adolph" who resided in Kansas City, whom she told deponent she was going to marry and requested deponent not to tell her brother anything about the letters. Deponent went to the Post Office with her on several occasions and got letters addressed to her from Kansas City.

She only paid deponent \$1.50 during all the time she resided with her, saying she would pay her when she got her money from the man in Kansas City whom she said she was "trying to beat."

I think it was in the month of ~~March~~ or April when Mrs Ernst who keeps a barber shop at No. 59 Warren Street and who received all the mail directed to our building, came up to my room with a letter directed to Josie Ehrenheit. The letter was handed to her, she at the time was sitting at the table. She opened and read it; it consisted of two pink and two white sheets of paper. After she finished reading the letters she laid them on the bureau and Mrs Ernst who remained in the room all of this time requested her to get a pint of Beer.

While she was doing so Mrs Ernst picked up the letter and after reading it said, that the letter showed that she, Josie was a married woman and that the writer was looking for her husband, but that her husband had left Kansas City and he could not therefore be found and she might as well have him, the writer, who was the Adolph before spoken of.

On or about the 28th day of March she brought a suit against her former employer Mr. Heins in the First District Court to recover wages due her.

I went with her either in the latter part of March or beginning of April to the Court to see a Marshal by the name of Louis Levy who had charge of the matter for her.

On our way to the Court-room she asked me if she gave me the money to release my dress from the Pawn Office where it was pledged, would I go to the Atlantic Garden with her where I could make more money than by the use of the scrubbing brush, and said that she would get gentlemen there to treat me to nice wine suppers. I replied that I didn't care about that kind of business and refused to accept her offer.

On this day while on our way to the Court House to see the Marshal she met a man at the corner of Warren Street and Broadway whom she ~~addressed~~ introduced to me as a Professor. He was attired in dark clothes and a light derby hat. He was a light complexioned man and wore eye glasses. He took her arm and walked with us to the Post Office and from there to the Court building and then back again with us as far as the stoop of my house, where he remained standing talking to Josie. He did not want her to leave and as I desired to go up-stairs to my room I asked her for ten cents; she said she didn't want to give me any money in that man's presence as she was afraid of him, that he had taken all of her money, that she had made in the beer business in Brooklyn. I then took her by the arm to bring her up-stairs to my room but he took hold of her other arm and took her away from me and walked away with her. As she was leaving she turned around and said to me she would be back in a little while.

About one hour after this she came back and I saw her in the hall-way of the building talking to a man who worked at that time in a printing establishment in the neighborhood and who was known as, "Tommy the Printer".

After this man left her he came up-stairs to our room and said to my husband in my presence that he had ~~it~~ all fixed ~~with~~ for the night with Josie; that he intended to have a good time with her, that he was going to meet her at the corner of ~~Brooklyn~~ Bayard Street and Bowery between 7 and 8 o'clock. This man called on Josie at my house on different occasions, one of which he had her on the sofa in my room, (she having only a chemise and petticoat on) hugging and kissing her, she requested me to leave the room, which I declined to do and I said to her, she ought to be ashamed of herself, and do such things and she replied to me, it was none of my business, the next day I informed my husband of this and he told me the best thing I could do was to get her to look for another place of residence.

I told her of this and she left me, on another occasion before this another man named Brockway who is in the Express Business in Murray Street was in my room with his hands under her clothes laying on top of her on my sofa. After I ordered her out of my house, I was taken sick and confined in my house for three weeks she came there and brought me some oranges, and said if I would only do as she wanted me to, she could lend me clothes as she had plenty.

I told her "no", I was better off the way I was; After that I heard no more of her.

While she was living in Alabama Avenue Brooklyn she came over to my house with the man whom she called "Professor" and whom I would recognize were I to see him.

He did not come up-stairs, but stood at the stoop, and waited until she came down, while she was up-stairs I went down-stairs for a pint of beer, when I got to the street several men who work in the building asked me if I was looking for the dude, that was with Josie. He was standing leaning against my stoop at the time. The men work in the house yet, and I think they will be able to recognize the man.

Annexed hereto is a copy of a letter ~~has~~ received from Josephine Ehrenreich and a translation thereof.

Deponent further states that she does not know the defendant and never communicated the foregoing facts to her or her attorney until the 11th day of July 1887 when she sent a note to Mr. Charles Steckler, Counsel for the defendant.




