Photographs were taken at Muhammad's Mosque #25, at 257 South Orange Ave. Newark, N.J. in March 1963, during a karate demonstration by members of the Fruit of Islam (FOI) at Muhammad Mosque #25. Identical photographs and various other photographs taken at the same time were displayed at Muhammad Mosque #25 and orders were taken from those who wished to purchase copies. Source advised that he was not present when the photographs were actually taken, but source assumed most of them were taken by FRANKLIN DURANT, aka Franklin X. (It is noted that a stamp reading "FRANKLIN DURANT, Photographer, 113 Rose St. Newark 8, N.J." appears on the back of the photographs).

All individuals in photographs are active members in Muhammad's Mosque #25 except HAYER, FRANKLIN DURANT and CHARLES JOHNSON.

INVESTIGATION- PATTERSON, N.J.

On July 20, 1965, the assigned Detective, accompanied by Det. Confrey, MNHS, proceeded to Patterson, N.J. endeavoring to obtain additional evidence or information that would assist in the Malcolm X Little investigation.

Det. Howard Klein, Patterson, N.J. P.D. informed the assigned of a dispute that had taken place in a pool room in Patterson, N.J. between two Black Muslims (TALMADGE HAYER WAS ONE) and the proprietor of the establishment. An altercation took place because the owner did not wish to purchase the Muslim newspaper "Muhammed Speaks" and made a remark to the two sellers.

Det. Klein contacted the above businessman and received his assurance of being available for the ~~xxx~~ prosecution of the defendants in the Malcolm X trial.

1. Subject was born on 3/16/42 in Hackensack, N.J. *Mar 17, 1942*
2. He was arrested on 11/7/63 in Patterson, N.J. on a charge of receiving stolen property (Guns). He was residing at 530 Ellison St., Patterson, N.J. and the guns were found there. The burglary was at the LIBERTY FIREARMS CO. 327 BROADWAY, PASSAIC, N.J. and a large quantity of guns and Ammo. were stolen. (Not all Recovered.) Also arrested at this time were ROBERT CHAPPEL (same address as Hayer, now doing time in N.J. State Pen) JOHN HENRY MCKINNEY, 569 MAIN ST., HORACE 4X WRIGHT, 31 HARRIS ST., all from Patterson.
3. Subject arrested in 1960 - Disorderly Person - 3 Mos. S.S. Patterson, N.J..
4. Family members of the MOSQUE # 25- NEWARK, N.J.. HORACE, WAYNE, CONNIE, and JOSEPH 12 X. all give address as 347 MARSHALL ST., PATTERSON, N.J. (Hayers family address.)
5. *Not pertinent* TALMADGE X HAYER registered with the NEWARK MOSQUE # 25, on 9/23/62.
6. Selling of MUHAMMED SPEAKS NEWSPAPER in Patterson, N.J., can be attested to by DET. KLEIN of Patterson, N.J..
7. Fight in the Poolroom over the owner not buying the newspaper, can be attested to by the owner of the poolroom. *Check date*
8. Karate pictures received from the FBI.
9. Subject attended meeting at the Sons of Veterans Hall in Patterson (MUSLIM MEETINGS) - *Sacklen*
10. Hung out in IKES TAVERN AND THE PLAZA DANCE HALL with group that are all Muslims according to Patterson, PD.
11. Believed to have attended the Muslim Dinner at the Audobon Ballroom on 2/16/65. *Mama T. B.*
12. Believed to have visited the Shebazz Rest. on Lenox Ave. on several occasions.
13. Was he part of the Honor guard for ELIJAH MUHAMMED when he held a rally in Phila. in 1963. (FBI believes they have a picture where he is standing as a guard.)
14. His sister -in-Law is named SHIRLEY EASON, does he know AHMAD EASON, son of BETTY 5X EASON of Patterson, N.J.
15. Does he know CHESTER CULLUM and did he stay with him in an apartment on 113 ST. & MANHATTAN AVE. in the spring of 1964, and did he tell CULLUM that he was a MUSLIM and that he was from N.J. (CULLUM is confined to ELMIRA at the present and was interviewed by the assigned, states this was in the apartment of JAMES SHEBAZZ and HAYER STAYED TWO NIGHTS.)


