

Dear Sir:

The Mayor transmitted to me your letter to him of 5th inst., urging that 50th Street, west of 11th Avenue to the water front be opened, paved and provided with proper sidewalks.

In reply, I beg to say that chapter 223 of the Laws of 1893 authorized the Board of Street Opening and Improvement to change the grades of 48th, 49th and 50th Streets, from the centre line of 11th Avenue westerly, to correspond with the grade of 12th Avenue.

The matter was before that Board in September, 1893, and, after several hearings, was laid over. The obstacle to the accomplishment of the desired improvement is that the owners of the abutting property have not petitioned for the alteration of the grades, and the cost of the changes would entirely fall upon the City if the Board ordered the changes without such petition.

The matter will probably come up again at the next meeting of the Board of Street Opening and Improvement, as it is no doubt desirable to settle the question of grades and improve these streets as early as possible.

Your letter of 11th inst., complaining of delays in executing necessary street improvements in the section of the City which includes 96th, 97th and 98th Streets, Park, Madison and 5th Avenues, was duly received and referred to the respective bureaux which have charge of the different classes of improvements.

From reports which I now have, I find that there has been no delay on the part of this Department in executing ordinances and resolutions providing for such improvements, except the delays which are necessitated by the requirements of law in advertising, letting and executing public contracts.

Bids for the contract to pave 96th Street, between Park and 5th Avenues, are to be opened on the 22nd inst; a resolution for the repaving of 95th Street is now before the Common Council; in 97th Street there are as yet no water-mains nor gas-mains which must be placed before the street is paved.

An ordinance was recently passed to pave Park Avenue, from 95th to 97th Street. The surveys for this work are now being made, and the contract will be advertised and let at an early date.

An order has been given to the Consolidated Gas Company to lay gas-mains and light public lamps on 97th Street, between Park and 5th Avenues, and on the west side of Park Avenue, from 96th to 97th Street.

In respect to the improvements of regulating, grading flagging and curbing streets and fencing vacant lots, the Department can take no action until directed by ordinance of the Common Council, and in every case, as soon as an ordinance is passed, the City surveyors are appointed to make preliminary plans and estimates, and all other measures are taken to execute the ordinance.

Your letter of 6th inst. to the Mayor, calling attention to the play-ground on 50th Street below 11th Avenue, which you desire to have retained, was referred to me.

In reply, I beg to say that the Captain commanding the U. S. Receiving Ship "Minnesota" addressed a request through the Mayor a few days ago, that 50th Street, from 11th Avenue to the River, be graded, curbed, paved and flagged as speedily as possible, so as to give convenient access to the river front, and, in the investigation which was made on his letter, it was found that by chapter 223, Laws of 1893, the Board of Street Opening and Improvement was empowered to establish grades for that and other adjoining streets west of 11th Avenue to correspond with the grade of 12th Avenue, with which the old grades do not coincide. The matter was under consideration of that Board for some time and then laid over. It is now found that the establishment of a new grade, which is really necessary, requires the petition of the owners of not less than two-thirds in frontage of the property on the line of the street, and it appears that the entire property is owned by the Astor Estate. It is probable

that the Estate would petition for such change of grade and possibly regulate and grade the street to the new grade at its own expense if the matter were properly represented to its representatives. The subject will come up for consideration and action at the next meeting of the Board of Street Opening and Improvement.

Dear Sir:

The Mayor has referred to me your letter to him of 17th inst., alleging errors in the making of plans for the bridge over the Harlem River at 3rd Avenue.

In reply, I beg to say that section 1 of chapter 413 of the Laws of 1892, which authorizes the construction of the bridge, prescribes that it shall be as nearly as possible in the position of the present or old bridge.

Section 2 of the Act provides for the construction of a temporary bridge.

Section 4 reads as follows: "The expense of constructing the said bridge and approaches shall not exceed one and one-half million dollars and such further sum which may be paid for the lease of land" as mentioned in section 6 thereof, also to pay awards and compensation for lands taken for the purposes of the bridge.

The engineers who were employed by authority of the Board of Estimate and Apportionment to draw the plans for the bridge presented several plans under the limitation of \$1,500,000 expenditure for construction.

Public hearings were had in the matter before the Board of Estimate and Apportionment, and the present plan was adopted after mature discussion and consideration.

Considering the limitations as to the location of

the bridge, prescribed by the Act, the engineers had little or no voice in that matter.

The Chief Engineer of the Croton Aqueduct states that your estimate as to property to be taken under your scheme or plan would be found totally inadequate, and the cost of construction, including the approaches, pavements, etc., would exceed the limit of \$1,500,000 prescribed by the Act.

The Mayor has referred to me your letter to him of 12th inst., referring to a letter you addressed to this Department on the 18th ultimo. On receipt of the latter communication, the several matters therein complained of were referred to the Bureaux having jurisdiction over the same.

In the matter of the temporary awnings placed across sidewalks in stormy weather in front of a certain class of buildings, the Superintendent of Incumbrances reports that, notwithstanding your statement alleging the exercise of undue discretion or favor, all parties maintaining such awnings were notified, on receipt of a previous complaint, to remove them, and all except a few complied. In the latter cases the awnings were taken to the Corporation Yard.

I concur in the view of the Superintendent of Incumbrances that it is impracticable to carry out your suggestion of making a persistent crusade against temporary awnings in stormy weather. In considering this question, it must be borne in mind that this Department is limited to a force of six inspectors of incumbrances for the entire territory of the City, and cannot there-

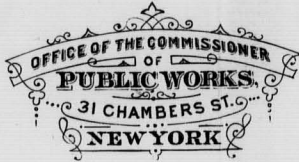
