

Dear Dr. Finley:

In answer to the communication from the Mayor with reference to the condition of the engines, I have requested the Chief Engineer to make an examination and he reports that all the engines are in good working order, with the exception of engine #3, which is undergoing repairs and not being used at the present time. Occasionally a wedge bolt breaks, but this does not cause any serious damage, as the engine is immediately stopped and repaired. Accidents of this kind are liable to occur to any engine. During the time the contractor was rebuilding engine #2, and before it was accepted by the College, one of the rods connected with the engine broke and caused some damage to the ceiling. This I think was two or three years ago.
