Date of This Report: 3-12-65

1. At about 3:15 Pm, this date, Charles (37X) Morris, M-N-45, residing 1851 Third Ave., Apt. 9F was interviewed at the Manhattan North Boro Det. Office.

2. Stated that he belonged to Mosque #7 for three years and that he defected at the same time that Malcolm did.

3. The above was present in the Audubon Ballroom on Feb. 21, 1965 and was seated in Booth #49, when Malcolm was introduced. He heard shots ring out and immediately fell to the floor and did not see anything. After the shooting subsided, he left the Ballroom through main entrance.

4. The above served with a subpoena for appearance for 3-16-65.

5. Morris formerly resided at 314 E. 143 Street, Bx, with his wife, Ruth and three children.

6. Further stated that he was a patient at Rockland State Hospital for about 60 days in 1960 or 1961.

INTERVIEW OF CHARLES 37 X MORRIS

At 11 AM, 4/30/65, the undersigned accompanied by Det. Con-Frey, interviewed Charles 37x Morris at the City Prison, N.Y.Cty.

Subject states that the KKK and the Black Muslims are one and the same. Says that Malcolm told him of the meeting in Atlanta with the Klan at which time one of the Klan officials was bragging about a Jew that they had killed and tortured. ( Says that "Hunt" a Texas Millionair, is the money behind both organizations. )

One week before Malcolm was suspended from the Nation of Islam he went to a meeting of top communists and was told to leave the Mosque and start his own organization and split the Nation of Islam in half. Thus the communists could exploit them and ferment strife, Elijah found out about this meeting and sent a letter to New York informing Capt. Joseph.

After Malcolm came back from his trip to the East, the first time, he started to spout the Communist line and Charles had an argument with Malcolm and was told to mind his own business. It was at this time that James Shebazz, Langston Savage, and " Hannibal" were training the Blood Brothers. These same youths were brought to the Hotel Theresa to a meeting of the OAAU and introduced to the organization by James Shebazz. Malcolm also introduced these youths to the organization from the stage of the Audobon Ballroom. Morris says that when he drove Malcolm home that night he told Malcolm that he was steering these boys wrong and finishing there lives and was told to mind his own business.

Sheik Hassan was sent back to this country with Malcolm to assist him in any way possible. Dr. Schwabi ( Phonetic ) of the Arab consulate was the person that gave Malcolm his orders

Believes that James Shebazz, Langston Savage and Rueben Francis were involved in Malcolms death. James Shebazz's father was a dedicated communist all his life. ( Also says that Shebazz told him that he was named after a US President and that he is probably not using his real name). Further states that he believes Shebazz received his communist training in Korea and that he and Langston Savage are dedicated, professionally trained commy agents. At the present time there are about 30 groups of young men in training ( Weapons Etc.) in harlem each group composed of ten to twenty men. He says that they are only waiting for the right moment to explode. Malcolms death was going to be the trigger for this explosion but the police acted too fast and they couldn't blame the slaying on the white man. Muslims that did the job were only tools for the commys who wanted to create a martyr and provoke an incident.

Betty Shebazz was not getting along with Malcolm and he was going to leave her and sh knew it, thats the reason that she is not co-operating with the investigation , shes glad hes dead. Also says that she didn't go to Mecca because women aren't invited in the Islamic religion, she went there to receive further instructions. The child she is expecting will be called the God of the West and will be exploited.

Charles had a 3 hour conversation with Malcolm a week before his death at which time he tried to reason with Malcolm and tell him that they ( The commies ) were only using him and as soon as his usefulness was over they would dispose of him. Malcolm admitted this but said that it had already gone too far, and that if they did kill him it would only be a matter of time before they would also kill Charles. Charles believes that he will be killed because he knows too much. He used to go to the Arab consulate and pick up boxes of literature for Malcolm's group to distribute says that when he read this stuff he realized what the organization was being used for. He further states that Sarah Mitchell ( Who he knows is very close with Langston Savage and is also a red ) invited him to her apartment but he feared that she was setting him up to be killed and begged off. She then asked for his address or phone number but he didn't give it to her. He thought it very strange that a woman who had never looked at him before suddenly found him attractive.

Charles Morris says that he is trying to do everything in his power to prevent bloodshed but he doesn't believe he can stop this from happening. Jesse Grey and numerous other leaders in Harlem are only pawns and are put up in the front to take the publicity .

he above had been staying away from recent meetings as certain ~~XXXXXXXXXX~~ incidents had taken place of which he apprised "alcolm; and when nothing seemed to be done, about them he failed to attend a meeting until the Monday after Malcolm's house was bombed.

a. It was brought to Morris's attention by several sisters that Benjamin Goodman had borrowed a some of money from them and was reluctant to repay them.

b. Monies collected to be used for bail purposes for those arrested at 116th St. for possession of rifles was misappropriated.

c. Other factions had been infiltrating the movement, of which Malcolm and James 67X were aware.

Morris had talked with Malcolm the week before the shooting at 135St and 5th Ave (in Auto) and was informed by Malcolm that things would be different now; that they were moving forward. he, then began returning to the meetings.

On 2-21-65, arrived at 2PM and sat down in Booth #49, already occupied by Robert 35X. Later joined by Sidney and Omar. Previously had known Sidney and Robert from Mosque #7. Sidney defected at same time as "alcolm. Doesnt know whether Robert defected or not but had been attending OAAU meetings.

Did not see any of the perpetrators or any weapons at the time of occurrence as he layed on the floor. After shooting, he left by the front door and when outside saw James 67X looking a P.D. car in which police were holding one person. Then went immediately to his auto which was parked at St. Nicholas Ave. and 165 St. and went home.
