During the early part of this year request was made for an issue of Special Revenue Bonds to the amount of One Hundred Thousand Dollars (\$100,000.00) for the purchase of Food Supplies &c., to provide for the needs of the department during the balance of the year 1913, the appropriations made being insufficient.

This request has not yet been acted upon but it should be considered in the calculation of the Total Net Increase which would then be only 221,287.68 had this amount been granted.

In the above mentioned request were eight items of Food Supplies aggregating \$73,653.00.

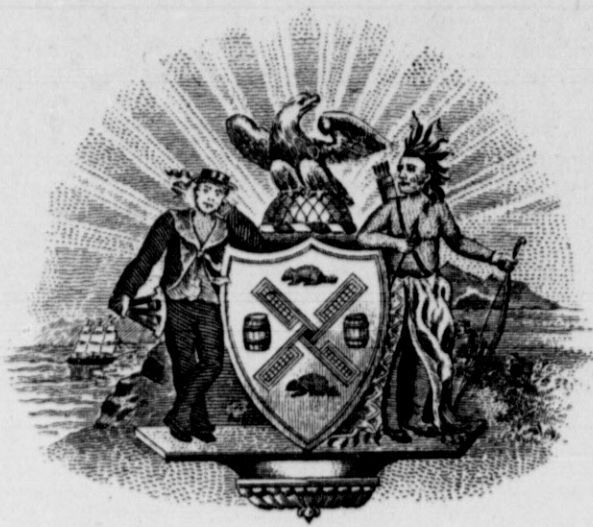
A comparison of the aggregate of Food Supply

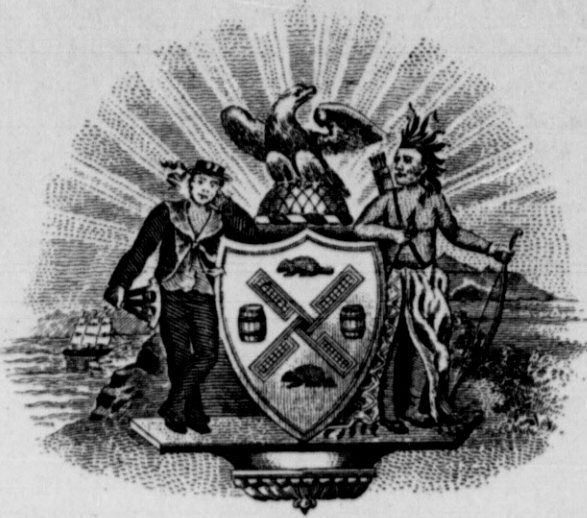

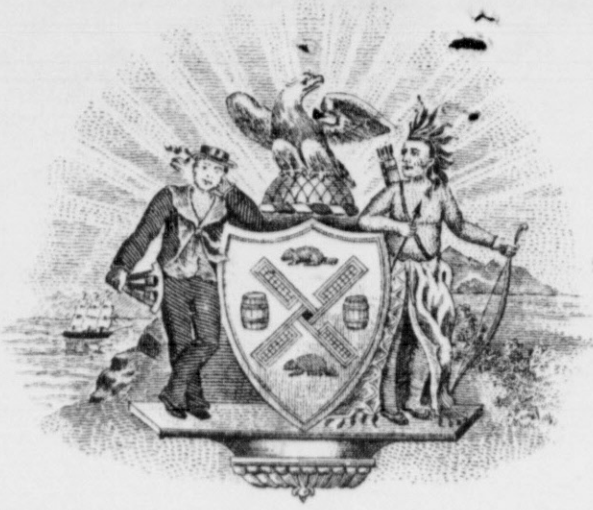

Honorable Sir:-

I most respectfully make application for reinstatement to the position of Keeper in the Department of Correction, Branch Workhouse, Hart's Island, from which position I was dismissed on October 31st, 1912.

The charge against me was that I had violated a regulation of the department in striking a prisoner. My reasons for making the application, briefly, are as follows: Prior to the charges, I had served twenty-nine years in the department and had never been brought up on charges, or had any charges made against me.

The testimony upon which my dismissal was based was absolutely false, but at the time of my hearing, this fact was not known to me. Subsequently I received information from various sources that the witnesses who testified against me had, with design, manufactured their testimony to accomplish my dismissal. Documentary evidence of this fact is now in the hands of my counsel, Alfred J. Talley of No. 165 Broadway, New York City, and I shall be glad to submit it.

I did strike a prisoner on the afternoon of October 5th, 1913, but the conditions under which the punishment was inflicted were such that it made it absolutely necessary for the maintenance of

discipline to do so. That I acted right under the circumstances is attested to by various witnesses, who since the trial, have come forward and are now willing to corroborate the fact that I acted properly in the premises and without any undue harshness or cruelty.

The prisoner who was struck committed suicide some four days after the punishment was inflicted, and the cause of his death was his own voluntary act, and was not due to the punishment I inflicted. The whole case has been investigated thoroughly both by the department and the Coroner and no blame whatever was attached to me by the Coroner.

During the month of October next, had I been permitted to retain my position in the department, I would have served thirty years, during which period, as I have said before, my record has been one without reproach or complaint.

My dismissal was unjust as subsequent facts have demonstrated and I believe that if you will investigate the circumstances, you will agree with me that I should be reinstated in my position in the Department of Correction. Should you decide to reopen my case, I will place in your hands all documents pertaining thereto and will summon, if you so desire, the parties who are the authors of said documents and who are willing to testify under oath as to the correctness and truth of the statements which they have subscribed.

Trusting that this appeal will meet with your ap-

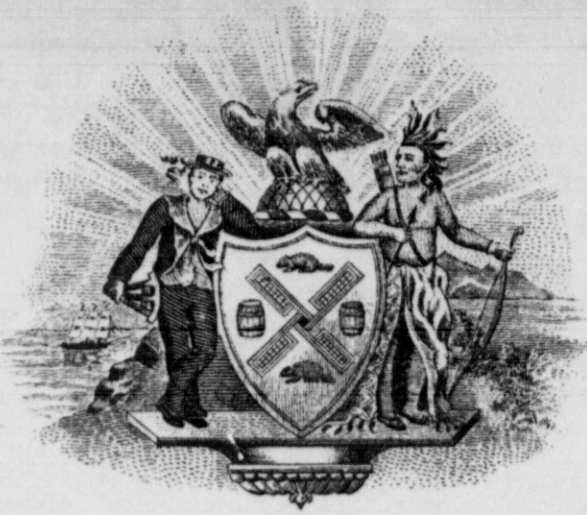

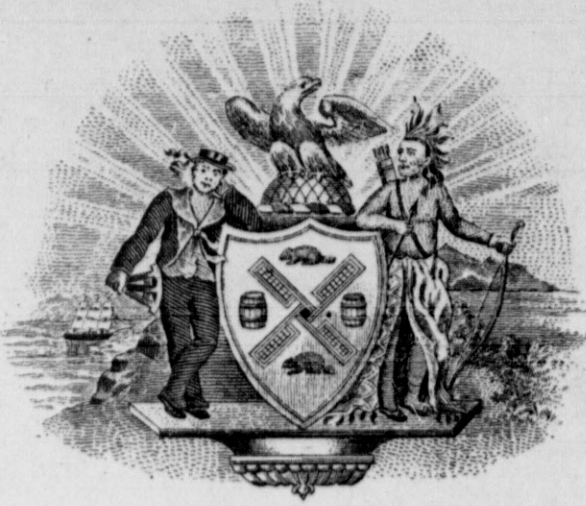

Dear Sir:

Replying to yours of November 5th, 1913, relative to proposed Ordinance, which gives the right to a writ of certiorari to removed members of the uniformed force of the Department of Correction, I would say that I appeared before the Committee of the Board of Aldermen and argued in favor of the passage of such an ordinance.

The reasons given by me at the time, were that I was desirous of giving full protection to the members of the uniformed force of this Department, so that a removal might be reviewed by the proper authorities, putting our force on the same plane as that of members of the Fire Department, the Police Department and the Department of Street Cleaning.

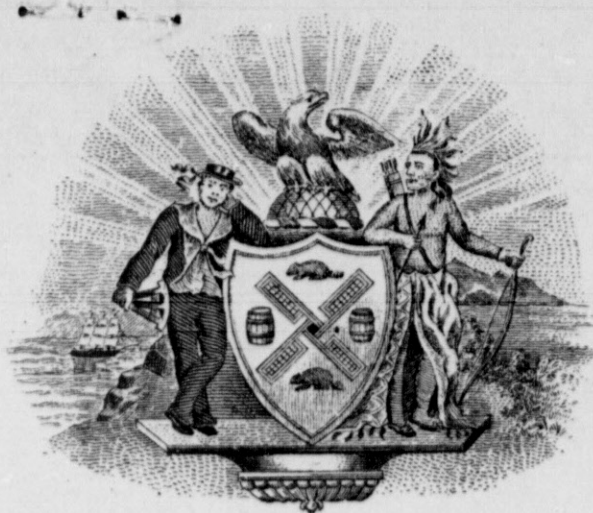
These reasons still hold good, and I would state that I still approve of the ordinance.

Furthermore, I would inform you that a bill of similar nature, was presented to the Legislature, but, at my request, it did not come out of the Committee for the reasons that I believed that the Home Rule Measure which was then under consideration, gave the Board of Aldermen power to regulate a matter of this kind.

Dear Sir:

Replying to yours of November 5th, 1913, relative to the division of Matrons and Keepers into three platoons, I would say that I also appeared before the Committee of the Board of Aldermen on this matter, and argued in favor of its adoption, for the reason that the State and the City are virtually pledged to an eight-hour work-day, and, as the keepers and matrons in the Department of Correction work on an average of twelve hours each day, I felt that something should be done to reduce their working hours. I, therefore, made a strenuous plea in favor of the ordinance as afterwards passed by the Board of Aldermen.

In answer to your request for an estimate of the increased amount of money required to put this ordinance into effect, I would call your attention to a letter which I sent to the Board of Estimate and Apportionment relative to this very matter, on October 29th, 1913, and which is as follows:-

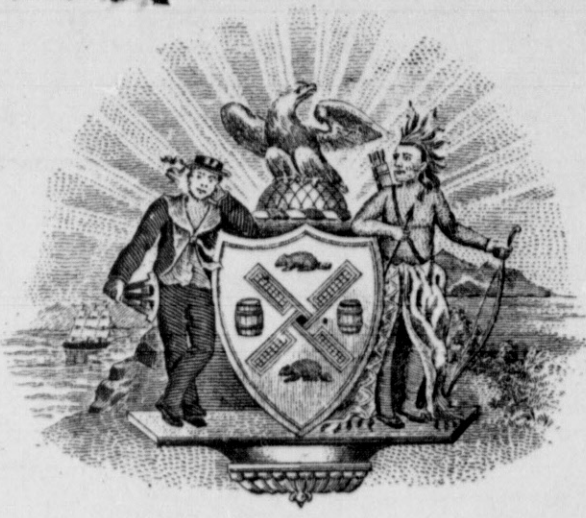

I have been informed that, at their meeting yesterday, the Board of Aldermen passed a resolution to the effect that 8 hours shall constitute a day's work for Keepers and Matrons. 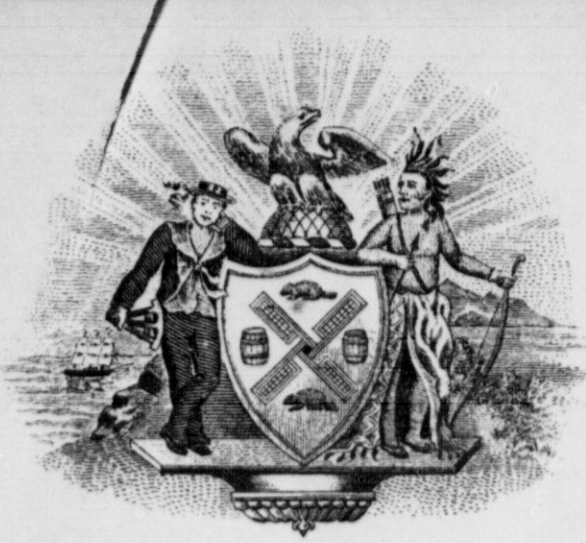

Dear Mr. Crowell:

In writing to you yesterday, relative to an ordinance passed by the Board of Aldermen, creating a Uniformed Force in the Department of Correction, I would say that I omitted one reason why such an ordinance should be approved by the Mayor. The reason is this: The Wardens, Head Keepers, Keepers and others mentioned in the ordinance, as constituting the uniformed force, are in a good many respects in a position similar to the members of the Police Department and Fire Department, and are subjected to criticisms and complaints from outside of the Department, the same as the members of the Departments mentioned above. Therefore, I believe that they should be protected in case of removal by the right of a writ of certiorari.

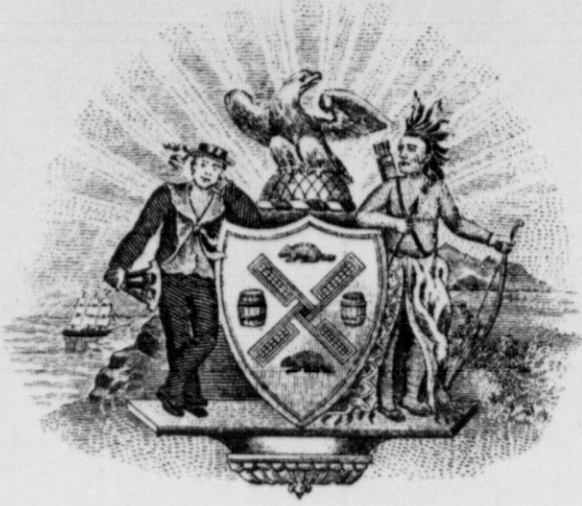
We, The Grand Jury of the County of Queens, called and sworn on September 23rd, 1913, and continuing during the month of October, having visited the city prison and jail in our county, and having been impressed with the general deplorable condition of the same it is our opinion that it is unhealthy and unsanitary, We cannot nor can any Grand Jury from a casual visit undertake to specify in detail the numerous defects and requirements, but inasmuch as former Grand Juries have called attention to this condition without avail we do hereby express our condemnation of the general situation and do strongly recommend that such action be taken as will result in a thorough investigation and complete report to the proper authorities as to this condition with a view to obtaining speedy relief and immediate action upon the same and we call upon the Mayor of the City of New York to instruct the officials having charge of such prisons to investigate this matter at once, and make a report which will call for intelligent appropriation for such alterations and requirements as are necessary.

We recommend that the incoming Grand Jury give the above recited matter immediate consideration,

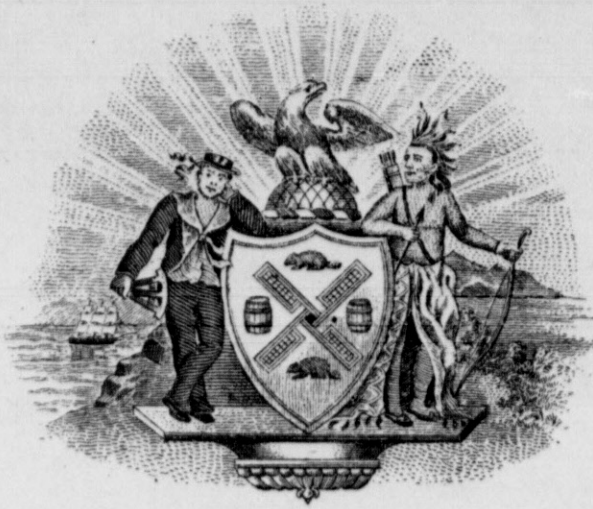

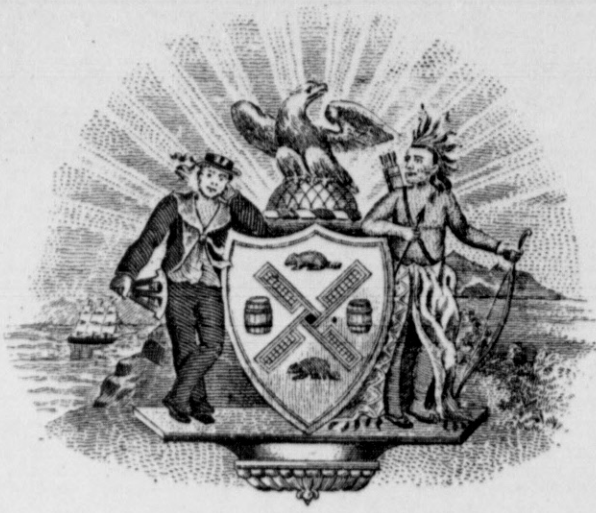

Dear Sir:

In acknowledging receipt of yours of November 13th, enclosing a presentment from the Grand Jury of the County of Queens, would say that the statements made in the presentment are true and that no one in the City Government would sooner see those conditions corrected than myself.

A history of the Queens Jail, covering the years 1912 and 1913, would not be amiss. Prior to June 1st, 1912, the jail was under the jurisdiction of the Sheriff of Queens County, at which time by act of Legislature it was placed under the control of the Department of Correction. One of the strong arguments in favor of the passage of the bill was that, if a change of jurisdiction was made, there would be some chance of bettering the conditions which existed in the jail that had been condemned by the State Prison Commission. We are happy to say that some things have been done in the way of improvements, but very much remains to be done before the jail can be called a fit habitation for prisoners. The jail came into the Department of Correction, as stated before, on June 1st, 1912, and, of course, no provision had been made in our 1912 budget for such a contingency, so you can see we had no funds available for repairs of any kind. However, we got some money by taking it from other Department sources; skimping here and there, neglecting some things which were necessary but which did not seem so important as a few of those bad ones at Queens, and thereby a little was done to make the Queens Jail presentable. Our Department Inspector made a thorough examination of the jail. He informed me of what was needed. From his reports, I quote the following:

"I must report that the sanitary condition of the plumbing system in the cells of this institution (City Prison, Queens) is in a very unhealthy and filthy condition, \* \* \* .

\* \* \* it is needless to say that the inmates are compelled to live in this foul atmosphere, which situation, it seems to me, should be put up squarely to the Board of Estimate and Apportionment for immediate action to allow a sufficient appropriation to put the sanitary conditions, if money for no other repairs is given, in a healthy and habitable condition for the prisoners incarcerated therein. To put the plumbing system in shape it will cost at least \$10,000.00".

Among our budget requests for 1913, the sum of \$85,000.00 was asked for the purpose of making the needed repairs at the Queens Jail. The money was denied me because the Budget Committee ruled that it should be a corporate stock request, so, on November 6th, 1912, a request was made on the Board of Estimate and Apportionment, as per copy of letter enclosed herewith.

The enclosed clipping from the City Record will show what was done with our request for money for improving the Queens Jail.

I desire particularly to call your attention to two allowances of money which were made to our Department, namely:

Installation of a laundry plant, \$3,000.00

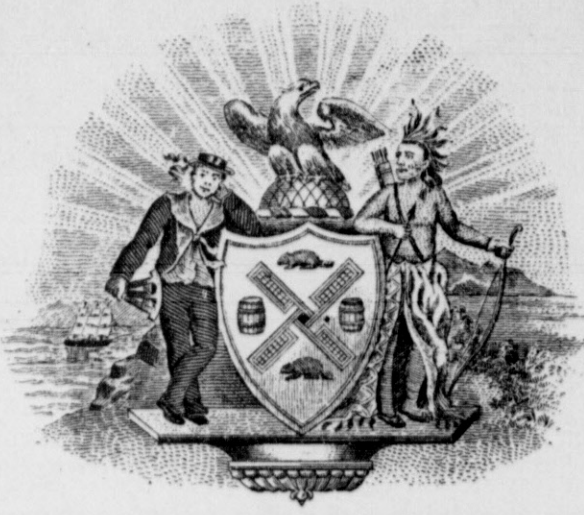
Installation of a sterilizer, 1,000.00.

These were given and there is no place suitable in the jail to install them. I am going to request the Board of Estimate and Apportionment to allow the transfer of the \$8,000.00 allotted this Department, for elevation of wall, to building an addition to the jail for laundry and kitchen purposes.

I make this long explanation to show that there has been no neglect by the Department of Correction in trying to improve things at the Queens Jail.

I endorse the recommendation made by the Grand Jury in respect to an investigation of the Queens Jail. I would suggest that you call upon the Board of Estimate and Apportionment to

appoint a committee for that purpose. And I would also suggest that the committee go further and make an investigation into the buildings of the Department of Correction on Blackwell's Island, Riker's Island, Hart's Island and of the City Prison, so that something may be done by the City to alleviate the existing conditions. But very little can be done to reform the inmates of our institutions unless we have the proper tools to work with, and the first step is to make the living quarters habitable.

The press is giving quite considerable space to a report from two women who entered the Auburn State Prison and remained there for one week. Nearly all who read the report of the interviews wonder why something has not been done to better conditions at Auburn. Yet in our Penitentiary at Blackwell's Island we have women confined in cells 3 feet 6 inches wide. We have no work for them to do. Their only opportunity of relief from the monotony of cell life is to go down to the corridor for meals, where they can exercise a little before and after eating. We have no workshops for them. A few of them are employed in cleaning around the prison. As you can see from the enclosed clipping from City Record, a request for \$250,000.00 to put up a prison for women with workshops, kitchen, mess hall, etc., was denied. New York City can not be proud of its prisons, and I beg of you to do all in your power to have a committee of the Board of Estimate and Apportionment make a report on them.

Thanking you for the opportunity given me to comment on the Grand Jury presentment and trusting that it may bring forth good in the near future, I am,

Dear Sir:-

I would respectfully ask the Honorable the Board of Estimate and Apportionment to authorize the issue of Corporate Stock to the amount of Eighty-Five Thousand Dollars (\$85,000.-), for the purpose of improving the City Prison, Borough of Queens, both as to sanitary conditions and the means of securely guarding the prisoners therein confined.

This institution (formerly Queens County Jail, under the jurisdiction of the Sheriff of Queens County) was on June 1st of this year taken under the care of the Department of Correction.

We made application in our Departmental Estimate for 1913 for \$75,000.- to put this jail in proper condition, as a result of a report on its condition made by our Department Inspector Mr. Charles Jamer, but were advised that this was a matter that should be provided for by an issue of Corporate Stock.

In order to meet the immediate sanitary needs of the situation Mr. Joseph D. Duffy a plumber, was ordered to make an inspection of the prison in order to ascertain what repairs would be necessary. He reported that it would be a waste of money to make repairs.

A copy of the report on this matter by our Department Inspector A estimating the cost of putting the plumbing system in proper shape at \$10,000.- as well as his previous report on general repairs needed, to cost \$75,000.- is herewith enclosed.

I would strongly urge the granting of this request, and trust that your Honorable Board will set aside the necessary funds for this purpose.

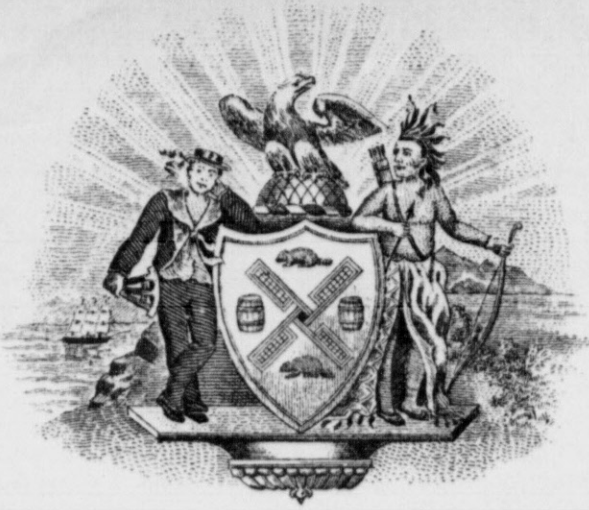

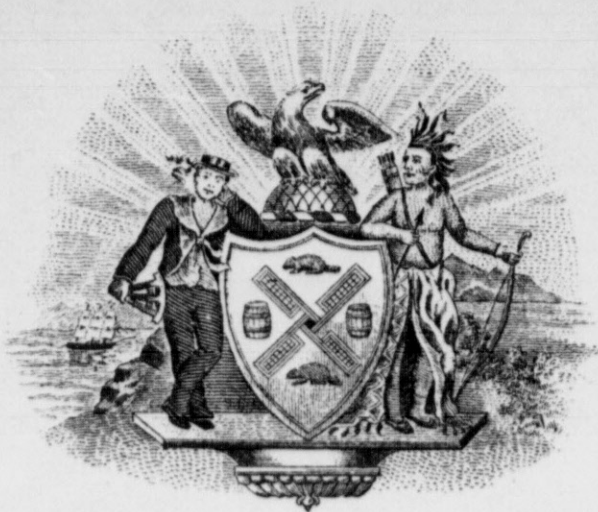

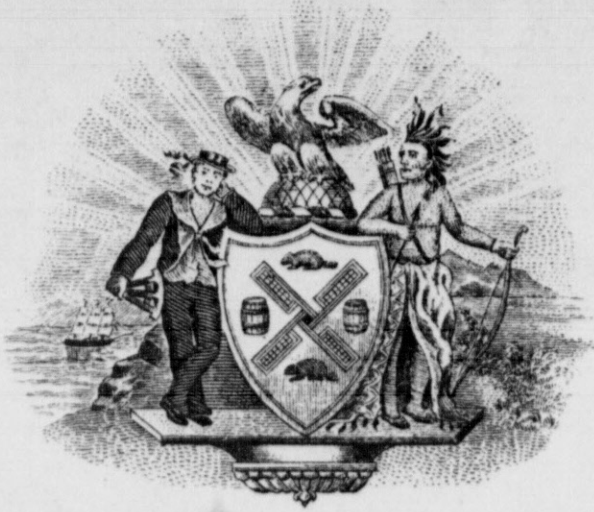
