

My Dear Sir:-

Continuing the subject broached by me yesterday in our conversation, I beg leave to submit the following suggestions as to the power of Mayor Strong to appoint marshals of the City of New York for a term ending May, 1903, which appointees shall be irremovable by the incoming Mayor, except for cause.

Section 1424, chapter 378 of the laws of 1897 (the Greater New York Act) reads as follows: "The Marshals in the City of New York as heretofore known and bounded, and the marshals and constables in the Cities of Brooklyn and Long Island City, and in the several towns mentioned in section one of chapter one of this act, in office at the time this act shall take effect, shall continue to hold such offices and perform the duties thereof until midnight of the thirty-first day of January, eighteen hundred and ninety-eight, and said terms of office shall then expire, except those of the marshals in the late City of New York and the marshals in the late City of Brooklyn, who shall continue to be Marshals of The City of New York, as hereby constituted, till the expiration of their respective terms."

You will notice that the marshals of the present City of New York shall continue in office until the expiration of their respective terms. Section 95 of said act does indeed give the Mayor power to remove public officers holding office by appointment except

members of the Board of Education and judicial officers; but this section must be read in connection with section 1424 which is a later section and modifies the former. Besides that it is evident that the Legislature meant to make an exception in favor of the present marshals. With reference to no other head of department or appointee of the Mayor is there a statement that they shall continue until the expiration of their terms; and the exception having been made in favor of the marshals it must be evident that it was so made intentionally; And there is reason for this also: The heads of Fire, Police, Dock, Public Works and other Departments, are in a sense subordinates of the Mayor, <sup>in</sup> carrying out a part of his executive duties. The work of marshals on the other hand is similar to that of the sheriff and is of quite a different nature from that of any other official.

Section 1427 is as follows: "On the expiration of the terms of said marshals of the City of New York mentioned in the last clause of section fourteen hundred and twenty-four of this act, the said mayor shall appoint their successors for terms of six years respectively." Here is the intention of the legislature clearly indicated, viz: that it desired the marshals appointed by the present Mayor to serve out their terms of office. So too section 1428, relating to the duties, powers &c. of marshals states that they shall apply to the marshals appointed "or continued in office pursuant to this title." No language can be plainer. "Continued in office"


can mean only that the next mayor shall have no power to remove the marshals appointed by Mayor Strong except for cause.

In any event there is at least sufficient in the above contention to warrant Mayor Strong in appointing marshals before the expiration of his term; and if Mayor Van Wyck should attempt to remove such appointees they can resort to the Supreme Court to maintain their positions.

Please urge the Mayor to give this matter due consideration. The present appointees, or such others as he may appoint, will undoubtedly be of a different political belief from those that would be appointed by the incoming Mayor.

Please urge the Mayor also to consider my individual case. During my present term of office and the preceding terms I have never had a charge made against me. I am a Veteran of the War of the Rebellion and have served my country both on the battlefield and in public office without criticism, and I think I am not asking too much if I should now ask Mayor Strong to exercise the power which has been given him by the legislature and re-appoint me as one of the marshals of the City of New York for the term ending May, 1903.



charges, but whether any of them are in the 7th Judicial District, where father resides, I do not know.






