Gentlemen:

Your letter of May 26th to his Honor the Mayor, in regard to the seizure of two gutter bridges, by this Department, taken from in front of your premises, has been referred to the Department of Street Cleaning for reply.

This seizure was made at 3 A. M., on the 23rd instant, after the receipt of a report from the Police Department to the effect that the gutter beneath them was in a dirty condition.

This report upon examination, was found to be absolutely correct.

If you will refer back to December 14th, 1895, you will find that a gutter bridge of yours was seized on that date also for the same reason.

All who use gutter bridges have been repeatedly notified, personally, or their employees have, that it is absolutely necessary to keep the gutters beneath them clean at all times.

The fault lies most likely in your men not giving the attention necessary to the gutters.

Your permit requires that the gutter be cleaned once a week, but this Department must insist upon it being cleaned as

often as it becomes dirty.

The bridges will be released upon the payment of \$2.00
fine for each bridge.

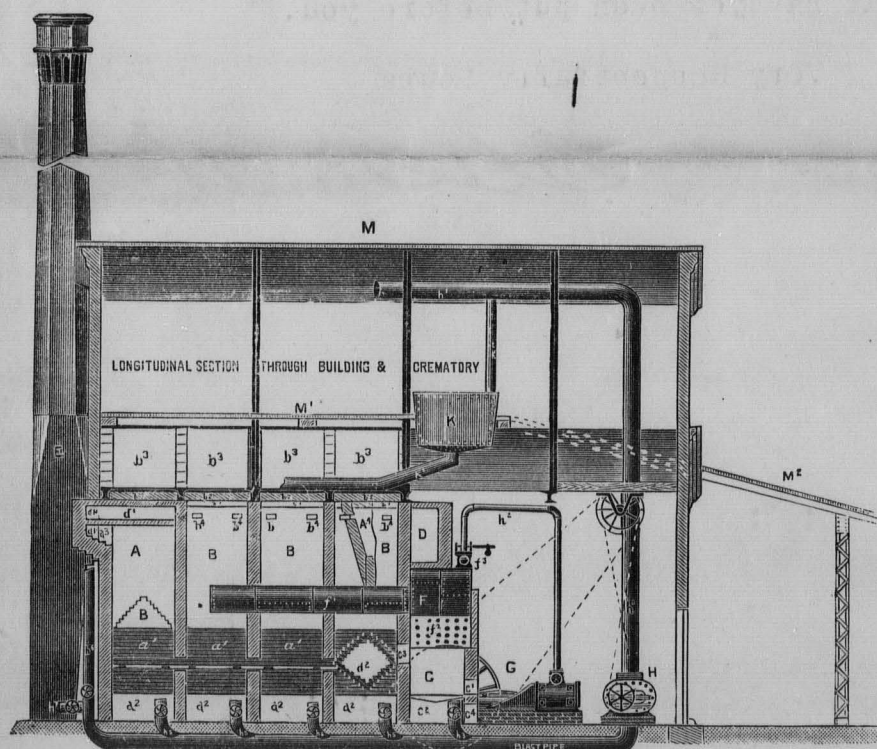
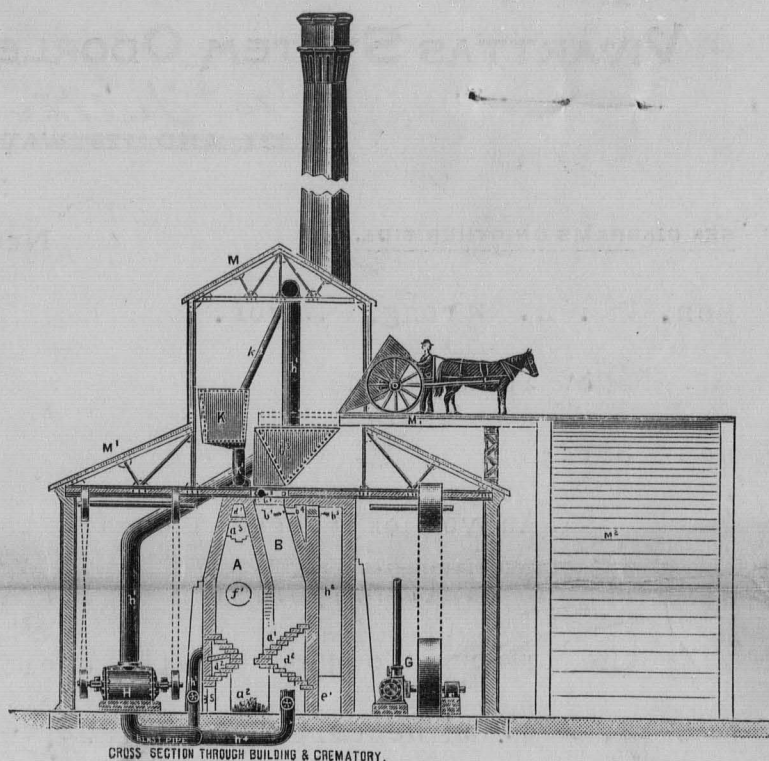
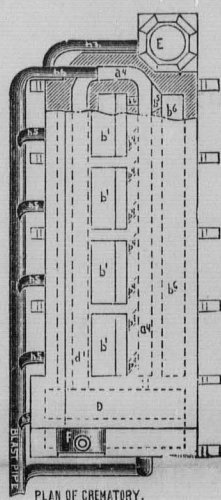

Returning enclosed letter I beg to say: I called on Mrs. DeLacy, who is the wife of Ex-Alderman DeLacy.

I hardly know what to say regarding this letter. I have had several complaints from this lady regarding very trifling matters. She told me to-day that enclosed letter was addressed to the Comptroller, and that she had sent similar ones to the Mayor and the President of the Board of Aldermen, the latter's reply she showed me. During the last year I have sent out every Sunday morning 4 sweepers alternately from 45, 47 and 49th Sections, and alternating amongst the men, and one cart to clean up gutters, etc., on 125th St. and 8th Ave. which is necessary, owing to business prominence of these thoroughfares, and the lateness to which the stores, located in these streets, keep open Saturday evenings.

There is, true enough, a great traffic through 126th St. but whether the men are paid or not for Sunday work I should not advise the sweeping of this street on Sundays for the simple reason that the same demand would at once be made from every other resident street in the district.

I also enclose Mrs. DeLacy's complaint to the Mayor.

I am directed by the Commissioner to return herewith the communication of M. Heilbronner, No. 50 Eighth Avenue, and to inform you that the District Superintendent, to whom his complaint was referred for investigation, reports as follows:-

"The above complaint is one of many just complaints. Every Police Station in this District has received orders to notify all householders to provide metal, water-tight ash receptacles; the Policemen have not done so, consequently the people do not understand why their wooden receptacles are confiscated.

I have called on all complainants and have in every instance settled the matter according to the Sanitary regulations by simply explaining the cause of confiscation. The people are satisfied to provide cans but object to seizure without notification first. It is impossible for me to notify all the residents of this District with the limited force of officers under my control.

I would respectfully request that the Police be again reminded of these violations of the Sanitary Code."

The City of New York, through the Commissioner of Street Cleaning, has entered into a contract for the final disposition of the City's garbage separated from ashes and street sweepings, and is under obligation to secure as complete a separation as possible.

In furtherance thereof attention is called to the following regulation of the Health Department, passed June 23rd, 1896;-

To HOUSEHOLDERS and HOUSEKEEPERS;-

PLEASE take notice that Section 95 of the Sanitary Code, which requires that a SUITABLE and SUFFICIENT RECEPTACLE be provided on every premises for receiving and holding GARBAGE WITHOUT LEAKAGE, and that a SEPARATE RECEPTACLE made of or lined with some suitable metal shall be provided for ASHES, and that ASHES AND GARBAGE SHALL NOT BE PLACED AND KEPT IN THE SAME RECEPTACLE, will be enforced by the Board of Health on and after AUGUST 1, 1896.

The Department of Street Cleaning will collect ashes and garbage in SEPARATE CARTS on and after August 1, 1896, AT THIS HOUSE.

Dear Sir:-

I have investigated the matter referred to in Judge Jeroloman's letter to you of June 29th, which is herewith returned.

The District Superintendent, in his report of this seizure, states that Mr. Barry had his wagons unhitched on the street after 10 o'clock P. M., which would indicate that it was the intention of leaving them there all night.

After this seizure was made, the stable employees about the place, took one wagon away from our men by force, and considerable trouble was made. The Police reserves, from the 20th Street Station, had to be called out, and in the fray two of our men were injured. This seems to have been as flagrant a violation of the law as has occurred during the entire period of our incumbence seizures.

In view of these facts, I think Mr. Barry appears only in the light of a deliberate law-breaker.



Dear Sir:-

Your letter of August 21st to His Honor, the Mayor, has been referred by him to this Department. In regard to the men of this Department depositing ashes and garbage on the same Scows, would say that this City is under contract with the New York Sanitary Utilization Company to furnish them clear garbage, and as the separation of garbage only commenced on the first of August, it has been impossible up to this time to procure a complete separation, and deliver to the Contractor such garbage as he would be willing to take as such, therefore the separation up to this date has been in the way of educating the people as to the separation as it will be required by the Contractor.

Up to the present time the Contractor has been taking 60 tons of garbage daily, but when his Plant is completed, which it is hoped will be in the very near future, he will take the entire garbage accumulation of the City.

In regard to the paper of which you complain, would say that this Department is employing carts for the collection of

paper, exclusively. In some Sections of the city however, we find it necessary to put paper with the ashes, but ^{now} ~~no~~ is permitted to be mixed with the garbage. I would say in addition in regard to the collection of paper, that it is not strictly the business of this Department to take it at all, as its duty consists in taking away the garbage, ash and street sweeping accumulation, and the collection of paper has been purely and entirely for the convenience of the inhabitants.

Should it come under your notice that any of the employees of this Department are neglecting their duty in any way, you would confer a great favor upon the Commissioner by reporting the fact at once, giving the badge number, if a sweeper, or the cart number if the man be a driver, also the date of the occurrence.

I hope this will be a satisfactory reply to your letter.



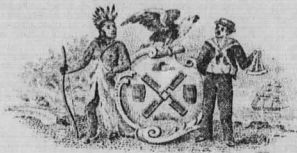

In answer to a request from Mr. Hedges, asking that a printed circular from this Department, showing when garbage is to be collected and what kind of stuff is taken away by the Department of Street Cleaning, be sent you, I would say that the garbage collection from houses is made in the forenoon; the other material collected is ashes and sweepings.
