Dear Sir:-

This office is in receipt of your letter of February 26, 1912, enclosing a communication from Mr. G. Dalmeyer, written upon the letter paper of William Coulson & Sons, of this City.

Mr. Dalmeyer's letter is returned to you, and in this matter I beg to advise you of the following:

There are two (2) Courts in this County receiving the applications of aliens for citizenship; one is the United States District Court, in the Post Office Building, and the other is the Supreme Court, of which I am the Clerk.

In the United States District Court, I understand, the rule is to limit the receipt of applications by taking only a certain number each day. In this Court, while the office hours are from 9:00 A. M. to 4:00 P. M., the rule has been to receive all applicants presenting themselves, and keep the office open until the Bureau has been cleared.

In the particular case, which is the subject of this letter, I note in the second paragraph of Mr. Dalmeyer's letter, in the second line, that he states he was downtown twice with a witness.

The Law requires that an applicant for citizenship



must have with him, to vouch for his good character, "two (2) witnesses, citizens of the United States, who have known the applicant continuously for the past five (5) years."

It may be that Mr. Dalmeyer did come down with one (1) witness, to either of the Courts receiving applications, and was then informed that it was necessary for him to bring another witness.

I can assure you that if Mr. Dalmeyer, or any other resident of New York County entitled to have his application for citizenship received by this Court, will present himself at this office between the hours of 9:00 A. M. and 4:00 P. M., any day except Saturdays, when the office is open from 9:00 A. M. to 12:00 noon, he will receive the fullest consideration and prompt attention.

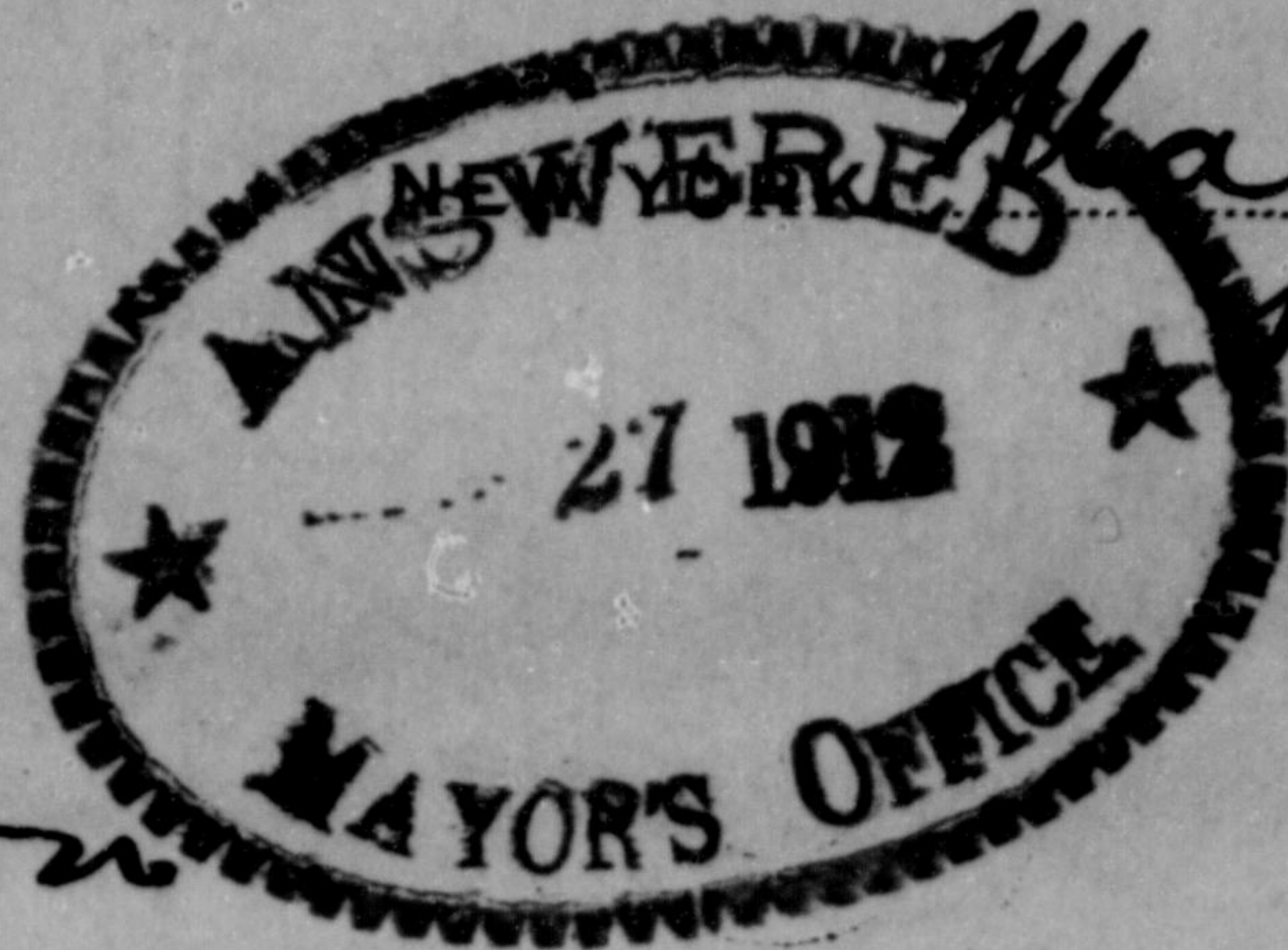



Gentlemen:-

In connection with the Budget Allowance for this office for the year 1913, "Personal Service - Salaries Regular Employees", which you have divided into five separate accounts, - (Code Nos. 3640-3641-3642-3643-3644-1913), I desire that four of these accounts be consolidated (3640-1-2-3) into one.

In the case of the "MARRIAGE LICENSE BUREAU", there is no reason in having a separate roll for the five clerks paid under this appropriation. At the time the Legislature imposed upon the County Clerk the duty of furnishing to the State Board of Health a certified copy of each marriage license recorded in his office, we requested of the Board of Estimate & Apportionment an issue of Revenue Bonds to cover the salaries of five additional clerks required for this extra work, and in certifying the title of the account to us the Finance Department gave it this title of "MARRIAGE LICENSE BUREAU" - a misnomer. The duties imposed by statute will always be incumbent upon the several clerks of Counties in this State, unless the statute be amended. In fact every employee in this office has to copy some of these marriage licenses, in order to keep up with this work.

PRESERVATION OF PUBLIC RECORDS - Similar reasons apply for this request. The clerks appointed pursuant to the enactment of this statute in 1883, when not employed in performing duties strictly applicable to this title, are engaged in general clerical work. Their services could not be dispensed with without absolutely crippling the service.

RE-INDEXING LIENS & CLAIMS UPON LAND - Similar reasons apply here. It is a general and not specific duty imposed upon the County Clerk for all time or until the statute be amended.

In certifying to the pay roll of this office each month, I certify that the parties named therein have been regularly employed in the performance of the appro-

priate duties of their indicated position and have at no time during the period covered been assigned to the performance of duties pertaining to any other title.

This certificate can only be complied with literally by having the clerks assigned generally and not specifically by departments or bureaus, as this office is not organized by Departments or Bureaus.

I have therefore to request a modification in the Budget Supporting Schedule lines for Salaries for this office for the year 1913, in accordance with enclosed memorandum, and trust you will see its necessity.
